Freed Pussy rockers reunite in Siberia

Two freed members of anti-Kremlin punk band Pussy Riot yesterday met in Siberia for the first time since their release, discussing plans to set up a new rights group to help Russian prisoners.

Maria Alyokhina, who had been serving her sentence at a prison colony in the central city of Nizhny Novgorod, flew into the Siberian city of Krasnoyarsk to meet up with bandmate Nadezhda Tolokonnikova, who was released

from a prison hospital.

Alyokhina, 25, and Tolokonnikova, 24, were released two months early under a Kremlin-backed amnesty after serving most of their two-year sentences for staging a protest performance against Putin in an Orthodox cathedral in Moscow in February 2012.

Tolokonnikova's husband Pyotr Verzilov told AFP the two women had discussed plans to create "a fully-fledged organisation to help inmates."

On the formation of resistance committees, she asked her alliance members to involve all sections of society, including minorities, and remain alert to ensure their safety and security. "There will be zero tolerance for any form of communalism."

This announcement of the "March for Democracy" comes following a series of mindless blockades from November 26, a day after the Election Commission declared the polls date.

Till yesterday, the opposition enforced blockades of roads, rails and waterways for 22 days, crippling communications countrywide. Frequent clashes, arson blasts and killings took place almost every day, claiming at least 120

Only seven days were free from the blockades -- four Fridays, two holidays for Martyred Intellectuals Day and Victory Day and December 15 when the Jamaat-e-Islami enforced a hartal to protest the execution of convicted war criminal Quader Mollah.

Khaleda earlier had called another march towards Dhaka for the restoration of the caretaker government system.

The government imposed heavy restrictions and police joined by ruling party activists blocked roads, rail and waterways to stop opposition supporters from pouring into Dhaka on March 12 last year.

Yesterday, she warned the government not to obstruct Sunday's march by any means.

"Do not block roads, close down transport and hotels. Do not try to arrest or harass those coming to Dhaka. Allow citizens to exercise their fundamental right of peaceful assem-

Otherwise, she said, the opposition would announce even stronger programmes.

Khaleda alleged the government was aware that people would rise in unison and this is why the timing of the "fraudulent election" and implementation of the verdict against Quader Mollah was "cunningly coordinated and was timed in a planned way to create diversion.

On Islamabad's expression of concern over the execution of war criminal Quader Mollah, she said, "The reaction of the Pakistani legislature on this has hurt us as citizens of Bangladesh."

She added, "The Awami League government had signed the Tripartite Agreement in 1974 and forgiven the Pakistanis accused of these crimes. Assurances were also given by them to look beyond past bitterness.

She appealed to all those who are concerned not to involve the army in the "fraudulent election" and make it controversial.

Khaleda added the government which would be formed through the election would also not have any legitimacy.

"Such a government will be undemocratic and unrepresentative. No servant of the Republic is obliged to follow the orders of such an illegitimate government," she said.

"I appeal to all citizens and the voters of Bangladesh to boycott this farcical exercise. When the whole world has decided not to grant any legitimacy to it, when the majority of the people are not involved with this, I ask all those connected with the process to stay away from it

Referring to three-round dialogue between the government and the opposition through the initiative of the UN, Khaleda said it was now clear that the government had staged a drama in the name of dialogue to kill time to carry out its plans of holding the farcical polls.

"Despite knowing that no election is possible without the participation of the two main parties, the AL pressed ahead with its design to hold a one-sided election," she said.

Terming the incumbent government "illegal", she said the servants of the republic and citizens will not be bound to comply with its

Hafizul's brother Shahidul Islam said locals had told them that if the police took the body, they would not return it. That is why they hid the body. He added that none of his four brothers was

With Hafizul, at least three people have been killed in the drives in Satkhira that began on December 15. However, the joint forces claimed that five people were killed in a drive on December 15 alone, while Jamaat claimed one.

Meanwhile, the joint forces arrested eight Jamaat-Shibir men between Monday night and yesterday evening. They have so far arrested 58 people in their drives.

The drives were launched in the wake of largescale violence in the southern district during the hartals and blockades in the last one month

At least 10 leaders and activists of the ruling party were killed in the district during the period.

Contacted, an AL leader said the party highups have denounced that the CEC informed the media what the party had asked for.

Besides, Bortee, a non-government organisation that also observes polls, yesterday informed the CEC that it would deploy observers in the election, Sharmin Murshid, chief executive of the organisation told reporters.

Code breaker

convicted of "gross indecency" with a man in 1952. Now, nearly 60 years after his suicide from cyanide poisoning at the age of 41, Alan Turing has been officially pardoned by the Queen under

the little-known Royal Prerogative of Mercy. The pardon comes after a change of heart by ministers who had previously insisted that Turing was properly convicted of what at the time was a criminal offence.

A pardon is usually granted only when the person is innocent of the offence and where a request has been made by someone with a vested interest, such as a family member. But Turing's pardon has been issued without either requirement being met.

It follows a sustained campaign by scientists, including Stephen Hawking, and a petition to Government signed by more 37,000.

Announcing the change of heart, the Justice Secretary Chris Grayling said Turing deserved to be "remembered and recognised for his fantastic contribution to the war effort" and not for his later criminal conviction. "His later life was overshadowed by his

conviction for homosexual activity, a sentence we would now consider unjust and discriminatory and which has now been repealed," he said. "A pardon from the Queen is a fitting tribute to an exceptional man." The pardon under the Royal Prerogative of

Mercy came into effect on Monday.

Since 1945, only three high-profile pardons have been granted in England and Wales under the Royal Prerogative: to Timothy Evans, Derek Bentley and Michael Shields.

The opposition men made the attack when about 20-25 Rajshahi-bound trucks were crossing Harishpur bypass in Sadar upazila around 12:30am under police escort, said

Momen said he had sent an urgent letter to the Armed Forces Division (AFD) on Monday upon repeated requests from the UN Peacekeeping Office to send troops for deployment on peacekeeping missions. "The officials of the Department of

Peacekeeping Operations might have pursued the UN secretary-general to directly call the Bangladeshi prime minister to make a request for the emergency need," he added. The United Nations, he mentioned, is fully

aware of the fact that it is possible only for Bangladesh to send troops for peacekeeping

missions within the shortest possible time of eight to 10 weeks.

As of 30 November 2013, Bangladesh has contributed the second highest number of military and police personnel to UN Peacekeeping Operations, totaling 7,968 members.

Bangladesh is sending some 1,450 troops to the peacekeeping mission in Mali, which is already under process, Momen told this correspondent.
