

# 'Missing' schoolboy, housewife found murdered

Police recovered the bodies of a missing schoolboy and a housewife in Chapainawabganj and Bhola districts on Tuesday and the day before.

Police recovered the body of a missing schoolboy from a ditch at Dimkoil village in Nachole upazila of Chapainawabganj Tuesday afternoon, reports our correspondent.

The deceased is Johny Babu, 14, son of Wasim Ali under Nejampur union in the upazila. He was a class eight student at Dimkoil High School.

SI Saiful Islam, duty officer at Nachole police station said, Johny went out of his house November 4 last year for working at their crop field and remained missing since. His family members filed a general diary with Nachole police station on the day.

Locals on Tuesday spotted the body dumped in a ditch of the village and informed police.

The reason behind the killing could not be known immediately, said police.

In Bhola, Police recovered the body of a housewife with the throat slit at Sadapur village in Lalmohon upazila on Monday morning.

The deceased was Joytsna Begum, wife of Yousuf of the village, reports UNB.

Police, quoting locals, said Yousuf on Sunday midnight had wanted some money from Joytsna for buying drugs, which she refused to give.

Police arrested Yousuf from the house.

Officer in-charge of Lalmohon Police Station Khandakar Mizanur Rahman said Yousuf was a drug addict.

He might have killed his wife for drug money.

# Hospital staff 'commits suicide' in B'baria

A woman allegedly committed suicide by jumping from the rooftop of a seven-storied building at Banikpara in the district town yesterday morning.

The deceased was identified as Lipika Gomes, 40, the assistant accountant of Christian Memorial Hospital here.

According to police, Lipika lived alone at a rented unit on the top floor of the seven-storied building of her hospital as her husband and two girls stayed in Dhaka. The hospital runs from ground to fourth floor of the building.

Doctor Duke Chowdhury, resident surgeon at the hospital, said Lipika had been working in the hospital for three years. Her activities were normal and the accounts section was running smoothly. Yesterday she left the workplace as usual after office hours, he said.

I cannot understand why she killed herself, he added.

Contacted, Norbat Lorence, the husband of Lipika, 'showed reluctance' to make any comment in this regard.

# Farmers in Jhalakati opt for sunflower cultivation

They hope to earn good profit from new oilseed

Farmers in the district are now cultivating sunflower as a new oilseed crop on their vast tracts of land.

Sources at the Department of Agriculture Extension (DAE) here said, a target was fixed to bring 6,830 hectares of land under cultivation of oilseeds like mustard, peanut and sesame in four upazilas of the district in the current Robi (winter) season.

On the other hand, Brac, a non-government organisation (NGO), took steps to boost sunflower farming to a greater extent with the target of bringing 694 hectares of land in Sadar and Rajapur upazilas.

The leading NGO under its food safety programme has also planned to assemble 1,000 farmers of the two upazilas to cultivate sunflower on cooperative basis.

In the meantime, at least 477 farmers have already started cultivating sunflower on 380 hectares of land in Sadar upazila and 470 others on 314 hectares in Rajapur upazila.

Farmer Hayat Khan of Gabkhan village in Sadar upazila said he was preparing his land that was earlier used for paddy farming for cultivating sunflower.

Another farmer, Abdur Rahim, of the same area said, after harvesting of Aman paddy, he prepared his land for sunflower farming and is now sowing seeds of the winter crop.

Farmer Abdul Latif of the same village said he harvested paddy from his four bighas of land late and was tilling the land for sunflower cultivation.

He hoped to earn a good profit from sunflower farming.

Talking to UNB, Champak Aich, manager of Brac's food safety programme in Jhalakati, said farmers have to spend Tk 14,000 for cultivating sunflower on each acre (per acre=30 decimals) of land.

On an average, production of the winter crop is expected to be 30 tonnes per acre, he said, adding that growers can make a profit of Tk 22,000 by selling their produce from one acre land.

Besides, sunflower output might exceed 30

maunds per acre if the crop field is nurtured well, he added.

Farmers said, oil produced from sunflower seed crushing usually sells for Tk 14,000 per maund (one maund is equivalent to 37.32 kilogrammes).

# To evade danger, he finally swallows the bitter pill

Chairman of Kamarpukur union parishad (UP) in Saidpur upazila under the district finally married a woman who he had deceitfully abused, after the victim filed a rape case against him with a special tribunal.

UP chairman Ziko Ahmed, 28, often met the 25-year-old headmistress of a kindergarten in Saidpur, and tried to be close to her, saying that he would help get government's MPO for the school and also donation from his relatives living abroad, said the victim in her complaint to the tribunal.

"On May 10 of 2013, the chairman made me nearly unconscious by having me take tea mixed with sedative, and then took me to the house of his friend Pulok in Saidpur municipality area," said the complainant.

"There, two bearded men forced me to put signature on a piece of paper to divorce my husband, now staying abroad as an army member. Then one of them took my signature on another paper and said that marriage was performed properly and there was no hindrance to my starting conjugal life with the chairman.

"Since then, the chairman kept me at different rented houses in the municipality and continued physical relation, but he did not take me to his own house as wife.

"Knowing that he married another woman on November 21 in 2013, I went to his house the next day and wanted to know the reason of another marriage without my consent.

"But he denied any relation with me and tried to strangle me. As I resisted, he with the help of his brother Joshi Ahmed poured poison in my mouth. However, neighbours rushed in and took me to Saidpur 100-bed Hospital. I was then referred to Rangpur Medical College Hospital.

"After getting released from hospital, I submitted a petition for filing a rape case with the Special Tribunal for Women and Children Repression Prevention on November 28," said the complainant.

Following a court order, Saidpur police investigated the matter, found the allegation true and prepared to file the report when the court reopens early January after winter vacation.

To evade 'danger',

accused Ziko Ahmed married the victim before the local notary public on Tuesday on condition of Tk 20 lakh *denmohor* (dowry to be paid to the wife).

Meanwhile, another rape case against Ziko is under trial at the same tribunal.

Contacted, UP chairman Ziko Ahmed said the case by the kindergarten headmistress was filed as a result of misunderstanding, and the matter had been settled. Regarding the other rape case filed against him, he claimed that it was a false one.

# Jubo Dal man murdered

Locals found the body in Darogarasta area in the morning and informed the police, said officer in-charge of Begumganj police station Mostafizur Rahman.
