

# NEW CABINET TOMORROW

## All-party; team of around 50

An "all-party" cabinet is going to be formed tomorrow, for the first time in the history of the country's parliamentary democracy.

The exact size of the cabinet could not be known, but it may have around 50 members, compared to the 32 in Sheikh Hasina's last cabinet.

Contacted, several Awami League leaders have said they are in the dark about who will be in the cabinet and that only Prime Minister Sheikh Hasina knows it.

Over the past few days, however, more than 150 lawmakers from the AL and several lawmakers from five other parties had been lobbying hard for ministerial posts.

Some of them, including those who magically amassed huge wealth over the past five years, met Hasina at the Gono Bhavan and expressed their desire to get the job.

They even went on to praise the PM for what they called her "bold leadership",

#### Army to stay put till Jan 17

UNB, Dhaka

The Army will remain deployed in eight constituencies till January 17 to ensure peaceful conduct of re-polling in 392 centres on January 16, said an ISPR press release.

The eight constituencies are Dinajpur-4, Kurigram-4, Gaibandha-1, 3 and 4, Bogra-7, Jessore-5 and Laxmipur-1.

The Election Commission has taken the decision of keeping the army personnel deployed as the strike force for free and fair re-polling in the centres.

On January 5, parliamentary elections were held in 147 constituencies

## PM talks tough

### Vows to tackle violence with an iron hand, taunts Khaleda over polls boycott

Prime Minister Sheikh Hasina yesterday warned against political violence and attacks on the minorities, and said the government "will act as tough as it takes" to save lives and properties of people.

"The Awami League knows very well how to deal with troublemakers," she said in a mammoth rally at Suhrawardy Udyan in the capital.

The prime minister alleged the BNP and Jamaat-e-Islami had been attacking the Hindus and unleashing violence in different parts of the country like they did after the 2001 election.

"We could not do much back then as we were in the opposition. Now, with people's mandate, we are in the government and we will go tough as much as required to bring back normalcy and peace in the country," she said.



## Two housewives raped for voting

### Victims file cases

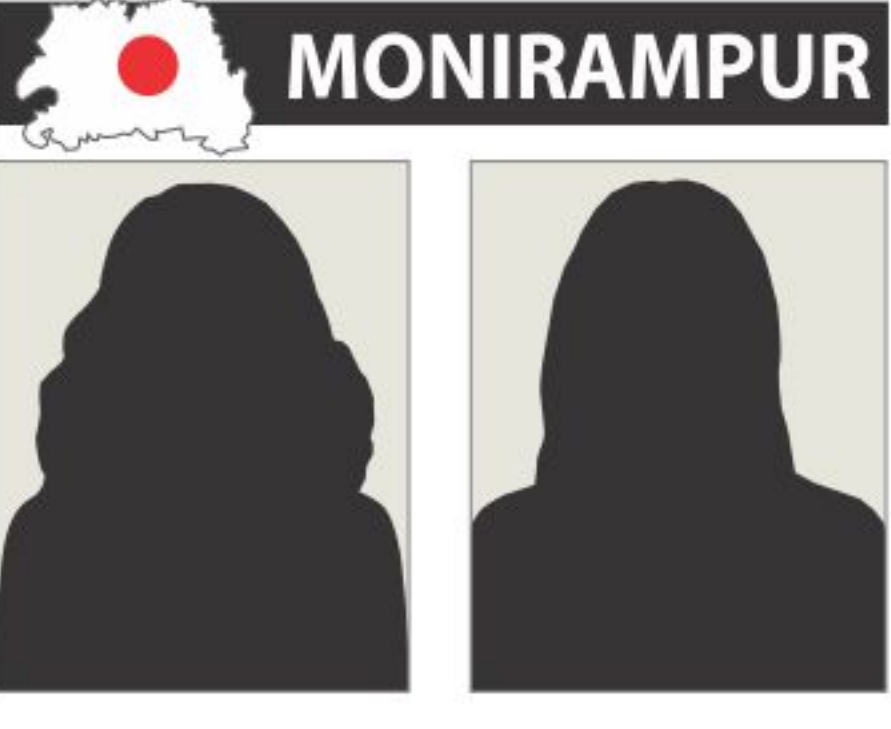
Criminals raped two Hindu homemakers at gun point in front of their families for voting in the January 5 elections.

The incident took place at Hazrail Rishipara of Monirampur upazila in Jessore, just two days after the attack on Hindus at Malopara in Abhaynagar of the district on the election day.

Criminals, wearing masks, stormed two Hindu homes late Tuesday night and early Wednesday. They tied up the men and children before violating the women.

Yesterday, the victims filed two cases with Monirampur Police Station against seven to eight unidentified men.

The gunmen, also armed with sharp weapons, stormed a hut of the village



around 10:00pm on Tuesday where they raped one of the women, reports our Jessore correspondent.

## Notorious robber after Hindus

### Rape, extortion targeted at the community; he enjoys 'blessings of BNP-Jamaat'

Some Hindu families at Shikdermalki union of Pirojpur Sadar upazila have fled their homes in the face of rape, extortion and arson by an infamous band of robbers.

Villagers are tight-lipped in fear of further torture by robber Ashraf Ali Sheikh and his gang, who with blessings of Jamaat-BNP men are committing the crimes as police take no action over the incidents, said victims.

Robbers broke into the houses of Nimai Mistri and Girish Mistri in Gabtola village in mid-September last year.

"Actually, the perpetrators stormed the poor households of Nimai and Girish to rape women," said an arson victim of South Gabtola village.

### Working on petition; war crimes tribunal's directives to be sought for getting compensation for victims from the party

The government is set to file a petition with a war crimes tribunal for the trial and banning of Jamaat-e-Islami for crimes against humanity during the Liberation War, 1971.

The investigators and prosecutors dealing with the 1971 war crimes are working on the petition against the backdrop of some critical observations made by the tribunals in some verdicts.

The petition will be filed within the first

week of next month, barrister Tureen Afroz, one of the prosecutors, told The Daily Star yesterday.

In the petition, the prosecutors will pray for a ruling on Jamaat to apologise to the nation for its war-time roles and pay compensations to victims of crimes the party committed in 1971.

They will seek directives from the tribunal on the government to create a trust fund to disburse the compensation money among the victims or their families, Tureen Afroz said.

She added a team of investigators and prosecutors have been enquiring the criminal activities of Jamaat-e-Islami, as a political organisation, during the Liberation War.

The team has already collected some documents and evidence on the war crimes of Jamaat, and it expects to collect more at home and abroad.

After collecting the necessary documents, investigators will hand over its report to the prosecution.

Scrutinising the investigation report, the prosecution will finalise the petition for
