
General Conditions:


- Persons employed in Government, Semi-Government or Autonomous organization(s) or in Public Limited Company should apply through proper channel.
- Candidates having 3rd Division(s)/Class(es) or CGPA below 3.00 on the scale of 5 points or below 2.50 on the scale of 4 points in academic career need not apply.
- Incomplete application will not be considered. Only short-listed candidates will be called for written examination or interview or both.
- In case of unavailability of freedom fighters and of eligible freedom fighters as candidate for the post of sl. no.6 to 11, the son/daughter of freedom fighter, then if they are unavailable too, their son/daughter, and Tribal candidates, may apply along with the certificate issued by the competent authority, complying with the latest policy of the government. As proof of participation in the liberation war, freedom fighter's son/daughter or their son/daughter will have to submit freedom fighter certificate of their father/mother/grand father/grand mother respectively signed by the Secretary and hon'ble Minister/ State Minister of the Ministry of Liberation War Affairs or the certificate issued by the Muktijoddha Sangsad from the year 1997-2001 which is to be counter signed by former hon'ble Prime Minister. Applicant being the son or daughter of a freedom fighter must submit a certificate stating that he/she is the son/daughter of that freedom fighter, issued by the City Corporation/ Municipality/ Union Parishad. In case of any applicant's grandfather/ grandmother is a freedom fighter, a separate certificate mentioning that the applicant's father/mother is a son/daughter of that freedom fighter issued by the City Corporation/ Municipality/ Union Parishad is to be submitted.
- Candidates must be willing to work in any project area / power plant(s)/ installation of EGCB Ltd.
- Persuasion of any kind will disqualify the candidate.
- Age limit shall be calculated on 09/02/2014.
- Number of post may be increased or decreased.
- Income tax to be paid by employee.
- EGCB Ltd. reserves the right to cancel any or all applications without assigning any reasons whatsoever.
