HC tells govt

The High Court yesterday directed the government not to show detained BNP leaders Abdul Awal Mintoo and AM Mahbub Uddin Khokon arrested in any case "without the due process of law".

It means that police cannot implicate or show them arrested in any more case if their names are not in the first information report (FIR) of the case and if there is no specific allegation or arrest order against them, their lawyer, AKM Ehsanur Rahman,

told The Daily Star. He said police had already shown Mintoo, an adviser to the BNP chairperson, arrested in five cases, and Khokon, joint secretary general of the BNP, in three cases although their names were not in the FIRs.

The HC bench of Justice Salma Masud Chowdhury and Justice Md Habibul Gani passed the orders after hearing two separate petitions filed on behalf of the detained BNP leaders. Mintoo's wife Nasrin Awal

Seven killed photojournalist Aftab for money: Rab

Five of them arrested

Veteran photojournalist Aftab Ahmed was killed by seven robbers including his chauffeur in the capital's West Rampura in late December, Rapid Action Battalion said yes-

The murderers entered the house, saying they wanted to pay money in advance for renting a flat in the four-storey building, of which, Aftab lived alone in a second-floor apartment.

Rab arrested five of the alleged killers in Dhaka and Gazipur on Sunday, Rab Media Wing Director Habibur Rahman told journalists at Rab headquarters in the capital.

They arrestees are Humayun Kabir, 32, driver of Aftab's car; Belal Hossain Kislu, 35, mastermind of the killing; and aides Habib Hawlader, 21, Raju Munshi, 22, and Sabuj Khan, 18, he said.

Two others, Rasel and Nizam, are on the run, the official added.

A Rab-3 team first arrested Humayun at Sayedabad, and he led them to arrest the four

The 79-year-old Ekushey Padak winning

photojournalist was found dead at his residence on December 25 last year. His hands and legs were tied and mouth gagged.

The Rab official said that after learning about Aftab's solitary life from driver Humayun, the group planned to rob the house in mid-December. Humayun was reluctant at first but got interested when he saw some cash in Aftab's hands one day, he added.

Humayun, who took up the job in early November and lived in Rampura, told Rab that on December 24, his six accomplices arrived around 7:15pm.

Entering the flat, Kislu held Aftab's collar and asked for money and other valuables. As he shouted for help, Kislu, Humayun, Habib and Rasel strangled him, said the Rab official.

Later, they placed the body on sofa and locked the door before making off with Tk 65,000 from the wardrobe and Aftab's cell phone. Later, Humayun received Tk 10,000

from Kislu. Aftab's daughter Afroza Ahmed, who attended the press briefing, demanded that everyone involved in killing her father be

A faction led by Md Shamim attacked Mahmud while the latter was on his way to take an exam, said Kazi Rabiul Islam Fahad, senior joint-secretary of the BCL

On information, police rushed to the college premises and brought the situation under control.

A dispute existed between the two BCL factions over establishing supremacy in the area, said Nurul Islam, sub-inspector of Khulshi Police Station.

2 Bangladeshis held with 55 gold bars

WAR CRIMES TRIAL Decision on Qaisar's Sayedee indictment Jan 30

The International Crimes Tribunal-2 yesterday fixed January 30 to decide whether it will frame charges against Syed Mohammad Qaisar, former state minister in military ruler HM Ershad's cabinet, for his alleged involvement in war crimes during the Liberation War.

The three-member tribunal led by Justice Obaidul Hassan fixed the date after both the prosecution and defence completed their submissions over his indictment yesterday. On November 10, the prosecution

pressed 18 charges against Qaisar for crimes against humanity and genocide in Habiganj and Brahmanbaria in 1971. According to the prosecution, Qaisar

was the founder of the "Qaisar Force", an associate organisation of the Pakistani army, and involved in an act of genocide that left 108 people dead, and at least 10 incidents of killing that left 47 people dead.

Qaisar, 73, was arrested in the capital on May 21 last year.

Govt to bring back fugitive killers of Bangabandhu

Law Minister Anisul Hug tells The Daily Star

Law Minister Anisul Huq yesterday said that after learning about the latest progress, he would take necessary steps to bring the fugitive killers of Bangabandhu Sheikh Mujibur Rahman back to the country so that they face the further process of trial.

He said this while talking to The Daily Star at the law ministry following his takeover. Anisul was the principal counsel for the state in the cases of killings of Bangabandhu and four national leaders in 1975, and the Pilkhana carnage in February 2009.

"I joined the office for the first time today. I don't know what measures the last government took to bring back the fugitive killers of Bangabandhu. I'll use my experiences to get the Supreme Court verdict executed after knowing about this."

Six convicted killers of Bangabandhu and most of his family members are now absconding. They are Khandaker Abdur Rashid, Shariful Haque Dalim, Nur Chowdhury, Rashed Chowdhury, Abdul Mazed and Moslehuddin Khan. Two of them are now in the United States and Canada, while whereabouts of the remaining four are not known. SEE PAGE 4 COL 1

Two killed in capital STAFF CORRESPONDENT

Two youths were stabbed to death in the capital's Mirpur and Bangshal areas yesterday afternoon.

In Mirpur's Darus Salam area, Fazal Miah, 21, a garment trader, was killed by some of the local youths. Fazal' cousin, Md Jewel,

said a football match was held in the area. After losing, Fazal's team blamed the winning team for cheating.

Around 4:00pm Fazal went to meet five members of the winning team after getting a call from them. The youths stabbed Fazal indiscriminately. He was declared dead at Dhaka Medical College Hospital.

In Bangshal area, Md Shahed, 26, was also killed by some of the local youths as he filed a case against them on November 21 for beating him up. Shahed was declared dead at Mitford Hospital. Police are trying to arrest the killers.
