## EPP moves for a resolution

The European People's Party (EPP), the largest political group in the European Parliament (EP), has moved to adopt a resolution on January 5 parliamentary elections in Bangladesh, according to the EP website.

Twenty-two powerful MPs belonging to the EPP Group have called for adopting the resolution in the EP and hold a debate which will focus on fundamental freedoms, human rights and democracy in general in Bangladesh.

The motion for a resolution has noted with concern the preliminary results and low

turnout for the parliamentary elections held on January 5.

The motion also says it condemns the acts of violence which occurred in the run-up and during the elections and particularly attacks against the most vulnerable populations, including women and children as well as religious and ethnic minorities.

It is deeply concerned about the high number of casualties in these clashes and expresses its condolences to the families of the victims.

The conditions for transparent, inclusive and credible elections were not met and that

## Re-polling today in 7 constituencies

Re-elections will be held in 390 polling centres in seven constituencies across the country today, as voting had to be postponed there due to violence on January 5.

These constituencies are Dinajpur-4, Gaibandha-1, 3 and 4, Bogra-7, Jessore-5 and Laxmipur-1.

One other constituency, Kurigram-4, was supposed go to the polls today. The polls were postponed following a High Court order yesterday.

Meanwhile, the BNP-led 18-party combine, which had been staying out of the polls, called a daylong hartal in Bogra's Gabtoli upazila (Bogra-7) for today.

The elections are being contested by 16 candidates. Of them, six are nominated by ruling Awami League, two by Jatiya Party, two by Jatiya Party (Manju), one by Workers Party of Bangladesh and one by Bangladesh Tarikat Federation. The other four are independent candidates.

The eight constituencies have 959 poll-

ing stations. Of them, 390 will go to the polls today, with the number of voters being 10,25,272. Voting in the rest of the centres was held on January 5.

In Dinajpur- 4 constituency, ALnominated candidate Abul Hasan Mahmood Ali is running ahead with 68,088 votes. His rival candidate Enamul Haque Sarker of Workers Party has 1,380 votes.

In Kurigram-4, Ruhul Amin of JP (Manju) won 30,544 votes, while his rival Zakir Hossain of AL 23,946 votes.

AL candidate Manjurul Islam Liton is keeping ahead with 68,993 votes in Gaibandha-1, while his competitor Abdul Quader Khan of JP got 8,386 votes. In Gaibandha-3, AL's Yunus Ali Sarker bagged 70,664 votes, and his rival independent candidate Khademul Islam Khudi 12,781

In Gaibandha-4, independent candidate Abul Kalam Azad polled 59,862 votes, whereas Monowar Hossain of AL 18,806 votes.



Unidentified assailants killed four people by slitting their throats and injured another seriously of a family at Diadanga village in the district's Bhurungamari upazila early yes-

terday. The dead are Sultan, 55, a

45, and their two granddaughters Rumana, 14, and Anisa, 7. The injured was Mousumi, 16, a daughter of the deceased couple. Mousumi is now undergoing

treatment at Rangpur Medical College and Hospital, said Sahabuddin, Kurigram additional superintendent of police. On information, at around

3:00am, a police team was sent to the spot. They found three bodies lying in a room, and Hazera and Mousumi groaning with injuries, said Bhurungamari Upazila Nirbahi Officer AZM Ershad Ahsan Habib.

Police with the help of the locals took the injured to Rangpur Medical College and Hospital. But Hazera died on

the way, he added. The bodies were sent to Kurigram Sadar Hospital morgue

for autopsies. "Nobody open their mouth about the brutal incident. We would find clues to the killing when we can talk with Mousumi. She cannot speak now. But we are trying to trace the killers of the four," said

property of an unparallel scale.

This strategy yielded very little in BNP's favour. Rather people were aghast. Despite repeated calls from all quarters, including the media, Khaleda did not relent to change this line of action. The economy bled. The poor bled. The country bled.

But now, we can thank her for shunning that path. Her new strategy is smart and positive for several reasons.

First, she has seen the folly of waging this kind of violent

Above all, we can all thank her that she did not go for another endless bout of strikes and blockades that have wreaked havoc on

Her call on the government to allow her party to do politics in its rightful way is also correct. It is now time for the government to let her party offices function and let her hold all peaceful democratic programmes. Most of her party leaders are behind bars. And it is obvious that

many of the charges against them are fabricated. Her demand for the immediate release of these leaders is also a rightful one. This is no way of doing democracy by interning Khaleda to hold

elections and sending anyone of her party who dared to talk to jail. This culture has to change.

Khaleda has called for dialogues to resolve the crisis and look forward to an election in which all parties and above all, the people, will take part. In the rule, the court asked the respondents to explain in two weeks why they should not be directed to take immediate steps by deploying necessary forces to protect the interests of the minority communities and other vulnerable groups of citizens. The HC also ordered the respondents to

explain why the citizens, who were already victimised or have lost life, liberty, dignity and property, should not be compensated.
