8 BNP men charge sheeted for attack on Hindus

Panicky situation prevails as 7 including the alleged mastermind still out of dragnet

Police yesterday filed charge sheet against eight people for attacking Hindus at Satpatki Majhipara in Sadar upazila under the district on November 4 last year.

Of them, only Hamidul Islam, 44, is now in jail, while others -- Shawon Islam, 25, Alamgir Hossain, 25, Maznu Miah, 50, Abu Taher, 45, Badsha

Miah, 45, Soleman Miah, 60, and Rabi Hossain, 24, are still at large.

The eight accused, all residents of Satpatki village of Mohendranagar union in Lalmonirhat Sadar, were members of union units of BNP, Jubo Dal and Chhatra Dal and got expelled from the party for their alleged involvement in the attack on the Hindu village, police and locals said.

Main accused in election official killing case held

A team of Detective Branch (DB) of police on Tuesday arrested the main accused in the case filed for killing assistant presiding officer Zobaidul Haque at Dogachi village under Baliadangi upazila of the district.

The arrestee is Siddiqul Islam, 36, son of Abdul Ali of Bhelajan village in Hazipara of Sadar upazila and a local leader of BNP.

Sub-Inspector of DB police Rowshan Ara told this correspondent over cell phone that acting on a tipoff, a DB police team led by her raided the village in the evening.

At one stage of their drive,

According to the police case, a group of 100 to 150 BNP-Jamaat men, equipped with sharp weapons and sticks, swooped on Molani Cheprikura Govt Primary School polling centre in Roypur union under Sadar upazila around 8:45pm 4

and petrol bombs and then attacked the polling officers and law enforcers.

The attack left assistant presiding officer Zobaidul Haque, 55, also a demonstrator at Salondar College, and two police constables critically injured.

After one and a half hour of the attack, a striking force went to the spot and rescued them and brought them to Thakurgaon Sadar Hospital where the on-duty doctor declared Zobaidul dead.

Police constable Zaherul Islam filed the murder case, accusing 150/200 people with Thakurgaon police station in connection with the killing of Zobaidul Haque on 4 January night.

Abducted schoolgirl rescued

Police rescued an abducted schoolgirl from China-Bangladesh Friendship Bridge area in Sadar upazila yesterday afternoon.

The victim was a Class Ten student and daughter of a school teacher in Hobirbari of Bhaluka upazila.

Police arrested two peo-

ple, identified as Monir Hossain, 18, a worker at a textile mills in Bhaluka and his brother Morshed Alam, 12, of Holdivita village in Jhenaigati of Sherpur for their involvement in the incident.

Police quoting the girl said, the arrestees went to her house of around 12 noon and tied up the house maid as her parents were

outside for their jobs. When she returned home from school around 12.30pm, the culprits also tied her up and later pushed a sedative injection to make the girl senseless,

said police. After the girl lost sense, the culprits put her in a tin-made huge trunk and boarded a Sherpur bound bus around 1:00pm.

Regaining sense, the girl started beating the trunk from inside when the bus was crossing the bridge

area The driver noticed the matter and stopped the bus. Later, the passengers and locals found the girl wearing school uniform inside the trunk and caught its two owners red-handed and informed police, SI Hafizur Rahman of Bhaluka PS said.

On information, police rushed to the spot and rescued the girl and took her to local police station.

Golam Sarwar, officer in-charge of Kotwali Police Station said, the arrestees and the victim were handed over to Bhaluka police.

Body of 'missing' youth found floating in river

Police on Monday night recovered the body of Meherpur school student Shaikh Hasan Pranta after five days of his missing, triggering protest by the people of the district town. People from all walks of

life, inchiding students of various schools of Meherpur town, formed a human chain yesterday, demanding proper investigation and punishment to the killers.

Pranta, 14, son of Zahid Hasan, was a student of Class IX at Meherpur Government Technical School and College. Pranta's father is an accountant at Meherpur municipality.

Kamal Hossain, subinspector (SI) of Meherpur Sadar police station, also investigation officer (IO) of the case, told this correspondent that Pranta went into missing soon after he went out of home at about 2.30pm on January 9.

Pranta's father filed a general diary (GD) with Meherpur Sadar police station the next day.

Later a team of Meherpur Sadar police recovered the body and the parents identified it as Saikh Hasan Pranta.

Away in Bagerhat, police recovered the body of Mir Mostafa Kamal alias Batul, 36, from the bordering Bishkhali River on Tuesday, four days after his 'missing'.

Son of Mir Ashraf Ali of Phultala village in Kachua upazila, Batul was abducted and strangled by rivals and dumped into the river,

BCL man killed, Sramik Dal leader stabbed

Police recovered the body of a 'missing' BCL leader from a land beside the Karkhana River under Baufal upazila of Patuakhalizz district yesterday morning.

The deceased, Alamgir Hossain, 25, was general secretary of Kanchipara union unit of the ruling party-backed student body.

Family members said Alamgir went out of the house at around 8:30pm on Tuesday and did not return.

Locals found Alamgir's body lying on the riverside and informed the police and his family.

Being informed, police went to the spot, recovered the body and sent it to Patuakhali Generel Hospital morgue for autopsy.

Officer-in-Charge Naresh Chandra Karmaker of Baufal Police Station said injury marks were found on the head of the BCL leader.

Our Khagrachhari correspondent reported that unidentified criminals stabbed a Sramik Dal leader and hit two Jubo League and Chhatra League men with sharp weapons in Sadar and Dighinala upazilas yesterday and on Monday.

Mohammad Rajob Ali, joint organising Secretary of

Bhai-bonchhara union Sramik Dal under Sadar upazila, was stabbed by a gang in the area on Monday night.

He was admitted to Khagrachhari Adhunik Sadar Hospital. No case was filed with the police station concerned as of yesterday. Family members blamed local Awami men for the

Unknown criminals swooped on Srikanta Deb Manik, 28, president of Chhatra League Panchhari unit, and Nazir Mahbub, 33 general secretary of Jubo League upazila unit, in Kalanal area of the upazila at around 11:30am yesterday.

The gang hit the two with sharp weapons, leaving them critically injured. They were admitted to Panchhari Upazila Health Complex and then shifted to Khgrachhari Adhunik Sadar Hospital as their condition deteriorated.

Mohammad Bahar Mia, president of Panchhari upazila unit of Awami League, held the armed cadres of local BNP and Jamaat-Shibir for the attack.

Upazila BNP President Mohammad Belal Hossaion refuted the allegation and said Awami League activists vandalised local BNP office
