Brick kilns 'force' farmers into selling topsoil

Serious threat to soil fertility in Lalmonirhat

Around 300 bighas of land loses the topsoil every year as farmers are lured or forced into selling it to brick kilns in five upazilas under the district.

The process causes serious decline of soil fertility in the agriculturebased northern district but the authorities concerned seem reluctant to take any step to save the farmlands from the influential brick

kiln owners. Topsoil from 9 to 10 bighas of land are needed to manufacture 10 to 12 lakh bricks in each of the 31 brick kilns in the district every year, said agriculture officials, bricks manufacturers and local farmers.

Topsoil is needed to manufacture first class bricks and labourers

farmlands around, said Hadilur Rahman, a brick manufacturing worker at Madonerchak village in Lalmonirhat Sadar upazila.

"Topsoil of one bigha of farmland is sold for Tk 6000 to Tk 12000 and a brick kiln owner buys topsoil from 9 to 10 bighas every year," said Jibon Chandra Saha, manager of brick kiln at Madonerchak.

Brick kiln owners are ago. collecting topsoil of two feet depth from the farmlands, much to the harm of soil fertility, said Jamal Uddin, Mansur Ali, Abdul Jabbar, Meher Ali, Sultan Miah and others of the same village.

> Kashem Ali, 60, a farmer at Bamonerbasa village of Kaliganj upazila, said he decided to sell topsoil of his two bighas of farmland to a local brick kiln owner this year, as his land faced water crisis after neighbouring lands were dug two feet deep a year

Denying the allegation of creating pressure on the farmers to sell topsoil, Shahidul Islam, owner of ASB Brick Kiln at Bamonerbasa village in Kaliganj upazila, said, "We purchase topsoil "I got about 40 maunds from the farmers as we need it for manufacturing

bricks. We never face any objection from the agriculture department regarding the matter."

Large-scale use of topsoil for manufacturing bricks badly affects agriculture and causes harm to environment, said Mamunur Rashid, agriculture and environment coordinator of NGO RDRS Bangladesh.

He urged the authorities concerned to take immediate measure for stopping the harmful practice.

Abdul Mazid, deputy director of the Department of Agriculture Extension in Lalmonirhat, said, "Crop production falls to about 50 percent if the lands lose the topsoil. I will take necessary step with the help of district administration to save the farmlands from the brick kiln owners."

Wife killed for dowry, woman kills drug-addict husband

A housewife was beaten to death allegedly by her husband over a dowryrelated conflict at Khudra Jamira village in Puthia upazila on Friday morning. The deceased was iden-

tified as Munira Begam, 19, wife of Ismail, a resident of the village, reports UNB. Witnesses said, since after

their marriage, Ismail had often tortured Munira for dowry.

On Friday morning, he picked up a quarrel with Munira and beat her mercilessly over the issue, leaving her dead on the spot.

Being informed, police recovered the body with several injury marks and sent it to Rajshahi Medical College Hospital morgue for an autopsy.

Munira's father Munsur Rahman filed a case with the police station.

In Bandarban, a man was killed allegedly by her wife at Golachipa of Kuhalong union in Sadar upazila early yesterday.

The deceased was identified as Chyagga Prue Marma, 42, husband of Renuma Marma, reports our correspondent.

Both were workers at a rubber garden in the area.

Police said, they recovered the body of Chyagga Prue from a house at the rubber garden in the morning. The body bore marks of injury, they said.

According to the family sources, Chyagga was a drug addict and often tortured Renuma for money.

At around 10:00pm on Friday, Chyagga demanded money from his wife and locked in a quarrel as Renuma refused to give money.

At one stage, an agitated Renuma hit her husband indiscriminately with a rod, leaving him injured. Locals found him dead in the early hours.

Neighbour kills madrasa kid for Tk 10 thousand!

Police recovered the body of a 12-year-old slain madrasa student from a remote village of Salanga upazila under Sirajgnj district and arrested the alleged killer from his village home in Gobindaganj upazila of Gaibanda district Friday evening.

Md Parvez, 22, of Kathalbaria village in Gobindaganj upazila, also a Kamil student of Mohonganj Kamil Madrasa in the area, killed his neighbour Zahidul Islam after snatching Tk 10 thousand from the boy, police said.

Zahidul, son of Abu Hanjela of Kathalbaria

village, was a Class II student managed Tk 10 thousand in of Kathalbaria Dakhil Madrasa.

"Informed by locals, police recovered the body from a marsh at Radhanagar Chakpara of Salanga upazila Friday afternoon and sent to Sirajganj General Hospital for autopsy. The victim was strangulated and the body dumped there probably on Thursday," said Rashidul Islam Biswas, officer in charge (OC) of Salanga Police Station.

ABM Jahidul Islam, OC of Gobindganj police station, said, "Parvez instigated Zahidul to bring Tk 10 thousand from home for travelling to the capital. Zahid

absence of his father and went out with Parvez on January 14."

"In the name of travelling to Dhaka, Parvez took him to the remote village in Sirajganj and killed him after taking away the money the next day. Police arrested Parvez from his residence on Friday evening and he confessed to the crime," he said.

"The victim's father filed a case with Gobindaganj police station, mentioning that Parvez killed Zahidul for Tk 10 thousand in collusion with his father Nur Hossain. Nur managed to escape after the incident," the OC said.

Acid thrown on woman, 2 killed

A woman sustained burn injuries in an acid attack following a dispute over a piece of land at Tattiuly village in Kulaura upazila of Moulvibazar district yesterday.

The victim is Phuljan Begum, 42, wife of Solyaman Miah of the village. She was admitted to Moulvibazar Sadar Hospital with wounds in her face and legs, reports our correspondent.

Locals said there was a longstanding conflict between Ashik Miah and Subhan Miah over the land.

On Friday, Subhan Miah erected a boundary wall on the land. Enraged by the incident, Ashik and his younger brother Parvez Mia swooped on the house of Subhan Mia yesterday morning. During the incident, they threw acid on Phuljan, alleged Subhan.

Away in Chuadanga, a man was killed in a clash between two rival groups over a piece of disputed land at Gobindohuda in Damurhuda upazila on

The dead is Mohsin Ali, 45, son of Dukhu Mondal of the village, reports our correspondent. Police and locals said there

had been a longstanding dispute between one Mowla Box and Nurul Haque over the land in the area. As a sequel to the conflict,

the supporters of the duo attacked each other with lethal weapons, leaving four from both sides injured. Of them, Mohsin was

rushed to Chuadanga Sadar Hospital where he died on Friday night. In Mymensingh, a man was killed by his nephew over

shops and houses. On information, three units from Mymesingh and Netrakona Fire Station rushed to the spot and

doused the fire after three hours of frantic efforts. Affected owners claimed

that valuables worth Tk 2.5 crore were damaged in the fire.

Domestic help tortured

An underage girl of the district, who had been working as a domestic help in Dhaka city, was severely tortured allegedly by the members of her master's family. Sumona Begum, 13, daughter of Shawkat Khan of Bangram area in Sadar upazila is now undergoing treatment at Gopalganj Sadar Hospital. Shawkat said, driven by poverty, he sent Sumona to Dhaka along with one Rabeya Tapashi of the same village early last year to look for a job there. A few days after Sumona joined the work at Dhanmondi in Dhaka the house members started blaming and torturing her and threatened her of dire consequences if she disclose it to others. On January 13, they sent her back to Gopalganj in a bad shape. As her condition started to worsen, Sumona's family took her to the hospital Residential Medical Officer (RMO) of Gopalganj Sadar Hospital Dr Ashit Kumar Mallik said the condition of Sumona was unlikely to improve soon.

2 boys rescued from trafficker

Members of Rapid Action Battalion (Rab) rescued two boys from the clutches of an alleged human trafficker at Chakgupal village in sadar upazila on Friday. The boys are Shamim, 12, and Jamal, 10, and residents of Ranisagor in Ranisankail upazila of Thakurgaon district. Sources at Rab-5 Joypurhat camp said, Shamim and Jamal are students of a madrasa in Damuirhat upazila of Naogaon. In the afternoon, when the boys came to Joypurhat rail station on way home, a human trafficker named Anwar Hossain offered them to them to their houses. While passing through the village, the boys sensed the evil motive of Anwar and started screaming, leading locals to rush in. They rescued the two boys and caught Anwar and handed over them to Rab. During interrogation, Anwar confessed to Rab that he had attempted to traffic the two boys to India.
