Move against Pakistan at int'l court

ICT people in Dhaka term it 'flawed', 'conspiracy'

A Bangladeshi organisation yesterday claimed to have filed a petition with the International Criminal Court (ICC) in The Hague, the Netherlands, seeking legal action against Pakistan for the crimes committed by its army during the Liberation War.

But the ICC, which has been governed by the Rome Statute, doesn't have jurisdiction over any events before July 1, 2002, when the statute came into force after ratification by 60 countries.

Besides, only the countries that ratified the Rome Statute or the United Nations Security Council or the prosecutor of the ICC are eligible to lodge any complaint with the ICC.

Meanwhile, people involved with the war crimes trial in Bangladesh have termed the move a "conspiracy" against the ongoing trial.

Asked, Mustafizur Rahman, a leader of Projonmo' 71, an organisation of martyrs' children, said, "We are aware of the matter. Actually, we have filed the petition to pressurise [the ICC] into bringing necessary amendment

to its law so that it can deal with our appeal."

At a press conference at the Jatiya Press Club yesterday, Azizur Rahman Aziz, who claimed to be the president of Projonmo' 71, said he appealed to the ICC on January 15 to investigate the crimes committed during the Liberation War in 1971 by the Pakistani

army and sought action against Pakistan.

"I, as the president of the organisation, have a collection of all proof including video footage, deeds and documents [of the crimes]," he said and asked for an international investigation into the atrocities.

About their organisation, Mustafizur said there are two factions of Projonmo' 71. One is being led by Azizur Rahman while eminent journalist Shaheen Reza Noor, also the son of martyred journalist Serajuddin Hossain, leads the other faction.

Contacted, Shaheen yesterday said Azizur is a "self-proclaimed president".

His initiatives went against the stance of Projonmo' 71 on the war crimes trial, he alleged.

"Our official stance is that war criminals, whoever they are and wherever they live, will have to be tried as per our local law and at our war crimes tribunals," he said.

Tureen Afroz, a prosecutor of the International Crimes Tribunals, told The Daily Star that bypassing the tribunals, they had filed the "faulty petition" with an illmotive to undermine the achievement of the ongoing trial process.

Around 30 lakh people were killed and over two lakh women were raped at the hands of Pakistani occupation forces and their local collaborators during the nine-month-long war in 1971.

Buffalo genome decoded

"Bangladesh, with about two million buffaloes, is ninth in Asia in terms of buffalo population," said molecular scientist Md Moniruzzaman, who led Lal Teer's buffalo genome project and liaises with the BGI.

Talking to The Daily Star, he regretted that buffalo population has declined in Bangladesh over the years in tandem with the rapid mechanisation in farm sector.

Moniruzzaman, who spent several months in BGI's Shenzhen facility for the genome sequencing, said the accomplishment would help reshape Bangladesh's highly potential but largely neglected livestock and dairy sectors, as better breeds of buffalo would attract new entrepreneurs.

He pointed out that buffaloes constituted 30 percent of the cattle population and contributed more than 60 percent of the total milk yield

in India and Pakistan, whereas its contribution to dairy field in Bangladesh was very negligible now. Lal Teer, which has a buffalo farm

in Mymensingh and has been trying to produce better breeds through conventional breeding by importing semen from Italy in recent years, thinks that BGI's partnership and the subsequent success in buffalo genome decoding would usher in a new era in buffalo rearing in Bangladesh.

Agriculture Minister Matia Chowdhury has welcomed the private sector's initiative in frontier research in livestock. Talking to this correspondent over the phone yesterday, she also said the government was already promoting buffalo farming in "char" areas.

Bangladeshi scientist Maqsudul Alam, a professor of the University of Hawaii, who earlier decoded the genome of papaya in the US, rubber plant in Malaysia and jute in Bangladesh, yesterday congratulated the buffalo genome project team and hoped this would take the country's genomics science to a new

A couple of years back when the BGI and the Lal Teer embarked on the buffalo venture, BGI President Dr Jian Wang had said, "We believe this project will have significant contribution to the breeding and the understanding of water buffalo evolution."

Under the collaboration agreement, Lal Teer Livestock provided the BGI with the DNA samples from water buffalo for analysis.

The BGI, also credited for its epoch-making human genome mapping project, applied its stateof-the-art facilities to the sequencing job that included sequencing and bioinformatics analysis, includ-

ing genome assembly, annotation and evolutionary analysis.

According to available statistics, world's current buffalo population is 168 million, of which 161 million are in Asia with India, China, Pakistan and Egypt being the top

four abodes of water buffaloes. Scientists say genomic analysis allows not only the understanding of the species but also their economic importance (milk, meat, disease resistance in the case of

buffalo). The first genome project --Human Genome Project -- was declared in 2003 and till date genomes of some 25 species (plants, animals) have been decoded.

Among the developing nations, Bangladesh remains in the forefront of genomic research with its credit in genome decoding of four species already -- two verities of jute, a fungi and buffalo.

OPPOSITION LEADER'S BENEFITS

The Leader and Deputy Leader of the Opposition (Remuneration and Privileges) Ordinance, 1979 doesn't give any details about the salary and other benefits of opposition leader. It only says he/she is entitled to the same salary, allowances and other privileges received by a full minister.

According to the Ministers, State Ministers and Deputy Ministers (Remuneration and Privileges) Act 1973, the opposition leader is entitled to get a monthly allowance of Tk 53,100 and an official residence furnished at a cost of Tk 5

He/she also gets allowances on taking up and laying down office, travelling expenses for himself/herself and the family, costs of transporting household items of 4,500 kg by freight train, steamer or vehicles, and costs of transporting two personal

The opposition leader receives sumptuary allowance of Tk 6,000 a month, an

official car, a jeep for essential official purposes, house rent of Tk 45,000 a month if official residence is unavailable, and costs for supply of electricity, gas, water, telephone and the like at the residence.

He/she is treated as a very important person while travelling on official duty, and receives travel allowances for journeys abroad, medical facilities and discretionary grant of Tk 4 lakh a year.

The opposition leader maintains an office at Jatiya Sangsad Bhaban and is entitled to have a private secretary, an assistant private secretary, two personal assistants, three office assistants and three peons

Khaleda enjoyed all above facilities and benefits as leader of the opposition. PERFORMANCE OF HER MPS

Under Khaleda's leadership, opposition lawmakers belonging to the BNP and it two allies -- Jamaat-e-Islami and Bangladesh Jatiya Party -- joined only 76 sittings in the ninth parliament, setting a new record of lowest attendance by opposition MPs.

In the eighth parliament, the AL-led opposition lawmakers skipped 223 of the 373 sittings, while the BNP-led opposition MPs stayed away from 163 of the 382 sittings in the seventh parliament (1996-2001).

The AL-led opposition MPs boycotted 135 of the 400 sittings in the fifth parliament that was dissolved a few months before the expiry of its five-year term.

The opposition MPs, who boycotted most House proceedings of the ninth parliament, availed themselves of all facili ties in the last five years.

BCB chooses FROM PAGE 1 a promotion. If India, England and Australia (who according to the proposal cannot be relegated) form the three lowest teams in the top tier, then Bangladesh will have to

face the fifth-ranked side. The impossibility of the situation is that the progress that Bangladesh have so far made has largely been due to them playing top-ranked opposition. If the proposal is adopted they will be playing against lower-ranked opposition and so scope for improvement outside the top eight will be improbable. The cricket eco-system is a fragile one with the few countries at the top needing to play each other -- with all the different conditions each country offers -- to stay competitive. The proposal will also remove power from the ICC and therefore any semblance of accountability of the top boards. It stands to harm cricket as a whole, but Bangladesh, and Zimbabwe, will be the swiftest and most tragic casualties.

BCB president Nazmul Hassan Papon hinted that when voting in favour of the draft proposal they took the long-term future of the game in account, citing reasons such as appeasing the powerful boards in order to gain future favours. What he and the BCB may have missed, however, is that with this draft proposal there may not be a longterm future for Bangladesh
