# BCL men go on the rampage

Cop among 10 hurt, BNP office, several houses vandalised

At least 10 people, including a policeman, were injured and local BNP office was set afire during a turf war between two factions of Bangladesh Chhatra League in Chuadanga on Thursday.

During the clash, Chhatra League cadres vandalised two shops, one motorcycle, a truck, an auto-rickshaw and six houses. They also torched a police van.

Locals and police said the groups -- one led

by Chuadanga unit President Sharif Hossain and another by General Secretary Joarder Anik - clashed for two hours sending a wave of panic through the area.

Anik and his supporters were returning after receiving Abdul Momin, an accused in a criminal case, from the district jail in a motorcycle procession.

As they reached Impact Hospital around 6:30pm, the rival group allegedly hurled two cocktails at the procession, injuring Anik and his associate Rimon.

Both sides got locked in a pitched battle that also spread to several other parts of the town.

Later, police and Rab stepped in to bring the situation under control.

The victims alleged that the BCL men while vandalising the shops and houses looted cash and valuables. The BCL leaders denied the allegation. The

feuding groups blamed each other for the violence. The houses that came under attack also

include the residences of BNP leaders Khondokar Abdur Jabbar and Lt Col (retd) Sayed Kamruzzaman and Awami League leader Shafiqur Rahman Shafi.

Shafi's wife Shahida Khatun, 48, was hurt in the incident.

Constable Shahidul, Khalid, 18, Malek, 26, Raju, 25, and truck driver Alamgir, 25, and his helper Manik, 18, were also among the injured.

Of them, the driver and the helper were admitted to Chuadanga Sadar Hospital while others were given first aid, hospital sources

Meanwhile, BNP acting secretary general Mirza Fakhrul Islam Alamgir condemned the attack on their party office by the Chhatra League men and demanded arrest of persons responsible.

Chuadanga Police Station Officer-in-Charge Ershadul Kabir Chowdhury said additional policemen were deployed in the town.

# Embattled Turkey PM to freeze judicial reforms

Turkish Prime Minister Recep Tayyip Erdogan yesterday offered to freeze key parts of a controversial justice reform bill in an apparent climbdown in the face of widespread opposi-

The compromise was welcomed by the main opposition party, which had warned the legislation would threaten the independence of the judiciary.

The row has added to the deep political turmoil in Turkey, which has spread to financial markets with the lira again hitting all-time lows on Friday.

Erdogan said ahead of an expected late-night vote in parliament that the legislation relating to the Supreme Board of Judges and Prosecutors (HSYK) would be suspended.

While other articles of the bill would be voted on, Erdogan said he had now agreed to "freeze the part on the Supreme Board of Judges and Prosecutors so that we can make progress because the elections are nearing".

However, the ultimate fate of the bill was not immediately clear as Erdogan also said it was "out of the question" that the reforms would be withdrawn completely.

The European Union, which Turkey has long sought to join, along with rights groups and the opposition had warned that the measures could threaten the independence of state institutions and undermine democracy. The leader of the main opposition Republican

People's Party, Kemal Kilicdaroglu, welcomed Erdogan's statement as a "very right decision" and a "democratic gain" for Turkey.

The move came a day after lawmakers again came to blows during a parliamentary debate on the bill.

The government has moved to curb the judiciary in the wake of a massive corruption scandal that has ensnared several key business and political allies of Erdogan.

It accuses supporters of influential Muslim preacher Fethullah Gulen in the police and judiciary of acting as a "parallel state" and instigating the graft probe to try to topple the government ahead of key elections this year.

The embattled Erdogan has retaliated by sacking hundreds of police and prosecutors running the investigation and vowed to rid the state from what he described as a "tumor" and a "virus", referring to the so-called Gulenists.

issued to mark what they call "The day [January 25] of democracy's death".

Bangladesh Krishak Sramik Awami League or BAKSAL, propagated by Father of the Nation Bangabandhu Sheikh Mujibur Rahman, was a political amalgamation of all the political parties in the country. Passed through the fourth amendment to the constitution on January 25, 1975, it banned all the existing political parties, including the Awami League.

BAKSAL was later dissolved after the assassination of Bangabandhu on August 15, 1975.

Referring to Awami League's role in establishing BAKSAL in 1975, Khaleda Zia alleged that the party killed democracy and established an autocratic administration by depriving people of their fundamental rights.

"Apprehending the danger [of losing] of a free and fair election, the party scrapped the system of neutral caretaker government from the constitution and it has once again deprived the people of their voting rights. It is not even hesitating to put the country's unity, solidarity and sovereignty at stake to make its autocratic rule longer through holding a farcical election," the BNP chief.

She also claimed that the people of the country are committed to ousting "the neo-BAKSAL government" to reinstate democracy in the

## Feroz made chief Thirty feared dead in Canada old home fire around 50 to 60 elderly people, half of them

Canadian firefighters searched the ashes of a Quebec retirement home Thursday after it burned nearly to the ground on a bleak midwinter night, leaving more than 30 residents feared dead. Quebec police confirmed five fatalities from

the blaze, while three dozen more remained unaccounted for as rescuers prepared to search through the night for more victims. The search and an investigation into the cause

of the fire were hampered by up to 30 centimeters (a foot) of ice covering the wreckage after water used to douse the fire froze. The blaze at the 52-unit home, which housed

more than 85 years old, broke out shortly after midnight. "We could hear screaming from inside. The fire

was intense, it was like a haystack on fire," witness and neighbor Pascal Fillion told Frenchlanguage public broadcaster Radio-Canada. By 1:00 am, the building "was completely

engulfed in flames, which were fanned by the wind," he said. The home is in L'Isle-Verte, a small town 450

kilometers (280 miles) northeast of Montreal with a population of around 1,400 people. The town's acting Mayor Ginette Caron told a

news conference that most residents of the home are reliant on caregivers.
