PM takes the helm

Decides to do the trouble-shooting in all major projects

Prime Minister Sheikh Hasina yesterday said she herself would oversee major projects of different ministries on a weekly basis and work as a troubleshooter to speed up their implementation.

The government has already decided to fast-track six mega schemes -- Padma bridge, deep-sea port, metro rail, Rampal and Rooppur plants and LNG terminal.

To expedite other major projects, Hasina asked all the ministries to prioritise tasks which she herself will monitor regularly. According to several ministers, this engagement of the

prime minister aims at carrying out visible development work to win over the people in the wake of the criticism over the one-sided January 5 polls. Speaking at a weekly cabinet meeting, Hasina asked

Communications Minister Obaidul Quader about the progress of the 200km Dhaka-Chittagong and 87km Dhaka-Mymensingh four-lane projects. December last year was the deadline for the two projects,

the implementation of which is vital for the country's economy. The Dhaka-Chittagong highway especially is seen as the lifeline of exports.

The prime minister asked the ministry to finish the tasks quickly to ease public sufferings, said meeting sources.

HC clears way for Ctg arms haul verdict

The High Court yesterday

cleared the way for a trial court to deliver verdict in the sensational 10-truck arms haul cases by rejecting four petitions of the accused.

The accused had prayed to the HC to allow them to cross-examine the first investigation officer of the two cases and transfer the cases to a new court.

KIBRIA MURDERERS NOT UNMASKED YET

Wife waits, in vain still



Nine long years have passed but justice still eludes Asma Kibria. Her hopes for seeing punished the mastermind behind the killing of her husband Shah AMS Kibria, Awami League leader and former finance minister, seem to be fading away.

She is frustrated that there has been no significant progress in the Kibria murder case though her husband's party, the AL, has been in power for more than five years.

"His [Kibria] party has come to power again. At first, [when the AL came to power in 2008] we thought that the trial would be held for sure. But we were disappointed," Asma said in an interview with Channel 24, a private TV station, yesterday.

Kibria's family observed his ninth death anniver-

at the long delay in getting justice. The AL leader along with four others

was killed in a grenade attack on a rally at Baidyer Bazar in Habiganj on January 27, 2005.

"They [the AL] are in power for the second consecutive term. Let's see whether they do anything ... they can do it [complete the trial] if they want. But I don't know whether they will or not," Asma said.

"Till now, we have not seen any signs that make us hopeful," she said.

The day after the grenade attack, Abdul Mazid Khan, organising secretary of Habiganj district AL, filed two cases -- one for murder and the other under the Explosive Substances Act -- with Habiganj Sadar

BNP leaders stuck in cases

HC asks govt not to harass 3 leaders, lower courts reject bail pleas of 2

The High Court yesterday directed the government not to harass or show three BNP leaders including its Vicechairman Sadeque Hossain Khoka arrested in any other cases "without due process of law".

Two other party leaders are its Joint Secretary General Rizvi Ahmed and Golam Akbor Khandakar, organising secretary of Chittagong BNP unit.

The HC order implies that police cannot harass or arrest the leaders in connection with any cases if there is no specific

BANK LOOTED THRU' TUNNEL

Culprits at it for 2 years

Central bank moves to beef up vault security

The tin-roofed house from where a tunnel was dug to break into the Sonali Bank vault may have been rented out solely for the burglary purpose.

The two-room house was given to one Sohel two years ago, but it bore no vestiges of daily living. Instead, it is full with earth removed to make the underground passage.

Police yesterday detained the owner of the house for interrogation.

Meanwhile, police have no lead to catch the robbers yet, a whole day after the discovery of the bank robbery. The burglars had made off with Tk 16.4 crore.

CID Inspector Md Shahjahan said, "We found a used cap and a mask from which we will be able to trace out DNA profiles of the robbers. We also found

some cloths, spades, electric wires, electric saw blades etc."

The robbery took place at the bank's main branch in Kishoreganj located on Isa Khan Road, Rathkhola.

Anwar Hossain Khan, superintendent of Kishoreganj police, said: "We have found that while renting the house Sohel had told the house owner that he was there for work. He never specified what sort of work though."
