SC scraps acquittal by HC

A five-member bench of the Appellate Division headed by Chief Justice Md Muzammel Hossain passed the order after hearing a leave to appeal petition against the HC decision filed by the Anti-Corruption Commission (ACC) in 2011.

But the grounds on which the SC passed the order could not be known as its full text was not released yet. However, the ACC's counsel Khurshid

Alam Khan said the SC came up with the order after accepting his arguments that the HC in its verdict did not review the statements made by the witnesses before the lower court in the case.

Barrister Ajmalul Hossain, lawyer for Tuku, could not be reached for comments

on the issue.

On March 21, 2007, the anti-graft body filed the case against the BNP leader with the capital's Mohammadpur Police Station on charges of illegally amassing wealth worth Tk 2.57 crore and concealing information about it.

Special Judges Court-5 in Dhaka on November 15, 2007 jailed Tuku for nine years as the corruption charges were proved against him.

In December 2007, the BNP leader filed an appeal with the HC against the lower

court decision. The HC on June 16, 2011 acquitted Tuku

of the corruption charges.

On December 4, 2011, the anticorruption watchdog filed the leave to appeal petition with the apex court against the HC judgment.
