HERMAPHRODITE BEATEN TO DEATH IN HABIGANI

Lawmaker's brother accused of killing

A hermaphrodite died on Sunday, after brother of a lawmaker and his men had allegedly beaten the person up on suspicion of a mobile phone theft at Nabiganj upazila in Habiganj Saturday night. The deceased was identified as Ador Kha, 24,

child of Daulat Kha of Jahurpur village in the upazila. The family of the deceased filed a murder

case with Nabiganj Police Station against Belal Chowdhury, younger brother of lawmaker from Habiganj-1 Munim Chowdhury, and three to four unnamed others.

Locals said Belal's mobile phone had been stolen from his business place Amin Decorators on Saturday night. Belal and his men captured Ador on suspicion of the theft and took Ador to the decorator office in Aushkandi Bazar around 11:00pm. There they tortured the hermaphrodite.

At one point of the torture, Ador lost consciousness and was taken to a friend's house in nearby village of Durlavpur, they added.

Informed, Ador's family members rushed their and brought Ador home in the small hours of Sunday. Ador breathed the last around 1:00pm that day.

Ador's brother Dilu Kha, the complainant of the case, said that in critical condition, Ador had told him that Belal and three to four of his employees tortured Ador to make the hermaphrodite admit to the theft.

"As Ador tried to run for life, they chased Ador down beat her up until midnight," said Dilu quoting Ador as saying.

Belal told reporters that Ador had been beaten up by a mob for stealing the mobile phone. Later Ador was handed over to police. When police had taken Ador to look for the mobile phone, Ador fell sick and died, he added.

Jahangir Alam, officer-in-charge of Nabiganj police, said Ador had been tortured for stealing. Later Ador fell sick and died, he Lawmaker Munim claimed that it was locals

who had tortured Ador. "My brother was not involved in it," he said. Ador's body was sent to Habiganj Sadar

EU needs 'to clear the air' with Russia at summit: official

The EU needs "to clear the air" with Russia at a summit today as sharp differences over the Ukraine crisis and eastern Europe test relations, a senior EU official said.

After Ukraine President Viktor Yanukovych ditched an EU accord in November under pressure from Russia, "there is a strong sense that we could not simply have a business-as-usual summit," the EU official said yesterday.

"It cannot be a matter of just ticking the boxes," said the official, who asked not to be

Stressing that the European Union and Russia were bound by "an extremely strong trading relationship," the official said Ukraine's decision in November to turn to Moscow rather than Brussels meant the two sides now needed "a strategic, fundamental discussion".

24 more Bangladeshis detained in KL

Twenty-four more Bangladeshi workers were detained in Malaysia in last two days as a nationwide crackdown on illegal migrants continued.

These detentions took the number of Bangladeshis rounded up in the crackdown to 297. On January 21, Malaysian government

launched the operation to streamline the country's labour market. "A total of 8,642 expatriates were inspected

and 2,134 were detained for not possessing valid documents, overstaying and possessing forged passes or permits," reported Malaysian National News Agency, Bernama, quoting Immigration Department Deputy Director Saravana Kumar Marimuthu.

Of the detainees, 870 are Indonesians, 306 are Myanmarese, 148 are Indians, 113 are Cambodians and the rest 697 are other nationalities, it added. The massive crackdown started after the
