Besides Pobitro, ACC has quizzed Motahar's bodyguard and chauffeur, the stenographers of Speedy Trial Tribunal-4 and Special Judges Court-3, where the judge served. Today, office assistants of the two courts will be interrogated.

ACC sources said so far with information gathered in the interrogation, they had been able to get into the corruption network and acquire further clues about the corruption charges. Some very important persons will also be quizzed in the coming weeks, said an ACC source.

The graft watchdog opened investigation against the judge on January 20 after it received allegations that Motahar, who retired last December and left for Malaysia on January 8, amassed huge wealth illegally and laundered money abroad during his service term.

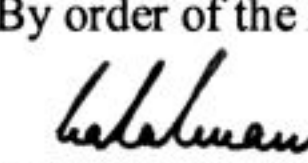
