> This year the commission also plans to spend more than double the money used in the previous upazila parishad election in 2009.

> Around Tk 148 crore was spent for holding elections to 479 upazila parishads on January 22, 2009. The cost will shoot u up for a host of reasons.

"For example, we will have to send electoral materials in six phases to different districts because the elections will take place in as many phases. In addition, we will have to pay polling officials more this year for election duties," said

a deputy secretary of EC. EC officials have proposed to pay Tk 3,000 to a presiding officer instead of Tk 1,000, Tk 2,000 instead of Tk 7,00 to polling officers, and Tk 1,500 instead of Tk 6,00 for election duties.

"Now, the commissioners will take the final decision, said EC officials. Besides, costs will soar in other sectors like deployment of law enforcers, electoral materials transportation, postal communication and others, they added.

## AL forms 7 committees

leaders would start a countrywide organisational tour today aiming to ensure party victory in the elections through resolving all disputes among the party's grassroots leaders, party insiders told the Daily Star.

The seven committees will be led by: AL presidium mem-

bers -- Matia Chowdhury for Rangpur division, Mohammad Nasim for Rajshahi, Syeda Sajeda Chowdhury for Dhaka, Mosharraf Hossain for Chittagong and Obaidul Quader for Sylhet -- and party advisory council members -- Amir Hossain for Barisal and Abdul Latif Siddique for Khulna division--, said a press release.

Party sources said the committees would finalise lone candidates for upazila chairman and vice-chairman posts in each upazila.

Earlier, AL Chief Sheikh Hasina asked the party activists at grassroots level to choose lone candidates for the posts of chairman and vice-chairman in each upazila, and directed AL lawmakers not to interfere.

The upazila polls will be held in two phases -- one on February 19 and the other on February 27.
