Cops shrug off Yusuf's claim of no one else being involved

Police suspect others were involved in the Kishoreganj Sonali Bank heist although the prime accused, Yusuf Munshi, did not disclose any new name during his seven-day remand.

Yusuf's second wife Mahila Akter, truck helper Alamgir, and Abu Bakar Siddik, an MLSS, have been arrested over the looting of Tk 16.40 crore on January 26.

Meanwhile, Monday's High Court order to transfer the case to Rapid Action Battalion within 48 hours has not been complied with.

34 Bangladeshis held in Malaysia

Malaysian police detained 34 Bangladeshis at a labour camp in Jalan Teluk Kumbar area following a scuffle between some Bangladeshis and Indonesians on Monday night.

Bangladesh High Commission sources in Kuala Lumpur said some Indonesians had beaten up a Bangladeshi over an argument. In retaliation, some Bangladeshis and Malaysians assaulted four Indonesians.

Three people sustained injuries and were sent to hospitals, said a police officer. Seventy seven migrant workers were detained for questioning.

PUNISHING PROVIDER OF FALSE INFO

Why it should not be unconstitutional

HC asks ACC, others concerned

The High Court yesterday asked the authorities concerned to explain why the provision of the Anti-Corruption Commission law for punishing individuals, who will provide false information against a person, should not be declared unconstitutional.

The Speaker to Jatiya Sangsad, cabinet secretary, prime minister's office secretary, law secretary, and ACC chairman have been asked to reply to the rule in two weeks.

The court ruled after hearing a writ petition that said the provision would discourage people from providing information of corruption to the ACC. According to Section 28 (Ga), if anyone submits any false allegation to the anti-graft body against a person, the informer will be jailed for a maximum of five years.

PRISONS OVERCROWDED



Gonojagoron Mancha observes 1st anniversary

Exactly one year ago from yesterday Bangladesh saw one of the biggest demonstrations in recent times.

Youths, later joined by several thousand citizens of all ages, flooded and occupied the capital's Shahbagh intersection protesting the life sentence of war criminal Quader Mollah and demanding capital punishment.

The government dismantled the structures, dubbed as Gonojagoron Mancha, erected by the protestors there on February 22, five days after the International Crime Tribunal act was amended.

The amendment created the provision allowing an appeal against the life sentence, leading to the execution of Mollah on December 12 for crimes he committed against humanity during the 1971 Liberation War.

However, this one achievement is not the end of the movement, quipped Gonojagoron Mancha activists celebrating the movement's first anniversary yesterday.

Its Spokesperson Imran H Sarker administered an oath to sustain the movement until every war criminal was handed down the highest punishment, their economic, social and cultural organisations were boycotted and Jamaat-e-Islami and Islami Chhatra Shibir were banned.

He also vowed that the movement will stand against communal attacks. Several hundred people brought out a procession touring past Bangla Motor and Dhaka University's Teacher-Student Centre bearing colorful, artsy placards and a gigantic version of the first flag of Bangladesh.

The Shahbagh intersection was adorned with street art and the road was lined with posters while women rights activist Rokeya Kabir unveiled a book which documented the movement.
