A 'missing' five-year-old boy was found murdered at a banana garden at Pathalia Naobhangachar village in Sadar upazila of the district on Tuesday morning.

Hapless Hossain Ali, son of Apel Miah and Hosna Begum, was staying with his maternal grand-parents at the village as his father divorced Hosna who is now working in Dhaka.

Since then Hossain went missing. Grand-father Amej Uddin looked for the boy

Being informed by two other children who had seen Hossain along with Aminul at the banana garden, police arrested Aminul at 9.30pm, said Joynal Abedin, subinspector (SI) of sadar police station.

Hearing of a case against Limon deferred again

College student Limon Hossain, shot and maimed allegedly by Rapid Action Battalion (Rab), could not see withdrawal of the charges in a case lodged by Rab even after eight months of a home ministry order as hearing for the purpose was deferred for the sixth time on yesterday.

The hearing has been deferred to April this year as the chief judicial magistrate (CJM) of Jhalakathi was transferred in August 2013 and the acting CJM, Senior Judicial Magistrate Md Arifuzzaman does not have the jurisdiction to hear such appeal, said advocate M Alam Khan Kalam, additional public prosecutor of Jhalakathi, and advocate Akkas Shikdar, defence lawyer.

Limon Hossain, then 16, got his left leg amputated at National Institute of Traumatology and Orthopaedic Rehabilitation Hospital in Dhaka on March 27, 2011, as Rab had shot him on the leg near his house at Jamaddarhat in Rajapur upazila of Jhalakathi on March 23, 2011.

The same day, Rab filed two cases with Rajapur Police Station against Limon and

seven others -- one under the arms act (GR-45) and another on charge of obstructing government duty, making attempts to murder and injuring Rab personnel (GR-

Sub Inspector Ariful Islam, investigation officer, submitted charge sheets of the two cases on April 24, 2011, and July 1, 2012, against Limon, and seven others.

The matter created huge sensation as newspapers ran reports on the matter and human rights activists became vocal about
