ASK leaders say at four founders' memorial

Bangladesh's human rights situation is still disappointing because the state is continually failing to ensure rule of law, strengthen democracy and stop extra-judicial killings, observed Ain o Salish Kendra (ASK) leaders yesterday.
They were addressing a memorial programme on ASK's four founding members, Advocate Aminul Hoque, Barrister Salma Sobhan, Justice KM Subhan and former IGP Abdul Khaleque, in the capital's Chhayanaut.



Bent with age and helpless against the moves of Mother Nature, this elderly can now only point at where her property once was at the edge of Beltola where Barisal city meets the Kirtankhola river. Why not fresh poll in Laxmipur-4

HC asks EC citing allegations of rigging, irregularities

The High Court yesterday asked the Election Commission to explain in four weeks why it should not be directed to hold a fresh election to Laxmipur-4 (Ramgati-Kamalnagar), cancelling the results of the January 5 vote in the constituency.
The court came up with the rule after hearing a petition filed by independent candidate Md Azad Uddin bringing allegations of irregularities and rigging in the election.
Awami League candidate Md Abdullah won from Laxmipur-4 constituency through the January 5 vote. The HC bench issued the rule upon the EC and the winner, said Deputy Attorney General Rona Nahrin.

Tamanna's employment violated law, rights

Activists, experts say about the 10-year-old domestic help who died after a stove fire

The employment of 10-year-old domestic help Tamanna, who died after being burnt in a stove fire at her employer's house Monday, was a violation of the law as well as human rights, according to experts and rights activists.
Syed Sultan Uddin Ahmed, assistant executive director, Bangladesh Institute of Labour Studies in Dhaka, said the Bangladesh Labour Act 2006 prohibited employment of children under 14 years of age, but poverty forced families to send their kids to work.
Tamanna caught fire while lighting a gas stove to boil water at her employer's house in Shulakbahar area in Chittagong city on January 24, suffering 40 percent burns. She died 17 days later in Chittagong Medical College Hospital.

Rabbani murder verdict today

The High Court is set to deliver a verdict today on the long pending appeals filed in connection with the sensational Commodore Ghulam Rabbani murder case.
Rabbani was an aide-de-camp (ADC) of Father of the Nation Bangabandhu Sheikh Mujibur Rahman, and a vital prosecution witness of Bangabandhu murder case and jail killing case.
Criminals shot Rabbani, the then managing director of Korean Export Processing Zone (KEPZ), in the throat by intercepting his microbus at Muradpur in Chittagong when he was going to the KEPZ on April 11, 2004. He died at a hospital in Bangkok on April 24, 2004.
On April 7, 2005, a Chittagong court

MEDICAL PHYSICISTS, BIOMEDICAL ENGINEERS

Accreditation stressed

Medical science experts at a roundtable yesterday underscored the need for accreditation of medical physicists and biomedical engineers through an autonomous board to ensure proper treatment.
The board should comprise the Dhaka University's (DU) Department of Biomedical Physics and Technology, Bangladesh Medical Physics Association (BMPA), oncology societies and the ministries of science and technology and health and family welfare, they said.
The roundtable was jointly organised by the department and BMPA at the DU Centre for Advanced Research in Sciences.
The department Chairperson Prof K Siddique-e-Rabbani said flying a Boeing 777 requires a license because it concerned the safety of many lives.
Only accredited medical physicists should operate radiotherapy machines for "many advanced machines are coming to medical service and a small mistake can cause damage to patients", he added.
Pro-Vice-Chancellor Prof Dr Shahid Akhtar Hossain said, "I do not want to die at the hands of a quack."
