Invitation for Expression of Interest (EOI)

For Consulting Services for Design and Supervision of Matarbari Ultra Super Critical Coal-Fired Power Project

- 1.0 The Coal Power Generation Company Bangladesh Limited (CPGCBL) is an Enterprise of Government of the People's Republic of Bangladesh under Power Division, Ministry of Power, Energy and Mineral Resources (MoPEMR), formed under "Bangladesh Companies Act 1994" in order to implement Coal Fired Power Plant Projects in Bangladesh. CPGCBL intends to construct a 2x600 MW Ultra Super Critical (USC) Coal Fired Power Plant at Matarbari area under Moheshkhali Upazila in Cox's Bazar District.
- 2.0 The Government of the People's Republic of Bangladesh (GoB) has currently applied for ODA loan from a reputed development partner towards the cost of a 2x600 MW USC Coal Fired Power Plant at Matarbari area under Moheshkhali Upazila in Cox's Bazar District including the cost of this consulting service. The complete project will comprise of construction of Port and Harbour for coal unloading, USC Coal Fired Power Plant consisting of 2 (two) units with capacity of 600 MW each, 400 KV Transmission lines from Matarbari to Anowara, Access road from Chittagong Cox's Bazar National Highway to plant site and Electrification of Matarbari area. CPGCBL will implement 2x600 MW USC Coal Fired Power Plant including Port and Harbour for coal unloading and Electrification of Matarbari area components of the Project. The Project is expected to be concluded by 2023. CPGCBL intends to engage the consultants for design & engineering, preparation of bid documents for EPC contract, bid evaluation, monitoring and assessment of the Project activities including construction supervision as well as providing advisory services for the project's O&M and environmental issues (the consultants);
- 3.0 The consultants will be selected through Quality Based Selection (QBS). Should the application to the development partner for the loan is accepted, the latest edition of "Guidelines for the Employment of Consultants" and "Standard Request for Proposals" of the development partner would be followed;
- 4.0 This EOI invites international consulting firms and Joint Ventures (JV) with inputs from both international and local specialists who are interested to render the services as the consultants under the Project;
- 5.0 The scope of the consulting services is as follows;

a. Preparation of the Basic Design for the total project work

b. Detailed Design for the Port & Harbour and Civil Works

c. Preparation of bid documents, bid evaluation and facilitation of pre-contract discussion for EPC contract

d. Construction supervision and certification

e. Facilitation of implementation of Environmental Management Plan (EMP)

f. Environmental Monitoring Plan (EMoP) and Resettlement Action Plan (RAP)

g. Technology transfer

h. Preparation of project's progress reports and documents including Project Completion Report (PCR).
- 6.0 Applicants must submit the EOI with furnishing the following information including supporting documents and the formats [Annexure 1, 2 and 3].

6.1 General Firm/JV Experience

a. Firm's registration certificate

b. Firm's profile: i.e. management, no. of employees, areas of specialization, track record including list of all consulting services provided within last fifteen years, etc.

c. Latest annual report

d. Summary of financial status of the firm/JV as per Annexure 3 supported by audited financial statements (balance sheet, profit & loss account, and cash flow statement) for the last five years

e. History of litigation in courts or any arbitration proceedings (if any)

f. In case of JV, JV agreement or memorandum of understanding among the partners.

- 7.0 In case of JV, the documents/information about working experience as mentioned in Clause 6.0 above for each member firm is required.
- 8.0 The consulting firm shall be solely, and in case of JV all the member firms shall be jointly and severally, liable for the entire performance of the contract, assigning sub-consultant will require prior approval of CPGCBL. The consulting firm/JV shall remain responsible for the performance of the sub-consultant(s).
- 9.0 The EOI document will be available in the website of CPGCBL and BPDB www.cpgcbl.gov.bd and www.bpdb.gov.bd respectively from 10/02/2014. Interested consulting firms/consortium may download the document from abovementioned website and convey CPGCBL of their interest in this EOI. Consulting firms/consortium shall submit one (1) original and four (4) copies of the EOI in sealed envelopes marked with "EOI for Consulting Service for Design and Supervision of Matarbari Ultra Super Critical (USC) Coal Fired Power Project" with soft copy in CD-R.
