#### Yusuf's war trial closed his ongoing trial at ICTY.

acquittal of AKM Yusuf for crimes against humanity and genocide for which he was indicted.' The three-member tribunal led by

Justice Obaidul Hassan with members Justice Md Mozibur Rahman Miah and Justice Md Shahinur Islam also regretted the "sudden death" of Yusuf as it "deprived" him as well as the victims of justice.

The 88-year-old Jamaat nayeb-eameer died at Bangabandhu Sheikh Mujib Medical University on Sunday.

Yusuf, who was buried at his village home at Rajoir in Sharankhola of Bagerhat on Tuesday, had been facing 13 war crimes charges. The closing argument of his case was scheduled to start yesterday.

When the court sat at 11:15am yesterday, the prosecution prayed to the tribunal to proceed with Yusuf's case, despite his death.

"The matter cannot be ended with his death," Prosecutor Syed Haider Ali said.

He appealed to the court to deliver a judgement or at least dispose of the case with some observations, terming it "a demand of the nation".

As the tribunal asked Haider to give instances of the continuation of trial from home and abroad even after the death of a lone accused, he cited the case of Slobodan Milosevic, former president of Yugoslavia, who died during Although ICTY (International

Criminal Tribunal for the former Yugoslavia) put an end to Milosevic's trial after his death in 2006, International Court of Justice (ICJ) announced the order [formal end to his trial] "ineffective", Haider said. Besides, this case is not a usual one as

the gravity of his [Yusuf] offences is very strong, he added. Haider, however, said as per the

domestic law, an accused gets discharged after his or her death. Saifur Rahman, who was a counsel of

Yusuf, said there was no way to proceed with the case after Yusuf's death. "He [Yusuf] will be considered innocent after death. The tribunal, in its order, said ICTY

and ICJ are two different judicial forums and only the appeal chamber of ICTY can intervene over the order of ICTY trial chamber. "In the absence of instances either

domestic or international, we are not convinced with what has been submitted by the learned prosecutor," said Justice

After a long delay, he said, the trial against Yusuf "significantly offered" the victims of 1971 a "fundamental occasion" to see and participate in "valid

"We regret that the accused's sudden death has surely deprived not only him

but the victims and sufferers, who with the aspiration of getting justice narrated the enormous pains and horror they sustained resulting from serious systematic crimes, in the dock," said Justice Hassan. "But with the death of the accused,

the rest of the proceedings have become redundant," he said.

"However, the testimony of victims and sufferers, who came before the tribunal, shall ever be considered as a response to the legitimate needs of justice," Justice Hassan said.

The court asked the authorities concerned to preserve the case documents according to the procedure. It also asked the jail authority to submit Yusuf's post mortem report immediately.

According to prosecution documents, Yusuf established the Razakar force, an auxiliary force of the Pakistani army, on May 5, 1971, at an Ansar camp on Khan Jahan Ali Road in Khulna with 96 Jamaat activists. He also named the

Yusuf landed in jail on May 12 last year, hours after Tribunal-1 took the charges against him into cognisance. Later, his case was transferred to Tribunal-2.

A total of 27 prosecution witnesses including the investigation officer testified against Yusuf while his son Mahbubur Rahman testified as the lone defence witness.

# 2 more killed in 'gunfights'

against the death sentence to Jamaat leader Delawar Hossain Sayedee in February last year.

When the police reached 2 no bridge on Keranihat-Bandarban road around 11:00am, some 20 Jamaat-Shibir activists opened fire on the law enforcers, Najmul Haque said, adding that police had fired gunshots in response.

All but bullet-hit Jasim and Rafuque fled the scene around 20 minutes after

the gunfight, he said. Police said they had recovered two firearms, eight bullets and sharp

weapons from the spot. The injured duo was taken to Satkania Upazila Health Complex around 12:00 noon. But Medical Officer of the hospital Rakib Hasan referred them to Chittagong Medical College Hospital where they reached

around 3:30pm. The duty doctors in the CMCH declared Jasim dead, while Rafique was undergoing treatment there.

Karim Uddin, Rafique's younger brother, said some plainclothes policemen had picked up Jasim and Rafique, and shot them afterwards.

He admitted that the duo had taken part in demonstrations after Sayedee's conviction last year.

Meanwhile, on information that some carjackers were passing through Satkhira district after hijacking a car of Sanjana Zerin, wife of an army officer stationed at Dhaka Cantonment, police signalled the car to stop at Chaltetola in the town around 12:30am yesterday.

Sensing danger, the carjackers fired five to six shots and hurled three crude bombs at the law enforcers, Inamul

Haque, officer-in-charge of Satkhria Sadar Police Station, said, adding that police had fired in retaliation.

After 15 minutes of the gunfight, police arrested bullet-hit Ekramullah Babu, 40, a resident of Sultanpur in the town and Shahidul Islam of Modhumollardangi area.

Babu died at Satkhira Sadar Hospital around 4:30am, hospital sources said.

Shahidul, now undergoing treatment at the hospital, claimed that Mahbubur Rahman, an acquaintance of Babu, was driving the car, which he claimed to be belonging to one of his relatives now visiting India, to Satkhira town when police asked them to stop.

A police constable also received minor injuries, police claimed.

The car was hijacked at Rajanigandha Shopping Tower in the capital around 3:30pm Tuesday, police said.

outlets -- one for headphone and another for charger. Iqbal Hossain Sujon, publisher of

the book, said one of his friends imported electronic gadgets from China and that he had suggested the idea after coming across some interactive books. Passing from the statistic department of Dhaka University, Sujon

used to work for a share market investing company. But when his friend came up with the business idea, Sujon began to think how he could apply this innovative technology. Himself the father of a four-year-

old child, he thought of bringing out books that would assist children in learning at the primary stage. Sujon borrowed money from his family members and friends to start

the business. Then he developed the content and the software and then imported the devices from China in May last year. He published 5,000 sets of books in the first lot. Every set that has four

books and a device with a charger costs Tk 4,000 but at the book fair it is available for Tk 3,500. "I wish I could produce more to make the books more affordable."

Sujon continued that the books could be used as education material by the Department of Mass Education.

### Concern mounts as govt

launch probe into the extrajudicial killings, the government criticised those who brought such allegations and asked them to file cases. On Tuesday, at an interview with

BBC Bangla Service in London, Law Minister Anisul Haque said the government would launch probes if only specific allegations of extrajudicial killings were made. "If there are incidents of extrajudicial killings and we get com-

plaints and then if we find evidence, we will identify those involved in the extrajudicial killings and bring them to book," he Asked why the government is not

filing cases and launching probes on its own in connection with extrajudicial killings, the law minister said that was possible if a victim's family or anyone filed a case. Interestingly, the government

had previously filed suo moto cases in connection with incidents of street violence and vandalism. Police even arrested scores of people on suspicion. Contradicting the law minister,

criminal law expert Khurshid Alam Khan said the government has more responsibilities in cases of extrajudicial killing. "The government must file a case

as soon as possible so that the trial of an extrajudicial killing can be held," he said, adding that it would help the government ensure transparency and remain vigilant. Kazi Rezaul Hoque, full-time
