# Landing station size cut to ensure navigability

The size of the temporary landing station being built on the eastern slope of the Meghna River for unloading the heavy equipment for the under construction 1200 MW plant of Ashuganj Power Station Company Limited (APSCL) will now be reduced by 20 feet.

The decision has been taken as per suggestion of Bangladesh Inland Water Transport Authority (BIWTA) to ensure unhindered navigability of the river, APSCL sources said.

On Tuesday, an eight-

member team, headed by Md Manzoor Quadir, joint director (Port) of BIWTA, visited the spot where TSK Spain, the contactor of 1200 MW power plant of APSCL, is making the temporary landing base with the help of local workers to unload pieces of heavy equipment weighing over 380 tonnes

As the team found that the 70×60 feet landing base may partially hamper the navigation, they advised APSCL to move it 20 feet towards the riverbank.

"One year ago, we gave permission to APSCL to use

the bank of the Meghna River temporarily to land heavy equipment for setting up its 1200 MW plant. Now process is on to renew the permission," said Manzoor

"The permission is likely to continue till completion of the plant. In case of any damage or loss to any party due to activities of APSCL, the power station authorities must compensate," he added.

Md Nurul Alam, manag-APSCL, said, "The landing base will be used only for

power plant and will be closed after completion of the base. As the pieces of equipment are very heavy, we have to unload those from barges to land, instead of jetty."

ASPCL produces 730MW electricity at present.

Its under construction mega-plant will start power generation in December 2014 and reach 1200MW production capacity by June 2016.

#### 2000 kg hilsa seized near border

Members of Border Guard Bangladesh (BGB) seized 2,000 kilograms of hisla fish while those were being smuggled out to India through Gatipara border point here early yesterday. Acting on a secret infor-

mation that a huge quantity of hilsa was being smuggled to the neighbouring country, a team of the 23-BGB battalion raided the area early in the morning and seized of the fish worth Tk 17 lakh, said BGB commanding officer Lieutenant Col Mostafizur Rahman.

The BGB team fired 22 gun shots as smugglers tried to resist them. However, no one was injured in the firing.

BGB could not arrest anyone as the smugglers managed to flee the spot sensing the presence of the border guards.

#### 2 punished for using chemical in fruit

A man was jailed and his son was fined by a mobile court on Tuesday for using toxic chemical to ripen bananas at Durakuti village in Sadar upazila.

In a special drive, the mobile court caught Mahir Uddin, 58, and his son Jahangir Alam, 18, along with the toxic chemical for yellowing bananas in a room beside their home.

Executive magistrate of the mobile court Aktarunnesa handed down the verdict on the spot in presence of police and

Mahir Uddin was jailed for six months and his son Jahangir Alam was fined Tk one thousand. The court realised the fine money from Jahangir on the spot.

Police and locals said, Mahir and his son had been ripening bananas in only three hours using a toxic chemical which is very harmful for the human being, especially children.

In another drive, two drug peddlers -- Belal Hossain, 38, and Abdul Quddus, 38 -- were jailed by the mobile court near the same spot and around same

Of the two convicts, Belal was jailed for six months and Quddus for seven

months. Both are residents of Durakuti village and they had been selling contraband Indian drugs including phensidyl and hemp since ong, police said.

### 30 houses gutted

At least 30 houses, including 10 tin-shed ones, were gutted in separate fire incidents that took place in Kushtia and Sylhet districts on Tuesday.

In Kushtia, a fire broke out at Mohishkundi village in Daulatpur upazila at noon, burning down 20 houses, reports UNB.

Locals said, the fire originated from a kitchen stove at the house of one Khoda Bux at the village around 2:00pm and it soon engulfed 19 other adjacent houses.

Locals doused the blaze before the fire fighters reached the spot.

Affected house owners claimed that the extent of loses from the fire could go up to Tk 20 lakh.

In Sylhet, at least 10 tinshed houses were destroyed in a fire at Karikona village

in Bishwanath upazila in the afternoon. Fire service officials said the fire broke out at a tin-

shed house at Firoz Mia Colony at the village around 5:00pm and it soon spread to other adjoining houses.

The extent of losses from the fire was estimated at Tk10 lakh.

### Watermelon farmers in Kalapara worried

Saline water has continued entering the cultivable land through the broken door of a sluice gate, much to the worry of a large number of watermelon farmers in Kalapara upazila.

The affected growers of Dhankhali and Champapur unions of the upazila formed a human chain in the sluice gate area on February 3, demanding immediate steps to resolve the problem.

The participants said that the saline water started entering their watermelon fields after one of the three-door sluice gate was

broken six months ago. Over 1000 farmers of the areas were

cultivating the fruit for the last few years as it was more profitable than paddy farming. Kalapara upazila agriculture extension office sources said, about 500 hectares of

watermelon cultivation this year. Of them,

the DAE fixed a target for cultivating the fruit

on 70 percent of the land in the unions. Farmer Abdur Rashid Akon of Dhankhali village expressed grave concern as he cultivated watermelon on his 26 acres of land this year.

Despite repeated appeals, the authorities are yet to take any steps to repair the broken door of the sluice gate, he said.

Other farmers -- Rashid, Hanif Mridha, Abdur Razzak Mridha and Nazib Sikder of the village -- made similar allegations.

We earned about Tk 50 lakh from selling the fruit last year, said grower Akon.

We will incur a serious loss this year if the authorities did not repair the sluice gate in

time, he said. Upazila agriculture officer Md Moshiur Rahman said, non-stop flow of saline water into the lands threatened watermelon cultivation.
