Cops crossed limits at RU

Says NHRC chief; fact-finding committee blames BCL, RU officials for Feb 2 attack

Police crossed their limits and did wrong by attacking Rajshahi University (RU) students who protested fee hikes and evening shift master's courses, NHRC Chairman Mizanur Rahman said yesterday.

Mizanur made the remarks when members of a fact finding committee, comprised of former RU students to investigate the February 2 incident, handed over their report to him at his office in the capital.

According to the report, the attack was a pre-planned one as some top officials of the RU administration, deputy commissioner of Rajshahi metropolitan police and BCL leaders of RU unit had held a meeting just before the incident.

cadres carried out the attack while some top RU officials, including three assistant proctors -- Shakhawat Hossain, Sirajul Islam and Helal Uddin -- led the assault, it said. Around 100 students of RU and

eight journalists were wounded on the

League (BCL) men backed by police attacked the students. The NHRC chairman demanded that the persons responsible for the attack be identified immediately and

superintendent, SM Anwarul Karim, their carpentry trainer Arif Mondol and automobile engineering teacher Zahir were also responsible for their situation.

"I often saw my son with bruised eyes and cheekbones. He told me that teachers had beaten him," said Jorina Begum, mother of a 14-year old. She came running to the centre after the authorities had informed her that her son was injured and in a "bad state".

In efforts to keep outsiders in the dark about the management, the overall environment, and the physical condition of those who had harmed themselves badly, the Gazipur Juvenile Development Centre has not been letting anyone in except for children's guardians.

Three hundred and eight children, including convicts, are living in the centre that has the capacity to house 200.

The juveniles whose cases are on trial are kept there with the convicts for 22 hours of the day, as claimed in the letter.

Sixteen of the last week's protesters are not yet convicted. They are facing

"International conventions do not allow keeping convicts and children on trial at one place," said Quazi Riazul Haque, chairperson of the children's rights committee of National Human Rights Commission.

Many of the inmates are violent and are often locked in vicious fighting, said people in the neighbourhood who see this all through the windows of the dormitories.

"If the children are violent then it must be investigated if the counsellors [at the centre] are doing their job properly," said former inspector general of police M Enamul Hoque who had dealt extensively with juvenile crimes.

Five counsellors are employed at the centre to look after the mental wellbeing of the children.

Asiya, the mother of Rajib, 14, said she had once seen her son with bandaged arms and forehead. When asked, Rajib told her that older boys had beaten him up.

Besides, drug addiction is rampant at the centre, said Aminul Islam, a programme manager of child rights organisation Aparajeyo Bangladesh. He had worked on a project at the centre in 2009.

"Of the current inmates, 45 have been held under the Narcotics Control Act," said Nasima Begum, secretary of the social welfare ministry.

There is no facility inside the correction centre for drug rehabilitation.

When asked why, Ayub Hossain, director general of the social welfare department, claimed the centre did not have any drug addict.

Azhar Ali Miah, deputy director of

the Gazipur social welfare department, said, "They [children] do not have access to drugs at the centre. How can there be any drug addict?" Requesting anonymity, police

sources, however, told The Daily Star that the children were given small amounts of drugs they had been addicted to to keep them from becoming violent.

All these issues, however, appear insignificant to the children whose daily basic needs are not well taken care of.

"My child slept on the floor throughout this winter without any pillow and blanket," lamented Jahanara who came to visit her son.

The process of obtaining food and other resources often takes a long time as it gets caught up in bureaucratic tangles, said Aminul, the programme manager of Aparajeyo Bangladesh.

Children do not get enough soap for proper hygiene, their toilets are often overflowing and there is often very little food, said Mohammad Anisur Rahman Bhuiyan Firoze, convenor of the Gazipur office of Bangladesh Manabadhikar Council. He had worked with the juveniles for a long

"I have even found cases when parents brought food and money for their children, but the authorities kept those for themselves," he added.

Azhar, social welfare deputy director in Gazipur, refuted the allegation. He said the children were allowed to step out to meet their guardians so they could hand the gifts themselves.

Mohammad Joynal Abdul Maisbhandari, who came to see his son, said how he had once been locked in a balcony, and the goods he had brought were confiscated by the authorities.

Mohammad Ali Asgar, whose younger brother is an inmate, shared a similar experience. "They tore my shirt and lungi, beat me up and took away

"6 April 5 May 6 May and realisation of Bangladesh", an audio clip posted in mujahideenmedia.wordpress.com, is one of such items. It slams the Shahbagh movement, Sheikh Hasina and the Awami League government and brands them as enemies of Islam. It also claims at least 3,000 Muslims were killed during the crackdown on Hefajat-e Islam activists in Motijheel in the early hours of May 6, 2013. Interestingly, the audiovisual message

said to be Zawahiri's starts with photographs from a rally of Hefajat-e Islam, a Qawmi madrasa-based radical organisation. The Hefajat, however, denies links

with the post.

During a press briefing at the Rab

headquarters in the afternoon, Rasel admitted he circulated the clip through his Facebook page and blogs. "I have shared the dawahilallah link of the Zawahiri clip in

On February 8 this year, Rasel uploaded this message under the title "Silent Genocide in Bangladesh" in his blog islameralo.wordpress.c

In the meantime, Jihadology, which describes itself as a clearinghouse for Jihadi source materials, released the item on January 14, saying

this was a new message of Zawahiri and it was presented by As-Sa ab, known as the media house of al-Qaeda. This time the title was "Bangladesh: A

Massacre behind a Wall of Silence".

However, it surfaced in the mainstream

media not until February 15. On May 7 last year, Rab said, a message from krasel73@yahoo.com was sent to dr-ahmadinejad@president.ir, an e-mail ID of the then Iranian president Mahmoud Ahmadinejad. Its title was "Mass killing on protesters in Dhaka at night by armed Joint Forces at least

Rasel claimed he removed some IDs from the admin panels of his blogs for their jihadi write-ups. He, however, admitted many of his Facebook friends write posts in favour of Jamaat-e-Islam and militancy.

At the briefing, Rab Media Wing Director Habibur Rahamn said Rasel spread the audiovisual message through

several Facebook IDs and page

basherkella2 and blogs.

"He is an IT expert and very active with Facebook and blogs -amardeshvabna.blogpost.com, islameralo.wordpress.com and amardeshvabna.wordpress.com. He was very active to have the message widely circulated."

Through spreading the message, Rasel had tarnished the country's image and violated the ICTAct, the Rab official added. During yesterday's raid, the Rab seized

three cell phones and many jihadi books from his possession. Two hours later, in a separate raid at

his village home in Kaliganj upazila of Gazipur, the elite force seized two laptops and some Islamic books, said Rasel's relative Bilkis Begum over the phone. She added that Rasel's family members who were present during the raid went into hiding afterwards.

The Rab said it had found documents on militancy in the laptops.
