in 'shootout'

An alleged robber was killed in a "shootout" between police and his cohorts in Shyamnagar upazila of Satkhira early yesterday.

A sub-inspector and a constable of Shyamnagar Police Station received minor injuries during the gunfight.

The dead, Ashraf Hossain, of Kurikaunia village in Ashashuni upazila, was the ringleader of a gang of robbers, said Sagir Miah, officer-incharge of the station.

He was accused in 20 cases filed with different police stations there and jailed for 11 years in an arms case, the OC said.

Police started a drive in the area, adjacent to the Sundarbans, around 12:30am following information that Ashraf was holding a meeting with his associates there.

When the law enforcers reached there on a speedboat around 4:00am, the gang members opened fire on the law enforcers forcing them to fire back, the police official said.

After a 15-minute gunfight, police recovered Ashraf's bullet-hit body but his associates managed to escape by a trawler.

Doctors declared Ashraf dead around 7:30am when he was taken to Shyamnagar Upazila Health

Complex. Police recovered a gun, a machete, four cocktails and two cartridges from the spot.

Rakib, who was commander of the militant outfit in Khulna division, was nabbed around 3:00pm. Following his escape from the prison van, he had shaved his long beard to avoid arrest, but police identified him from the marks of fetters on his hands and legs.

Law enforcement agencies continued their hunt for the two others in Mymensingh and Tangail.

Police said they had picked up Rakib from Gazipur's high security prison, Salahuddin from Kashimpur-1 and "Boma" Mizan from Kashimpur-2 jails and started for Mymensingh around 7:15am.

As the van reached Signboard point, a truck waylaid it. As planned, a black Toyota Voxy microbus with armed criminals aboard was already following the prison van from Gazipur, while other members of the gang were waiting at Signboard point in a white microbus.

With the prison van blocked from both sides, the gang got down and started shooting and hurling crude bombs.

The attackers then snatched the key from the law enforcers, opened the door of the van, cut the fetters with rod cutters and took away the JMB men, said Firoz Talukder, officer-in-charge of Trishal Police Station.

They took only five minutes to finish the operation and fled away in two groups, before people from nearby villages and markets rushed there. The white microbus

headed for Mymensingh and the Zakaria, 29, and handed him over and directed them to capture the black one made a U-turn and drove towards Shakhipur via Bhaluka, police said.

guarding the rear gate of the prison van, was hit by multiple bullets and bombs. He died on the spot. Two other cops -- Subedar Habib

and Constable Sohel Rana -- were wounded and sent to Mymensingh Medical College Hospital.

Law enforcers recovered one live and two used bullets of 7.65 pistol from the spot. They also found the two Chinese guns that the attackers snatched from the police.

The gang chose the Signboard point as there is no house or other establishment nearby.

barricade near Shakhipur Police Station. Around 11:00am, as a speedy black microbus (Dhaka Metro Cha-11-6048) was coming towards the barricade, police signaled it to stop but it drove away.

Meanwhile, Gazipur Reserve Police Inspector Saidur Rahman and Subedar Abdul Kader were suspended for negligence of duty, said Gazipur Superintendent of police Abdul Baten. But he did not clarify what their duties were.

attack in several years, following a series of bomb blasts by the outfit during 2004-2005.

HINDI MOVIE 'GUNDAY'

Dhaka protests history distortion

Dhaka has conveyed to New Delhi a

deep sense of hurt and disappointment over the distortion of historical facts about the 1971 Liberation War in the Hindi film "Gunday". The foreign ministry in Bangladesh

protested against clearing of the film by the Central Board of Film Certification, India and urged the authorities to move immediately to stop screening of the film in its present form, according to a press release issued yesterday. Gunday, produced by Yash Raj

Films, was released in India on February 14. It portrays the birth of Bangladesh in 1971 as a result of a 13-day battle from December 3 between India and Pakistan, undermining the nine-month-long bloody war the then East Pakistan fought with the West Pakistan. The war claimed as many as three million Bangalees.

Bangladeshis from across the world have expressed their strong disapproval of the film on social media and demanded an apology from the production company. Against the backdrop, the pro-

ducer of the film has recently offered an apology to the people of Bangladesh. In the press release, the foreign

ministry said its attention had been drawn to the media reports and reactions of people, particularly on the social networking sites, over the film.

"The matter has already been raised officially with the Indian authorities," states the press release.

The ministry and the Bangladesh High Commission in New Delhi have been working on ascertaining the veracity of the reported distortion of historical facts in the film, it adds.

Apart from Sohel, other mentionable leaders still eluding arrest include Masum, MA Sadik Babul, Abdullah alias Kafi, Abdullah alias Abu Jahid, Abu Sayeed Sheikh, Abdullah Al Mamun and Mir Mosharraf Hossain.

The sources suspect the outfit carried out yesterday's attack as part of a plan to revamp its strength.

Sohel Mahfuj might have made the plan from his hideout in a neighbouring country to snatch Mohammad Rakib Hasan Russell alias Hafez Mahmud and Salahuddin alias Salehin, who are the third and fourth top-ranked leaders of the outfit, said a top Rab official.

"Sohel Mahfuj, who is the oldest and most experienced among the existing JMB leaders, got the ability to reorganise JMB," said the Rab official wishing anonymity.

An official of another agency said if the dreaded leaders like Hafez Hammud, Salehin and Mizan join the group again, it would definitely be a threat to the country's stability. The Islamist outfit grasped the

spotlight as a hardcore militant organisation after blasting 459 synchronised bombs in 63 districts on August 17, 2005 leaving two persons dead and 50 others injured.

In subsequent attacks, it also killed a number of people including two judges in Jhalakathi, sending a chill through the nation.

With his neatly trimmed beard, Mizan looked unsurprised over what was going on around him that night. "I am on a path to justice and truth, you too should follow the lead," he had told reporters at the scene.

Following the confessional statement of Mizan, also known as Zahidul Islam, Rab busted a "minimunitions factory" of JMB in East Monipur of Mirpur and recovered 11 bombs, plastic explosives, grenade casings, fuses and detonators, a pistol, and a huge stock of chemicals.

Mizan from Shekherbhita of Jamalpur Sadar upazila was jailed for different terms for possessing arms, ammunitions, attacking a judge

and exploding bombs.

He was given eight years' rigorous imprisonment in the sensational August-17, 2005, serial bomb blast case filed in Cox's Bazar. A Dhaka court on June 4, 2012, sentenced him and his wife to 37 years' of rigorous imprisonment each for possessing weapons and bullets. He was also given 34 years' of rigorous imprisonment in absentia for a bomb attack carried out on a judge in 2005.

Once a computer shop worker in Tangail, he was JMB ehsar (fulltimer) since 2001 and had close relations with the executed militant kingpins Shaekh Abdur Rahman and Siddiqul Islam alias Bangla Bhai.

After his arrest, he had told The Daily Star correspondents, "I don't explode bombs; I rather train others how to make bombs and grenades."

In 2003, Mizan was arrested in Jhikargachha of Jessore, but was out on bail after three months. Since then he had been on the run.

He had visited a number of countries including Afghanistan.

Since, fives cases, including the one against Jamaat-e-Islami chief Motiur Rahman Nizami, in the tribunal have seen no progress.

Apart from the case of Nizami, the cases against Jamaat leaders ATM Azharul Islam and Abdus Sobhan, BNP leader Zahid Hossain Khokon, and Mobarak Hossain, former Jamaat-e-Islami member who later got affiliated with ruling Awami

League, are under trial in the tribunal. Besides, several petitions regarding contempt of court are also pending.
