Two held for rape

Police arrested two youths at Shahbajpur village in Rajnagar upazila on Tuesday noon on charge of violating a teenage girl. The arrestees are Rajon Miah, 28, and Mahmud Ali, 28, of the area. Police said one Dildar Ali, 29, Siddik, 25, of the village, Rajon and Mahmud forcibly picked up the 13-year-old girl from her house in absence of her parents early in the morning. They then took the victim to a nearby tranquil place and raped her. Hearing the hue and cry, locals rescued the girl and sent her to the hospital. However, the rapists managed to flee. A case was filed in this connection, said Kamrul Hasan, officer-in-charge of Rajnagar Police Station.

Woman electrocuted

An elderly woman was electrocuted at Notun Bhanderdah village in Sadar upazila on Tuesday. The dead is Jarimon Nesa, 60, wife of Sukur Ali of the village. Family sources said Jarimon come in contact with a live electric wire while she was collecting wet clothes from a cable and died on the spot. An unnatural death case was filed in this connection, said police.

Robbers loot house

UNB, Sylhet

Robbers looted valuables worth Tk 10 lakh from an expatriate's house at Bagbain village in Chhatak upazila early Tuesday. Police and locals said a gang of 10/12 entered the house of expatriate Majmil Ali by breaking open the door and held the house inmates hostage at gunpoint. They then took away 14 tolas of gold ornaments, Tk 2.50 lakh and other valuables and fled the scene.

Man murdered

A young man was killed allegedly by his neighbour at Teliapara Tea Garden village in Madhobpur upazila of Habiganj district early yesterday. The deceased is Bimol Dio, 28, son of Modhu Dio of the village. Yasinul Haque, officer in-charge of Madhobpur Police Station, said Sumon Shangma, son of Tomal Sangma of the area, beat up Bimol mercilessly, leaving him dead on the spot following an altercation over a trivial matter. Sumon went into hiding after the incident, said the OC.

Four held with arms

Police arrested four alleged criminals along with a pistol, four bullets and a magazine at a pre-cadet high school in Jaleshwaritola area of the town on Tuesday night. The arrestees are Faysal Ahmed Shaorav, 22, son of late Wasim Miah of SP lane of Malotinagar, Rumman Khalifa, 23, son of Shajahan Khalifa of Sutrapur, Mohammad Ashlam, 22, son of Badsha Miah of Kanujigari and Shajal Ahmed, 25, son of Rezaul Karim of Badurtola of the town. Town Sub-Inspector of Bogra Monjurul Islam Bhuiyan said on secret information, they raided the school around 9:00pm and

Teenager at life risk as FP inspector aborts her

A Class IX student is battling for life at Nawabganj upazila health complex in the district following unauthorised operation by a family planning inspector to abort her.

The girl, 15, daughter of a rickshaw-puller, became pregnant as Ruhul Amin, 22, son of Yasin Ali of Daudpur village in Nawabganj upazila, lured her into physical relation, saying that he would marry her, said family members.

But Rurul Amin, also a degree student of Daudpur Degree College in Nawabganj, refused to marry her when he learnt about the pregnancy.

Informed of the matter, Rurul Amin's sister Jui Akter and aunt Shefali Akter, took the girl to the house of Salma Begum, a family planning inspector of Nawabganj Upazila Health Complex, on Thursday. There Salma made the

girl unconscious and aborted her.

Afterwards, the girl fell sick with profuse bleeding.

The same night, she was admitted to Nawabganj Upazila Health Complex in a critical state.

Contacted, Salma Begum said she did the work as Jui and Shefali told her to do it, saying that the girl was married.

"The girl is still at risk as the operation was not done in a proper way and part the embryo has remained inside her womb. We have referred her to Dinajpur Medical College and Hospital," said Dr Sheikh Mohammad Ershad, medical officer of Nawabganj upazila.

If abortion is done by a non-technical person, it poses serious risk for the patient, including difficulties in becoming mother in future, said a doctor of the hospital.

Rurul and his family members left the area.

AKM Abdullah Abu Syed,

officer in charge of Nawabganj police station, said the girl's father made a complaint regarding the incident mentioning the names of Jui, Shefali and Salma Begum and primary investigation by the police found the matter true.

Meanwhile, the culprits are threatening the victim's family members through mobile and engaged influential people to negotiate the matter, said the victim's family members.

Fake doctor jailed

A mobile court sentenced a fake doctor to four months' imprisonment in Jaliyapara area under Ramgarh upazila yesterday.

It also fined convict Mohammad Mujibur Rahman, 35, Tk 50,000.

On secret information, the court, led by Executive Magistrate Minhazul Islam, raided an eye treatment camp in the area at noon and sentenced Mujibur for not having legal certificate.

AL men severs tendons of BNP leader

Activists of ruling Awami League severed tendons of a local BNP leader at Karamullah Bazar under Sadar upazila yesterday.

The victim, Md Belal, 35, is publicity secretary of Esbalia union unit of BNP.

Locals said local leaders and activists BNP and its associate bodies were sitting at the election camp of a BNP-backed candidate in the upazila election at the bazar at around 11:30am

Suddenly, a group of AL activists swooped on the camp and chased the BNP men. As Belal protested the attack on the

camp, the AL men took him to a place at the bazaar and cut the tendons of his left legs.

Locals rushed him to a private clinic in the district town in a critical condition.

Contacted, officer-in-charge Mosharraf Hossain Tarafder charge of Sudharam Model Police Station said he was aware of the incident.

In Munshiganj, A union parishad chairman sustained stab injuries in an attack allegedly by the activists of Awami in Sadar upazila yesterday, reports our correspondent.

The injured was identified as Sona Miah Bepari, 70, chairman of Mohakali union parishad and a supporter of BNP.

Bring Sabita Chakma's killers to book

Demands rally in Rangamati town

Chittagong Hill Tracts (CHT) unit of Stop Violence Against Women (SVAW) and Women Resource Network (WRN) jointly formed a human chain in front of the deputy commissioner's office in the town yesterday, demanding arrest of the killers of Sabita Chakma in Khagrachhari on February 15.

Sabita Chakma, 30, wife of Debo Ratan Chakma, of Komolchhari village in Khagrachhari, was killed after rape allegedly by some settlers on the bank of Chengi River.

Addressing a rally at the venue, leaders and activists of the two organisations police could not arrest the killers despite knowing the identity of the killers even 10 days after the incident.

Incidents of killing and raping of indigenous women are on the rise in hills as the perpetrators go unpunished, they said.

They speakers demanded arrest of the rapists and compensation for the victim's family.

Advocate Sushmita Chakma, coordinator of WRN Rangamati unit, its

Khagrachhari coordinator Lalosa Chakma, President of CHT Nagorik Committee Goutam Dewan addressed the rally.

They said Sabita went to the bank of Chengi River to collect grass for their cattle at noon. Md Nizam, Razzak, Ziaul Haque and Md Anwar, who were loading sand onto a truck there, forcibly took her to a nearby jungle and killed her after rape.

As she did not return home in the evening, her husband Debo Ratan went there and found her body lying in the nearby jungle, they said.
