Laxmipur saw widespread vote rigging yesterday.

Salauddin Tipu, son of AL leader Abu Taher, captured polling stations in Sadar upazila, driving out the agents of Tipu's opponents.

At Laxmipur Government Girls High School centre, Tipu's followers were seen forcing voters to stamp his election symbol, as polling officials and law enforcers looked on.

In Moulvibazar, a voter died from wounds he suffered when BGB personnel swooped on unruly AL and Jamaat men near a polling centre in Rajnagar upazila.

> AL and Jamaat men were locked in a clash near Gobindabati Government Primary School polling centre over control of the station.

In another incident, 10 people were injured in a clash between Jamaat and BNP supporters at Sunadighi of the Activists of AL-backed candidate same upazila around 3:00pm.

> Jamaat men led by party-backed chairman candidate MA Mannan attacked the supporters of BNP favourite Jamim Ahmed, as the latter tried to capture Sunadighi Government Primary School centre, said police.

> In Tangail, AL-blessed candidates' men allegedly captured 37 polling centres and stamped ballot papers in Ghatail upazila before voting began.

> Of the 13 candidates, nine, including those backed by the BNP, the Jamaat and the Jatiya Party, boycotted the election, raising allegations of capture of polling stations and stuffing

The candidates and their supporters laid siege to the assistant returning officer's office at 9:00am and blocked the busy Tangail-Mymensingh Road, demanding re-polling in the upazila.

Around 11:30am, police fired rubber bullets and teargas shells at them, leaving five people wounded.

In Munshiganj, 16 people suffered injuries in clashes in Tongibari and Sirajdikhan upazilas.

AL and BNP activists got into a scuffle at Balai Government Primary School in Tongibari around 11:00am, forcing the election officials to suspend voting for around one-and-a-half

As voting resumed at 1:45pm, the two rival camps clashed over capturing the polling station, prompting police to fire rubber bullets.

The AL-backed candidate's followers beat up two local journalists outside the Panchgaon Government Primary School in the upazila. Police detained two of the attackers.

An AL leader and two Chhatra ingcentres in Sadar upazila. League leaders were injured in an attack allegedly by BNP men at

Abdullahpur Primary School centre.

In Chhagalnaiya upazila of Feni, supporters of AL-backed candidates occupied 30 of the 47 polling centres, and forced the agents of other aspirants to leave the stations between 8:00am and 9:00am.

A gang of armed youths exploded crude bombs and stamped 600 ballot papers around 3:30am at Pathannagar Government Primary School, said Ahmed Ulla, presiding officer at the station.

In Madarganj upazila of Jamalpur, AL men captured polling centres and drove out the agents of the BNP and Jamaat-backed candidates, and cast fake votes for AL-blessed chairman and vice chairman candidates between 8:30am and 11:00am.

The situation was different in Rangamati, where the ruling party men were at the receiving end.

Supporters of the BNP, the Jamaat and Parbatya Chattagram Jana Sanghati Samiti attacked the AL candidates' polling agents in different poll-

The local AL unit called a dawn-todusk hartal for today to protest the attack but later called it off.

BNP men clashed with AL activists over allegations of vote rigging by ruling party men in Araihazar upazila of Narayanganj. Five supporters of both the parties were injured in the

There were incidents of violence and ballot stuffing in three upazilas in Satkhira, Amtoli upazila in Barguna, Kalapara in Patuakhali, Sandwip in Chittagong, Phulchhori in Gaibandha, Kasba in Brahmanbaria and in Narsingdi Sadar upazila.

The commission's failure to check violation of electoral code of conduct and rigging in upazila elections has drawn huge criticism.

Making matters worse, Chief Election Commissioner Kazi Rakibuddin Ahmad left the country for the US on March 3 after two phases of the polls, leaving the EC bereft of leadership.

Election Commissioner Abdul Mobarak, authorised by Rakibuddin to fill in for him, has been making controversial comments, adding to doubts about the EC's ability to conduct free and fair polls.

prevented from entering the centre.

A number of voters, preferring anonymity, said the ruling Awami League men were stamping ballots inside the

Presiding Officer Abdullah Al-Mahmud said unidentified youths snatched 2,500 ballots from the centre.

"Some 2,736 votes have been cast so far [of which 2,500 ballots were snatched]," he said around 11:45am.

This means, 12 votes were cast there every minute.

The Majlishpur Government Primary School centre of the upazila witnessed similar incidents. In the first three hours of polling, 2,000 of the 2,400 votes were cast, which means 11 people voted every minute.

Presiding Officer Abdur Rauf Molla confirmed the casting of 2,000 votes between 8:00am and 11:00am. Asked how that was possible, he said, "People are coming and voting."

Supporters of the AL-backed aspirant forced out the polling agents of the BNP-sponsored candidate and stuffed ballot boxes at the centre.

While visiting the centre around 11:00am, The Daily Star correspondent found none other than the ALbacked candidate's supporters there.

"Please take the money and keep quiet," said Khalilur Rahman, a local Jubo League leader.

Asked about the rigging, Presiding Officer Abdul Mannan said, "I am helpless." In Barguna's Amtoli upazila, ruling

party men stormed different polling

stations even before the voting began and started stuffing ballots. The incidents forced Assistant Returning Officer Md Abdullah to

suspend polling at 12 centres of the upazila. "We had initially suspended voting

at 12 polling stations following allegations of various irregularities. After examining those, we started voting at

four centres," he said.

Conditions in three other upazilas -- Barguna Sadar, Bamna and Patharghata -- were no different.

At least 30 candidates for chairmen and vice-chairmen posts in the four upazilas, including AL rebels and BNP contenders, boycotted the elections over vote rigging by AL men.


At a joint press conference at the sitting chairman's house, they claimed that supporters of the AL-backed candidates had captured 32 of the 59 polling stations and stuffed ballot boxes with the help of some administration officials.

In Feni, for example, supporters of Mesbaul Haider, an AL-backed chairman candidate, were marking ballots randomly at Pathannagar Government Primary School centre in Chhagalnaiya around 8:30am.

At Ballabhpur High School centre in the same upazila, Mesbaul's supporters took away all the ballot papers, marked them in neighbouring houses and then put them in ballot boxes.

That's why the committee members have unanimously made the recommendation for introducing evening session in courts," Suranjit Sengupta, chief of the committee, told reporters at a briefing at the parliament's media centre yesterday.

Citing an example of the evening shift,

Suranjit, also the ruling Awami League

MP, said different countries, including India, have evening shift at courts. He also said the parliamentary watchdog has also proposed enacting

a law for recruiting retired judges in the higher courts to meet the additional requirement of judges for running the evening shift. The committee chief said they have

also recommended increasing by 50 percent the remuneration of higher

court judges.

Suranjit informed the reporters that the remuneration of the chief justice in India is Rs 1 lakh, in Pakistan Rs 1.99 lakh and in Sri Lanka Rs 70,000, whereas in Bangladesh the amount is only Tk 56,000. "Remuneration and privileges of

judges must increase for getting brilliant and quality people in the judiciary," he said. The former minister also said, "It does not matter if the remuneration of the Supreme Court judges is higher

2012 due to political unrest. Additionally, there was an increase in the number of cases filed last year, says a Supreme Court high official. On Sunday, Law Minister Anisul

Huq told The Daily Star that his office had found the reasons behind the increase in the backlog of pending cases and had taken some steps to reduce the backlog.

The minister, however, declined to provide any details about the reasons and steps taken.

A law ministry high official, requesting anonymity, said the government had already amended the Civil Procedure Code to introduce alternative dispute regulation (ADR) for disposing of civil cases through a compromise between the parties in the cases in order to reduce the backlog.

Tribunal sets Apr 17 for decision on contempt

The International Crimes Tribunal-2 yesterday fixed April 17 for a decision on contempt proceedings against David Bergman, a Dhaka-based British journalist, for his write-ups that allegedly questioned the death figure of the Liberation War and demeaned the tribunals' dignity.

The three-member tribunal led by Justice Obaidul Hassan with members Justice Md Mozibur Rahman Miah and Justice Md Shahinur Islam set the date after hearing Bergman's replies. In response to a contempt petition

filed by a Supreme Court lawyer, the tribunal on February 20 asked Bergman to explain his write-ups posted on his personal blog that focused on the indictment order passed on Delawar Hossain Sayedee and the verdict in the case against Abul Kalam Azad.
