### Malaysia keen to recruit 3 lakh Bangladeshis

UNB, Dhaka

Malaysia wants to recruit over 3 lakh workers from Bangladesh soon, visiting Malaysian Home Minister Dr Ahmad Zahid Hamidi said yesterday.

He said this during a meeting with Planning Minister AHM Mostafa Kamal at the latter's office, according to a PID handout. Malaysian High Commissioner in Dhaka Norlin Othman was present.

The planning minister requested the Malaysian government to recruit Bangladeshi workers for Malaysia's agriculture sector.

Hamidi, who is leading a 12member delegation, also held another meeting with Expatriates Welfare and Overseas Employment Minister Khandker Mosharraf Hossain and discussed issues related to mutual interest.

Now on a two-day visit to Bangladesh, the Malaysian minister will leave Dhaka today.

#### Yemen's Hadi defends US drones

Yemen's president in an interview published yesterday defended the US use of drones against Al-Qaeda in his country, despite criticism from rights groups.

President Abdrabuh Mansur Hadi also again accused Iran of supporting southern secessionists and northern rebels as Yemen undergoes a difficult political transition.

The United States has launched repeated drone strikes on Al-Qaeda targets in Yemen as part of its "war on terror" and in support of the army's campaign against the jihadists.

three phases of the polls held on February 19, 27, and March 15. They had closed the gap in the third phase, which was marked by violence

and election rigging. In the fourth phase of polls on March 23, marred by widespread polls rigging, the AL-blessed secured 29 more chairman posts than their rivals favoured by

the BNP, giving them a 27-post lead. Yesterday, supporters of the ALbacked candidates intensified their unlawful activities, like capturing polling stations and stuffing ballot boxes, and made sure AL-favoured

contenders got the victories.

The AL-blessed runners got a sweeping victory in all the 21 upazilas where BNP-backed contenders boycotted the polls in the early hours protesting

election rigging by ruling party men. In those upazilas, the AL-blessed

candidates won by huge margins. For example, in Chhagalnaiya upazila of Feni, the AL-favoured chair-

man candidate won by bagging 59,577 AL rebels won three, BNP rebel one votes and his nearest rival, BNP blessed, got just 10,507, even though the upazila is considered BNP chief

In Satkhira Sadar upazila, the ALblessed candidate got 1,52,851 votes and his rival backed by Jamaat got 44,217 votes. In Debhata upazila of Satkhira, the AL contender secured 53,172 votes and his Jamaat-blessed challenger got only 7,750.

In Tala upazila of the same district, the AL-favourite won the chairman post getting 1,10,628 votes and the Jamaatbacked candidate received 37,946 votes. In the three upazilas of Satkhira, the

candidates blessed by the AL also won

all the six vice-chairman posts, including those reserved for women. Five years ago, the AL-backed candidates won 44 chairman posts in the polls to the same 73 upazila parishads.

The elections were held within a month after the December 29, 2008, lauded parliamentary polls in which the AL had a landslide victory. Both the AL and BNP had made efforts to pick a single candidate for

each post of an upazila parishad by persuading their rebels to quit the race or back off. But rebels were still there in every phase of the polls chipping away at the party vote banks. The upazila polls had become a

prestige issue for both the AL and the BNP as the outcome of the elections would indicate gain or loss of their popularity. The parties had engaged in the elections so much that the nonpartisan nature of the polls was lost.

AB Siddiqui, president of Bangladesh Jananetri Parishad, a pro-Awami League organisation, filed the case with the Dhaka Chief Metropolitan Magistrate's Court. Khaleda made the claim on March

27 at a discussion at the Institution of Engineers, Bangladesh. "With her statement, she belittled

Bangabandhu Sheikh Mujibur Rahman before the international community," Siddiqui said in the case statement, appealing to the court to issue an arrest warrant for Khaleda after taking the charges into cognizance. He also sought the highest punishment to Khaleda as per the law.

# 2 teenage girls raped in Jessore

3 arrested

Two teenage labourers of Akij Jute Mill were raped early yesterday in Monirampur of Jessore after they were abducted on their way home from the factory.

Monirampur police arrested three people in connection with the incident. The arrestees were identified as Hafijur, son of Yunus Dafadar; Jahangir, son of Aziz Morol, and Ripon, son of Ershad Gazi of Bijoyranpur village under Monirampur upazila. Some seven to eight miscreants

obstructed a factory bus at Mandartola around midnight when it was going to Monirampur with some female and child labourers, said the bus driver, Kamrul Islam. They abducted two girls aged 13 or 14. Later, he with the help of villagers

rescued the girls from a nearby banana orchard and found out that the two had been raped around 2:00am. Informed by the bus driver, a police

patrol team arrested two rapists and one of their accomplices from a nearby

house, said Sub-inspector Habib, second officer of Monirampur Police Station.

Mother of a victim filed a case. Medical examination of the girls was supposed to take place in the evening, the SI said.

The rapists are involved in local Awami League politics and are followers of an upazila-level leader, villagers said.

Mother of a rape victim said influen-

contradictory sources". The International Crimes Tribunal-1 on October 3, 2011 mentioned the figures in its indictment order in the case against Sayedee.

During yesterday's hearing, Bergman's lawyer Mustafizur Rahman Khan said one of the articles written by his client was posted around two and a half years ago, but no one, including the prosecutors and investigators, batted an eyelid before the filing of the petition.

Besides, the petitioner did not specifically mention which part of the article was contemptuous, said Mustafiz, adding that his client had written the article for 'fair criticism" and it was not tantamount to "contempt". The intention of Bergman's write-

ups was to assist the court, he claimed. Sara Hossain, another counsel of Bergman, said her client had made a documentary in the 1990s on three
