FROM PAGE 2 pesticides, radioactive substances reactive oxygen or nitrogen and fertilisers largely endanger honey bees, he added.

Pesticides might kill bees quickly or slowly, which was even worse, he said. If not immediately killed, bees carry the contaminated pollen back to their colony where it enters their food chain and kills many more, Dr Mahbub added.

Introduction of such toxic chemicals to a bee's environment by human activities results in abnormal or unusual behaviour, disorientation and even deaths among the species.

Mobile towers and networks may also affect bees and even cause deaths, while climatic condition or fluctuation of temperature with foggy weather may

kill them. ducting more research to find out

the reasons behind the deaths and decline of honey bees. They also advise the block supervisors of the agriculture department to instruct farmers to use insecticides in the afternoon as bees forage on crops

# Gold seized at Ctg airport, again

Customs intelligence officials seized 53 gold bars, weighing 6.18 kg and worth around Tk 2.65 crore, from a passenger of Biman Bangladesh Airlines at Shah Amanat International Airport in Chittagong yesterday.

They also detained the passenger, Anis Chowdhury, who hails from Boalkhali upazila of Chittagong. He arrived on flight BG-048 from Dubai around 7:30am.

Officials searched Anis and

recovered the gold bars hidden inside his socks, said Nahid Nawshad Mukul, assistant director of Airport Customs Intelligence. Since January 1, customs officials

and law enforcers seized around 260kg gold worth over Tk 100 crore.

Officials say the alarming rise in gold smuggling via Bangladesh has resulted mainly from import duty hike on gold in India. Smuggling syndicates are using Bangladesh as a transit point to smuggle the yellow metal to the neighbouring country.

However, following the tests Bangladesh Standard and Testing Institute (BSTI) carried out in 2012, it was found that the shields only had 2.363 grams of gold and an alloy was used instead of silver.

A BSTI deputy director had told the Bangla daily that the government took no action against the shield supplying company Amecon despite having the report about the shields being of lesser material worth.

A month after the delivery of the shields, Amecon received full payment for them, not according to the value of the alleged substandard products they supplied. Minister Mozammel told The

Daily Star Sunday night, "I have already asked the officials of my ministry to get all related documents ready. I will go through them. Actions will be taken against the people responsible immediately if the documents prove them guilty."

## Rwanda president slams France

Rwandan President Paul Kagame took a thinly-veiled swipe at France yesterday, saying it was impossible to "change the facts" about the genocide 20 years ago.

"The passage of time should not obscure the facts, lessen the responsibility, or turn victims into villains," he said in a speech

during commemorations marking the 20th

anniversary of the genocide. "People cannot be bribed or forced into changing their history, and no country is powerful enough, even when they think they are, to change the facts... After all, les faits sont tetus (facts are facts)," he said, saying the final phrase in French and drawing loud applause in the national stadium.
