# MSC's defence dispatches rivals

Mohammedan Sporting Club advanced into the final of the Modhumoti Bank Independence Cup football tournament with a lone-goal win over archrivals Abahani at

the Bangabandhu National Stadium yesterday. The Black and Whites will now take on surprise package Feni in the final on Saturday.

Mohammedan got the all-important goal at the half-hour mark from a nice build-up down the right flank. Hemanta Vincent fed Zongo Ousseni with a neat minus inside the box that the Burkina Faso striker drove hard and low. The goal-bound shot struck the chest of an onrushing striker Zahid Hasan Emily before rattling the roof of the net.

It was Emily who put his name in the scoresheet but more importantly it ended Mohammedan's two-year miserable run against their bitter rivals. Mohammedan not only lost two of their three previous meetings against Abahani this season but also failed to win against them in any competition since their 2-0 success at the Bangladesh Premier League in 2012.

The second semifinal was tipped as a battle between Abahani's attack versus Mohammedan's defence where the heavily fortified Black and White fort triumphed over a toothless Sky Blue attack in front of some 5000 spectators. The ploy adopted by Mohammedan was so frustrating for Abahani coach Ali Akbar that he described it as anti-football after the defeat.

"I did not see any football from Mohammedan, who deployed seven to eight defenders," said a dejected Ali Akbar who also blamed his charges for their lack of mental and physical strength to overcome such a situation.

His Mohammedan counterpart Rui Capella Batista however was very happy with the outcome.

"Before the match I told you guys it was a 50-50 match but my boys put up a big performance against Abahani to make it 100 per cent for Mohammedan," said the Portuguese.

"One-goal lead was enough to defend as my defence organisation and midfield had been in good condition. Our ploy was to defend first and then go for fast counter attack and my boys stuck to their guns," said a happy Batista.

On the back of two defeats and one draw against Abahani this season, Mohammedan started in aggressive fashion and pressed hard in a game in which their performance was a significant improvement from their quarterfinal clash against Muktijoddha.

Zongo, Nigerian Demian Chogozie and Hemanta Vincent controlled Mohammedan's midfield and their hard work almost bore result in the 31st minute when Emily raced deep down the right flank but his shot at the near post just drifted away.

In the next minutes, Mohammedan launched the attack from the right and a promising Vincent nicely dodged past Abahani's veteran defender Sujan inside the box to cut it for an unmarked Zongo, whose shot entered the net via an Emily deflection much to the delight of the Black and Whites faithful.

Zongo again came close to doubling the lead but this time his shot floated over the crosspiece at the stroke of half time.

Mohammedan adopted a counter-attack game in the second half, leaving all pressure on their backline that really stood tall to defy the Abahani forwards.

Abahani's Ghanaian duo Auwdu Ibrahim and Osei Morison threatened to level the margin twice but they were denied by new signing Ubom Henry and Nigerian Bayback. Portuguese forward Neolind Suares was not as bright as he was against Sheikh Jamal and headed his only chance over the crosspiece.

Mohammedan also got a couple of good chances in counter attack but they could not avail any of them, thanks to timely interference from Abahani goalkeeper Shahedul Alam Shohel.

## War of words goes on

Sri Lanka's cricket board and two senior players were locked in a war of words Wednesday, a day TWENTY20 after the World Cupwinning Twenty20 team

returned home as national heroes. Former skippers Mahela Jayawardene and Kumar Sangakkara sparked the row by criticising cricket

officials during a red-carpet reception at the airport, but the board hit back with a strongly-worded statement. Sri Lanka Cricket denied allegations that they had made any disparaging remarks against the duo after they appeared to announce their retirement

underway in Dhaka in mid-March.

Jayawardene was upset with reported comments from a Sri Lanka Cricket (SLC) official, who was said to have accused them of announcing their retirement without prior notice to the board.

"SLC considers such statements as damaging to both the image of the institution and the officials concerned," the board said in a onepage statement.

It said Jayawardene's allegations were taken seriously because he suggested that the purported remarks by board secretary Nishantha Ranatunga and CEO Ashley de Silva could have demoralised the players.

"SLC regrets such unsubstantiated accusations levelled against the secreas the World Cup tournament got tary and CEO by a senior member of the national team without verifying

the facts," the statement said.

Amid the allegations and denials, both players maintained on Tuesday that they had never publicly announced their intention to quit T20 cricket despite giving interviews talking about retirement.

Cricket commentators as well as local and international media played up the final game as a farewell match for the two former Sri Lankan skippers.

On Tuesday tens of thousands of fans joined an all-night party in Colombo after the team was driven in a slow motorcade from the airport, 35 kilometres from downtown Colombo.

The victory on Sunday night against India in Dhaka came 18 years after Sri Lanka's triumph in the 50over World Cup.

#### Quarrel in emergency meeting

With an aim to continue his successful run with the Kolkata Knight Riders (KKR) in the Indian Premier League, ace all-rounder Shakib Al Hasan left for the UAE yesterday morning.

Kolkata will kick-start the seventh season of the IPL with a face-off against Mumbai Indians at Abu Dhabi.

The left-hander played eight games for KKR in the last season and had taken a total of 12 scalps. He had a miserly economy rate of 6.50 and bowled at an average of 16.25. signed up the left-hander. Shakib has taken a total of 52 wickets in T20 cricket last year and was Bangladesh's best performer in the recently concluded T20 World Cup.

Oscar being grilled

South African Paralympian Oscar Pistorius faced fierce crossexamination at his murder trial Wednesday as the prosecution tore into his claim that he never intended to kill his girlfriend.

"You made a mistake?" prosecution lawyer Gerrie Nel thundered indignantly as he questioned the athlete's account of Reeva Steenkamp's death on Valentine's Day last year.

"You killed a person, that's what you did! You shot and killed her, won't you take responsibility for that?" he said just moments into the crossexamination of Pistorius who claimed he mistook Steenkamp for an intruder. Pistorius broke down, as he has done frequently

during the five weeks of his high-profile murder trial. His emotional state and arguments between

prosecution and defence lawyers forced a series of adjournments before Nel returned to the court to show footage of the Olympian firing a bullet into a watermelon. After seeing images of the fruit's pink flesh exploding through the air and hearing Pistorius remark it was "softer than brains" Nel turned to the witness box.

"You know that's the same that happened to Reeva's head," he said, causing a shocked Pistorius to grow more distraught.

Unrelenting, Nel then quickly showed the court a graphic photo of the 29-year-old model's

bloodied head, her blonde hair drenched with dark coagulated blood.

"That's it," Nel said, turning to Pistorius. "Have a look there, I know you don't want to

"I don't want to look at a picture where I'm tormented by what I saw," he said wailing through tears.

discussed. He is likely to remain on the stand for the remainder of this week as his extensive testimony is probed and picked at by Nel, who once won a corruption conviction against a South African police commissioner.

The 27-year-old Paralympian earlier wrapped up three days of emotional and harrowing defence testimony by denying he wanted to kill Steenkamp or the intruder he believed had broken into his house on Valentine's Day last

year. "I did not intend to kill Reeva, my lady, or anyone else," he told the murder trial, in his strongest rebuttal yet of charges against him.

He faces a life sentence if convicted of her murder. But he could also face a murder conviction if the prosecution shows he intended to kill when his life was not threatened -- regardless of whether he knew who was behind the door.

In calling Pistorius as a witness in his own defence, his handpicked legal team tried to counter the state's portrayal of him as reckless and obsessed with fast cars and guns.

Defence lawyer Barry Roux gently painted the portrait of a young man who likes dogs and carries out charitable acts, but who was marked by a fatherless childhood, the early death of his mother, physical disability and recurring crime.

## Wasim to coach BD bowlers?

Former Pakistan pacer Wasim Akram could become Bangladesh's bowling consultant Chairman of the Bangladesh Cricket Board's (BCB's) cricket operations committee Akram Khan had meetings with the Pakistan legend about a possible position with the BCB during the Asia cup and the recently concluded ICC World

Twenty20. According to BCB director Akram, a proposal could be

raised in the forthcoming board meeting.

"The board still does not know anything about the issue. I hope to raise it in the next board meeting. Details such as the number of days he can work with us or the different teams he can work with could be discussed at the meeting, said Akram.

If such a deal is finalised, Akram plans to utilise the legendary bowler, dubbed the 'Sultan of Swing', at various levels rather than just for the national team.

"I will ask the board to bring him in a manner that can help the different levels, starting form the Academy and

Under-17s," he said. In late 2012 Bangladesh had signed up former Pakistan

## Wisden afraid of 'colonial cricket'

International cricket is set for a future of "colonial-style divide and rule," and will be "holding its breath" over the extent of Indian influence, according to the 2014 edition of Wisden Cricketers' Almanack published Wednesday.

In February, changes to the governance of the International Cricket Council (ICC), handed the majority of the powers and revenue to the sport's 'big three' nations -- India, Australia

and England. "Here was colonial-style divide and rule," the English editor of cricket's 'bible', Lawrence Booth, wrote in the 151st edition of British-based Wisden,

published every year since 1864.

"If further proof was required of just how astonishing that was, it came at Perth in December, when for a few moments one Cook and one Clarke added up to exactly one Tendulkar: 200 Test caps, 15,921 runs and 51 hundreds."
