INACTION OVER TANNERY RELOCATION

14 top officials face contempt

The High Court yesterday issued a contempt of court rule on 14 present and former government officials for failing to ensure relocation of tannery industry from Hazaribagh to save the Buriganga river from pollution.

The HC order came following a petition filed by a human rights organisation on April 13.

About five years back, the court asked the officials, including the industries secretary and director general of the Department of Environment, to relocate the polluting tannery factories from Hazaribagh to a new industrial zone in Savar by April 30, 2011.

But the officials didn't take any steps to that end, leaving the Buriganga, the lifeline of Dhaka city, exposed to excessive pollution.

The tanneries in Hazaribagh discharge around 22,000 cubic litres of toxic waste into the Buriganga every day, according to the DoE.

In a 2012 report, the US-based Human Rights watch said the Hazaribagh tannery area is one of the world's most polluted places that affect health of people living around those.

In yesterday's ruling, the court asked Industries Secretary Mainuddin Abdullah, DoE Director General Raisul Alam Mondol, and 12 others to explain in two weeks why they should not be convicted of contempt of court for not complying with its order.

The HC on June 23, 2009 directed them to relocate the tanneries by February 28, 2010. It later extended the deadline for six months.

On October 30, 2010, the court gave them another six months to relocate those. The industries ministry in 2003 took up a project to shift the factories to the new industrial zone in Savar. And 155 industrial plots were also allocated there for this. But there has been no progress in relocating the factories due to negligence

KILLING CAUGHT ON CAMERA

2 key accused left out

Charge sheet against 11; family of victim rejects it

The Rapid Action Battalion yesterday pressed charges against 11 people, mostly Jubo League men, in the sensational murder of Jubo League leader Riazul Haque Khan Milky.

Milky's family, however, has rejected the charge sheet as the elite force has dropped the names of two main

accused. His cousin Niloy Milky said they would file a no confidence petition

against the charge sheet. The two main accused are

Zahidul Islam Tipu, general secretary of Motijheel thana Awami League, and Wahidul Alam Arif, general secretary of Dhaka city (south) Jubo League.

Six of the accused are in jail and five are on the run.

Riazul Haque Milky The charge sheet came almost nine months after Milky was gunned down on the night of July 30 last year in front of a shopping mall in the capital's Gulshan.

Milky's brother Maj Rashedul

Haque Khan filed the case the same night against 11 named and four to five unnamed people. Milky was an organising secretary of Dhaka city (south) Jubo League.

The court will decide on April 28 whether to accept the charges.

Asked why the two main accused were dropped from the charge sheet, Rab Media Wing Director ATM Habibur Rahman said, "We have included the names of those against whom we found evidence of involvement in the murder."

Baishakh tour turns tragic

2 students drown, 4 missing at coast of St Martin's island

A joyful trip turned tragic in a simple twist of fate.

Two university students drowned and four others went missing in the waters of St Martin's where they went to celebrate Pahela Baishakh.

The incident happened on Monday afternoon as they went swimming off the coast of the St Martin's Island in Cox's Bazar.

The dead -- Manfezul Islam, 23, and Saddam Hossain, 22 -- were students of Ahsanullah University of Science and Technology in the capital. The four who remain unaccounted for are their classmates Sabbir Hasan, Shahrier Islam Noman, Uday Mahmood and Ghulam Rahim.

A group of 34 students of CSE department went to the St Martin's to celebrate Pahela Baishakh, the first day of the Bangla calendar year, with no idea that the events that would unfold would haunt them for the rest of their

The Bangladesh Navy ship BNS Nirmul has meanwhile joined the Coast Guard and around 12 trawlers owned by locals in a combined search operation in the Bay of Bengal.

The search operation would continue until they found the students, said Lt Shahid Al Ahsan, St Martin's station commander of Bangladesh

United Airways in trouble

Non-payment of Tk 77cr charges may lead to suspension of operation

Private carrier United Airways (BD) Ltd may face operational suspension due to outstanding aeronautical and non-aeronautical charges of around Tk 77 crore to the Civil Aviation Authority of Bangladesh (Caab).

The airlines regulator has already imposed a ban on sale or purchase of aircraft by United Airways until it

clears all current and outstanding charges in the next one year.
