**ASSAULT ON FELLOW BY TRANSPORT WORKERS**

## Barisal University students block highway

Agitated students of Barisal University (BU) blocked Barisal-Patuakhali highway near the campus at Karnakathi and demonstrated in the city yesterday protesting assault of a fellow student by transport workers.

Later police, transport owners and workers association leaders, and university authorities at an emergency joint meeting settled the matter.

Shafikur Rahman, a student of political science department of BU, and three female students of the same department boarded a Patuakhali-bound bus of Ovi Paribahon to reach the permanent campus of BU at Karnakathi on eastern bank of the Kirtankhola River, witnesses said.

Following an altercation over payment of

bus fare, the transport workers forced the students to get down at the triangular road crossing instead of BU campus stoppage at about 11:00am.

That time Shafikur was assaulted by transport worker Sabur.

Hearing the matter, BU students blocked Barisal-Patuakhali highway in front of the campus.

The also held a sit-in in front of Barisal Metropolitan Police (BMP) Commissioner's office at about 12:10pm demanding arrest and punishment of the assaulter transport worker.

Then a tri-party meeting with the road transport owners and workers associations, BU authorities and BMP officials agreed to introduce reduced fare for students up to the BU campus stoppage, said Golam Rouf, deputy commissioner of BMP.

### Boy killed in wall collapse

A minor boy was killed in a wall collapse in Jamubari-Pokihana area under Badarganj municipality on Tuesday. The deceased was identified as Sabbir Hossain, 7, son of Abdul Momin of Chowdhury village in Kaunia upazila. Police and locals said seven days ago Sabbir went to his maternal grandfather Nuru Mian's house at Jamubari-Pokihana area along with his family members. On Tuesday afternoon, a dilapidated mud wall of Nazrul Islam's house, a neighbor of his maternal grandfather Nuru Mian, collapsed on Sabbir when he was playing beside the wall, leaving him dead on the spot.

### Two held with arms

Army personnel arrested two men along with a revolver and four bullets in Manikchandra para area under Ramgarh upazila early yesterday. The arrestees are Pushpa Kumar Chakma, 40, and Chaihlapru Marma, 22, of the area. Captain Lutfar from Shindukchhari army zone said, acting on secret information, a team raided the area and arrested the duo along with the arms and bullets. The arrestees were later handed over to Ramgarh police station. A case was filed in connection with the incident.

### SSC examinee drowns in Jamuna

A SSC examinee went missing while going to take a dip in Jamuna River at Rohodaha in Kamalpur area under Sariakandi upazila yesterday afternoon. The victim is Hridom, 15, son of Kazi Darul Islam of Azimpur area in Dhaka. He came to visit his uncle's home here. The boy went to take a dip in the river at 3:00pm and remained missing. The rescue operation was underway till filing of this report at 6:00pm yesterday, said Sub-Inspector Shekendar Ali of Chandanbaisha police station.

### Two acid throwers get life

A Sirajganj court yesterday sentenced two people to life imprisonment for throwing acid on a man last year. The convicts are Md Abul Hashem, son of Abul Kashem of Sonatola village and Babu Chan, son of Hassen Ali of Chamandigati village in Ullapara upazila. The court also fined the duo Tk one lakh each. In default, they have to suffer another six months in jail. According to the prosecution, the convicts hurled acid at Hafizur Rahman Alawal of Chamandigati village on April 6 last year over previous enmity. Victim's brother Abdur Rahman then filed a case with Ullapara police station in this connection. After examining witnesses and evidence, Sirajganj District and Sessions Judge Md Abdus Saleque of Acid Crime Protection Tribunal found the duo guilty and pronounced the verdict.

### Drug peddler jailed

A court here on Tuesday sentenced a drug peddler jailed to two years' imprisonment. The convict is Piru Muhammad, 45, son of Azizul Haque of Shingnagar village in Jibannagar upazila. Chief Judicial Magistrate Iyrob Hossain of the court also fined him Tk 5000, in default, he has to suffer another three months in jail. According to the prosecution, on February 1 in 2006, Piru was arrested on charge of possessing 71 bottles of Indian contraband phensidyl from Issarchandrapur area. Later, a case was filed in this connection. After examining witnesses and evidence, the magistrate found Piru guilty and pronounced the verdict.

### HSC candidate stabbed

A HSC examinee was stabbed allegedly by her former husband in Saidpur municipality yesterday morning. The injured was identified as Moyna Begum, 20, daughter of Babul Hossain of Dhonipara village in Saidpur upazila. Locals and police said Abul Bashar, 28, of the area stabbed Moyna following an altercation when she was going to the examination centre at Lions School and College in the municipality from his village home at 9:00am. # Schoolboy burnt alive, 3 houses gutted in Jamalpur

A boy was burnt alive and three houses were gutted in a fire at Haatbari village under Madarganj upazila of the district early yesterday.

The dead is Nazmul alias Nazu, 12, son of Elahi Mondol of the village.

Locals said the fire originated from the kitchen of Elahi Mondol's house at around 3:00am and soon spread to the adjacent three houses.

Nazu, a class three student of Abul Hossain Government Primary School at the village, was asleep in a room of their house and burnt to death.

His elder brother Arif, 15, and sister

Parvin, 9, sustained burn injuries during the incident. Arif was admitted to Jamalpur General Hospital and later shifted to Mymensingh Medical College Hospital as his condition deteriorated. Parvin received treatment at the upazila health complex.

Being informed, fire fighter from Sarishabari Fire Station reached the spot at around 3:50am and extinguished the blaze with the help of locals after half an hour.

Three cows and four goats were also burnt to death. Affected house owners claimed that their properties worth over Tk three lakh were destroyed by the fire.

## 2 killed over land disputes

Two people were killed over land disputes in Chapainawabganj and Laxmipur districts on Wednesday.

In Chapainawabganj, a youth was stabbed to death allegedly by his uncles over a piece of disputed land at Karnokhali-Mirzapur village in Shibganj upazila in the morning, reports our correspondent.

The deceased was identified as Abdul Karim, 28, son of late Mozammel Haque of the village.

Sub-Inspector Sudipta Reza of Shibganj Police Station said there was a longstanding conflict between Abdul Karim and his uncles Monirul Islam and Shukur over the land.

At around 9:00am, Monirul and Shukur went to the land to irrigate Irri crop, but

they were resisted by Karim. At this, the duo attacked Karim with sharp weapons, leaving him dead on the spot.

His body was sent to Adhunik Sadar Hospital morgue for autopsy, said the SI.

In Laxmipur, a man was killed in an attack allegedly by his rivals over land in Basghar area of Ramganj upazila the same day.

The deceased was identified as Abul Khayer Patoary, son of late Basir Ullah of the area, reports UNB.

Police and locals said the incident took place when Abul Khayer along with his supporters tried to prevent his rivals from constructing a building on the disputed land.

The law enforcers later arrested three people in connection with the incident.

## Classes at BAU resume

Classes at Bangladesh Agricultural University (BAU) resumed yesterday.

On April 2, the students of the university started agitation, protesting the killing of Saad and demanding life term expulsion of those involved in the murder.

They also demanded capital punishment of the killers under Speedy Trial Tribunal Act.

The agitating students continued boycott of classes and examinations until April 15, said BAU sources. Saad Ibne Momtaz, 23, a final-year student of Fisheries Faculty of the university, succumbed to injuries at a private clinic on April 1, a day after BCL men had beaten him up with hockey sticks, iron rods and cricket stumps in room No-205 of Ashraful Haque Hall on the campus.

The deceased was also a former organising secretary of Ashraful Haque Hall committee of Bangladesh Chhatra League.

Police are yet to arrest all accused except one Sujoy Kumar Kundua and Md Rukonuzzaman.

Although the students attended the classes yesterday, they threatened to go for a tougher movement if the demands were not met by April 22, said the sources.
