Shibir shoots Jubo League man in Ctg

Shibir activists shot and beat a Jubo League man at Fulo Fakir Haat in Satkania upazila of Chittagong yesterday afternoon, said police.

With bullet injuries in the right leg, Kamal Hossain, 35 an activist of Madarsa union unit, was taken to Chittagong Medical College Hospital.

Satkania police Sub-inspector Shamshul Islam and witnesses said around six armed men led by Shibir activist Sahid shot Kamal after taking him from a shop to a nearby hill around 2:00pm.

The upazila Jubo League General Secretary Abdul Gofur said Shibir activists attacked Kamal to create panic ahead of the verdict of war criminal Delawar Hossain Sayedee.

Denying it, Satkania Shibir President Towfiq Elahi said arm dealers shot Kamal as he was a source of police.

the new tabulation sheets without tallying the marks, they said, adding that then the authorities took away the new tabulation sheets and the matter was left at that.

Responding to the prosecution witnesses, defence lawyer Kazi Sanowar Ahmed said the tabulation sheets submitted by the teachers were tampered with. He said some numbers were cancelled, and new figures were written over those. A total of three prosecution witnesses,

including the two teachers, testified before the Divisional Special Judge Court of Ataur Rahman yesterday. The third witness is Abu

Sayed, a deputy director of the Anti-Corruption Commission. The court fixed April 30 for next hearing.

Over the allegations of the irregularities, an ACC official filed a case with Kotwali Police Station on September 13, 2012, accusing six people, including suspended BR (east) general manager Yusuf Ali Mridha, for manipulating the recruitment process through false documents.

Talking to The Daily Star yesterday, Mahfuzur Rahman, director general (Americas) of the ministry, said issues like regional strategic relations, military assistance, global security issue, UN peacekeeping operations, counterterrorism and disaster management will be discussed at the dialogue.

Sources said officials of both the sides will discuss purchase and receiving of military hardware from the US under the Excess Defence Article (EDA) programme at the meet.

A coast guard cutter ship of US was handed over to Bangladesh last year and Dhaka is expected to seek more military assistance under the EDA.

About the dialogue, US Embassy Spokesperson Kelly McCarthy told The Daily Star that "the dialogue reflects our growing defence relationship with Bangladesh, and our shared commitment to peace and prosperity in the region." She said it will include discussions on

maritime security, counterterrorism, disaster risk management, peacekeeping, law enforcement, nonproliferation, joint military exercises and exchanges.

Officials said the two countries will exchange each other position and views on strategic relation in South Asian countries, including India, Myanmar, Afghanistan and China.

the Pakistani army in 1971, faces 16 charges including genocide and murder committed in Brahmanbaria and Habiganj during the Liberation War.

A BSMMU medical team checked the health of the 73year-old accused on April 10, said a defence lawyer. The report's content, however, could not be known.

Qaisar, also an alleged leader of Habiganj Peace Committee, an anti-liberation force, was arrested on May 21 last year but got conditional bail on August 5 of the same

year on health grounds. Meanwhile, the tribunal completed recording the crossexamination of Shah Hasan Ali, the seventh prosecution witness against Qaisar.

Hasan, son of martyred Shah Firoz Ali of Habiganj, on Sunday testified that Qaisar and his accomplices had handed his father over to the Pakistan army during war and that his father never returned.

But during cross-examination, defence lawyer SM Shahjahan said Qaisar never went to Habiganj town during war, and the witness gave "false" testimony being "tutored" by the prosecution and three other prosecution witnesses. The witness rejected the claim.

The court adjourned the case proceedings until today.


