Flood insurance gives hope to farmers

Pilot project introduced among 1,661 flood victims in Sirajganj

Rasheda Khatun, a woman of thirty and wife of Md. Nazrul Islam of Mollikpara village in Masra Union (West) in Sirajganj Sadar upazila could do nothing but watch flood come in last September and ruin her life. Under pressure, she was bound to sell one of her cows at low price due to food crisis of her family cattle. Six of Rasheda's goats died due to food crisis and water borne diseases carried by the flood. Those six goats had a market value of 18,000 takas, and losing them meant Rasheda had no livelihood left. She had no way of putting food on the table for her children. Then, for the first time, she heard about a concept called flood insurance. She realizes how flood insurance protects the vulnerable, because in order to recover from a disaster,

one needs cash support. Like her, flood victim farmers of Sirajganj district are now protected against the odds which come with the occupation of farming, since there is nothing to be done to prevent natural disasters. Flood insurance is a safety net program for the ultra-poor flood victims around the world. The project is a unique attempt where a meso-level flood index insurance has been designed to protect the low income, vulnerable 'Char Communities' by improving their ability to sustain and recover in a post-disaster condition.

Flood victims used to suffer continuous hardship after a flood - since after the flood water recedes, they cannot find a job immediately, and by then they've

crops. Borrowing loan on high interests is a temporary fix at best, since they are not able to turn that credit into productive earning since the market conditions aren't good after a flood. Whatever crops they can recover, they are forced to sell off at poor prices. Realizing the continuous odds for flood victims, Oxfam, a leading donor organization around the world initiated to install flood insurance for the ultra-poor flood victims, introduced a flood insurance scheme among 1,661 ultra-poor flood victim families of 10 villages in four unions of two upazilas in Sirajganj. The level of optimism in these farmers lives have skyrocketed since.

Vulnerable parts of Bangladesh are affected with flood commonly, often twice a year. Large floods occur in 3.3 years-cycle. There were 16 massive floods damaging Bangladesh from 1954 to 2007. At least 21 percent of the total cultivated land across the country is affected by floods every year, according to a survey. every year. The victims often take loans at exorbitant interest or sell crops in advance for poor amounts, and it prolongs their sufferings. And so, we have initiated the pilot project here, said Md Nurul Amin, Economic Empowerment Coordinator of Oxfam. Families of the coverage

areas belong to six villages of Sirajganj Sadar upazila and four villages of Chowhali upazila - these are the people who were identified as most vulnerable to floods, said Md Habibullah Bahar, director of Manab Mukti Sangstha, a Sirajganj-based development organisation that is implementing the pilot project. The beneficiaries said they are now happy to be included under the project as it will help them in the case a flood hits the area. Several others, however, said the condition of water level staying one centimeter above the danger level for 26 days to get the insurance benefit seems unreasonable. Only rarely does the water level remain at such a high level for so long time. When contacted, Md. Zahid Al Amin, Oxfam Consultant, said that the proposal for reconsidering the flood level criteria is under

consideration. Such a project has the potential to benefit thousands of other farmers, and should be expanded across the country as Bangladesh is a flood-prone country. "We have shown the way with the pilot project. In the interest of farmers across Bangladesh, the government should extend their hands to introduce such flood insurance programs in other districts as well," added Zahid Al Amin.

Barapukuria Coalmine

Agitators cut power, confine 50 officials to building

The miners and workers of Barapukuria Coal Mining Company Ltd (BCMCL) toughened their agitation yesterday, cutting power supply to the administrative building and confining around 50 officials to the building, as they continued movement for the third day yesterday, demanding cancellation of the amended manpower structure.

No official could go in or come out of the building as the agitators blocked two main gates of the building.

The miners and workers under BCMCL Miner and Workers Union started the agitation on Sunday, urging the authorities to cancel the newly

amended manpower structure. They also gave the authority a 48-

hour ultimatum, which ended yester-

day without any solution. Meantime, the authorities communicated with the workers' leaders who agreed to sit for a meeting scheduled to be held on Wednesday.

But the miners and workers vowed to continue their agitation until realisation of their demand.

The miners took position at two entrance gates of BCMCL administrative building yesterday morning and continued demonstration there. At least 50 officials remained confined inside.

The miners also cut the power supply to the building causing serious sufferings to the official as the building is centrally air conditioned. And a CCIV camera also damaged, said the

The area is a KPI [Key point installation] but the law enforcers remained amid the situation, said a few officials.

Wazed Ali, president of BCMCL Miners and Workers Union, at a rally yesterday alleged that if the fresh manpower structure that was amended early January this year comes effect at least 1900 workers and miners would loss their jobs.

Md Aminuzzaman, managing director of Barapukuria Coal Mining Company Ltd, said, "Those who are agitating are not employees of BCMCL. they belong to XMC-CMC, the contracted company for the mine's coal production, maintenance and management."

"Not a single person will lose jobs if the amended manpower structure comes into affect," he claimed.

Three held with arms, ammo in 2 dists

The law enforcers in separate drives arrested three people along with arms and bullets in Rajbari and Faridpur districts on Monday.

In Rajbari, Abul Bashar Mia, officer in-charge of Pangsha Police Station, said police arrested an alleged member of an outlawed party along with a shutter gun and three rounds of bullet from a Mahogany orchard in Panghsaupazila.

The arrestee is Tajul Islam, ringleader of 'Tajul Bahini' and son of Abdul Rafique of Kurapara village.

In Faridpur, members of Rapid Action Battalion (Rab) arrested two men along with arms and bullets from Boropaturia in Kalukhali upazila on Monday.

The arrestees are Alamgir Hossain Mondol, 48, and Arjoo Sheikh, 22, of Sripur in Magra district.

Acting on a tip-off, a team of RAB-8 team raided the area and arrested the duo along with a shutter gun and some bullets in the evening.

A case was filed in this connection under the Arms Act.

Missing man found dead

BAU students lock treasurer's office

Reiterate demand for punishment to Saad's killers

Students of Bangladesh Agricultural University (BAU) yesterday staged a sit-in in front of the university administration building and locked up the treasurer's office, demanding immediate arrest of the killers of Saad.

They also demanded capital punishment of the killers under Speedy Trial Tribunal Act from a procession brought out on the campus around 10:00am.

The agitating students later declared to boycott all classes and examinations until the demands were met.

Saad Ibney Momta, a final year student of the fisheries faculty at BAU, succumbed to his injuries at a private clinic on April 1, a day after Chhatra League men had beaten him up with hockey sticks, iron rods and cricket

stumps in room No 205 of a hall on the campus. On April 15, a five-

member probe body, headed by Prof Abu Taher Muhammad Zia Uddin, was formed to investigate the killing incident. The probe body has been asked to submit the report within the next 21 working days.

Earlier, on April 9, BAU authorities expelled three students and suspended three others for their alleged involvement in the murder, said Vice Chancellor Md

Rafiqul Hoque. Police arrested two BCL men-- Sujoy Kumar Kundua and Md Rukonuzzaman--in

connection with the killing. The students began the agitation on April 2, demanding arrest of the killers of Saad, also the former organising secretary of BCL Ashraful Haque Hall unit.

Two fake medicine factories shut OUR CORRESPONDENT,

Dinajpur A mobile court in separate drives here on Monday sealed off two unlicensed Ayurvedic medicine factories and seized a large number of different types of chemical, bottles and mixing machineries from there. The factories include NA

Pharma Laboratories in Sastthitola area of the town.

The court also sentenced Md Obaidullah, owner of the laboratories, to six months' imprisonment and fined him Tk 50,000 for not producing valid documents against his factory. Executive Magistrate Md Mobarak Hossain led the court, said police.
