Watermelon farming on the rise in Patuakhali

Bumper yield, good prices make growers happy

Farmers of the district, especially in sandy lands of coastal islands, are getting encouraged to cultivate watermelon on more areas of land as the popular summer fruit brings more profit than traditional crops including paddy.

This year 13,368 hectares of land in seven upazilas under the district has been brought under watermelon cultivation while it was 10,250 hectares last year, said sources of the Department of Agriculture Extension (DAE) in Patuakhali.

The district's total production may cross six lakh tonnes, the value being Tk 110 crore, they

Land of Rangabali, Galachipa and Kalapara upazilas see large areas of watermelon fields as those are very suitable for watermelon cultivation due to soil, weather condition, availability of irrigation water, said Md Ziaul Islam, crop specialist of DAE in Patuakhali.

Of them, Rangabali upazila sees the highest 4,510 hectares of land under watermelon cultivation this

Now retail market prices of large, medium and small sized watermelons are Tk 130-150, Tk 70-80 and Tk 40-50 at par respectively.

Sandy soil in the area is very much suitable for watermelon cultivation and a good number of rivers and canals there provide irrigation facility, said Lutfur Rahman, assistant plant preserver of DAE in Rangabali

The invigilators took the answer papers of the examinees at 8, 9, 10, 11, 12 and 13 number rooms just 10 minutes before the end of the examination time, said the students.

Protesting the incident, they burst into agitation and went on the rampage. Later, they confined Principal Md Zahurul Islam till 3:30pm.

On information, police rushed to the spot and brought the situation under control, said Arman Hossain, officer in-charge of Birganj Police Station.

Man hacked to death

A 52-year-old man was hacked to death allegedly by his son-in-law at Khudramatia village in Belkuchi upazila of Sirajganj district on Tuesday

Police and family sources said Ibrahim Hossain married Kohinur Khatun, daughter of Shah Alam of the village in 2010.

After the marriage, Ibrahim often tortured Kohinur over a family feud. Fed up with the incident, Kohinur filed a case with Sirajganj court recently, seeking divorce. The court

issued a notice to Ibrahim for appearing before the court.

Enraged by her act, Ibrahim along with his brothers attacked Shah Alam with sharp weapons, leaving him seriously injured while he was watching TV at a nearby tea stall in the village at 10:30pm.

Shah Alam was rushed to the upazila health complex where on duty doctors declared him dead, said officer in-charge of Belkuchi police station Md Abdul Hai

Ibrahim and his family members went into hiding after the incident, he said.
