Storm lashes four districts

14 killed; train derailed; crops damaged extensively

STAR REPORT

Nor'westers, short-lived storms locally known as *Kalbaishakhi*, left 14 people, including four of a family, dead and 85 others injured late Sunday night in four districts.

Homes, crops, shops and trees were destroyed and vast areas in several districts were left without power.

Wind gusts of one of the storms were reportedly so powerful that they derailed nine carriages of a train, snapping rail communication between Dhaka and western Bangladesh.

Eight deaths were reported in Netrakona alone, four in Sunamganj and one each in Sylhet and Rajbari, report our correspondents.

In Netrakona, Afroza Begum, 30, her three sons Parvez, 9, Rony, 4, and Rana, 2, were killed in Bishompur when the storm caused their house to collapse.

Mamun, 17, of Noynagar in Kalmakanda upazila, Habibur Rahman, 85, of Borni in Netrakona Sadar, Soma, 9, of Haripur in Mohonganj upazila and Emdad, 14, of Gadarkanda in Barhatta upazila were killed in separate nor'westers. They died when their homes collapsed on them.

Additional Deputy Commissioner Abdullah Al-Mamun of Netrakona said the nor'westers lasted up to 45 minutes from 10:45pm and damaged over 2,000 homes, 1,000 hectares of boro crops, uprooted hundreds of trees and electric poles, disrupting electricity supply to 10 upazilas until 5:00pm yesterday.

Abduction all around

2 kidnapped from Mymensingh, 2 freed in Gazipur; no trace of 7 picked up from N'ganj

Four people were abducted in Gazipur and Mymensingh early yesterday, within 14 hours of seven people being kidnapped in Narayanganj.

Of the four, two brothers were abducted in Gazipur's Kaliakoir around 3:00am and two cousins at Bhaluka in Mymensingh about an hour later.

Police, however, found the two

Gazipur victims around 9:00pm yesterday, after their captors freed them in Chandra area of the upazila. It is not clear who abduc-

ted them or why.

Incidents of abduction by criminals and also allegedly by members of law enforcement agencies have risen sharply in recent months, raising serious concern over safety of the citizens.

At least 45 people have been picked up allegedly by law enforcers so far this year, according to rights body Ain O Salish Kendra and reports published in this newspaper.

MANZUR MURDER-6

President Ziaur Rahman was assassinated in Chittagong on May 30, 1981. Two days later, General Manzur was murdered. Facts related to the planned killing of Manzur show how top military leaders at the time desperately tried to bury the truth behind the Zia killing and how it helped them seize power. Manzur was the unsuspecting victim of their duplicity, which has become evident from the depositions of witnesses and the accused and from some authoritative books on the killing.

All these years since June 1981, justice for Manzur and his family has remained elusive.

Trial targeted freedom fighter officers

As adjutant general of the Bangladesh Army, Major General Moinul Hossain Chowdhury was empowered to supervise overall the court martial against those accused in the Ziaur Rahman assassination and mutiny.

But he was neither informed nor involved in this process. This was a gross violation of the Army Act, which

had authorised him to look into matters relating to discipline, court of inquiry and court martial in the army.

General Moin had earlier refused to sign the office order for the formation of the army's court of inquiry into the assassination. He refused to do so as his proposal to unearth the reasons behind the mutiny by the officers was not included in the terms of reference of the court of inquiry.

Ershad, however, gave short shrift to

Moin's refusal and signed the order himself.

For this, Moin, a veteran freedom fighter, had to face unpleasant consequences. He was kept under intelligence surveillance round the clock. His phone was continuously tapped.

Annoyed by such surveillance, Moin informed army chief Ershad and DCGI chief Mohabbat Jan Chowdhury about it. But he got no remedy.

Duty cuts for RMG exports not in sight

US negotiator says it depends on WTO

The visiting US delegation yesterday declined the country's request for duty reduction on garment items in the inaugural Ticfa talks, saying the issue is in the hands of the World Trade Organisation.

Michael J Delaney, assistant US trade representative for South Asia, who is leading the five-member US delegation, said the matter of extending duty privileges to garment products from Bangladesh is part of the Doha Development Agenda of WTO.

But the Doha round of negotiations is yet to be completed, he said.

The US diplomat went on to insist that garment items from Bangladesh
