fill the initial storage. The river flow remains higher at that time and water in excess of use in the field spills over the dam. Later, the spill stops in February-March as water use increases.

The average dry season depth of the flow of the Halda river is only 300 mm. Had the two rubber dams not been built, this additional half-meter depth of water would meet the tidal cycles.

Also, if the volume of dry season water that would be available during a tide cycle from not building the two rubber dams is compared with the volume of tidal prism that enters from the Karnaphuli past Madunaghat, the former counts for only 0.14% of the latter -- a trifling fraction that is unable to cause any impact on salinity propagation process at Madunaghat.

Regarding the operational aspect of the Bhujpur dam, the LGED rejoinder signed by the additional chief engineer said as per the memo issued by the agriculture ministry, the Halda rubber dam was deflated on May 2, 2013, impacted the fish spawning which is unusual as the Boro rice is harvested by the end of March and the dams are deflated. If it is so then we have to look into the operational aspects of the dams and we are pretty sure that we should be able to come up with a solution, making the dams operationally friendly for both rice and fish.

The LGED did not conduct any

(EIA) before constructing the dams. So it is not clear how it came to know that the salinity at the mouth of the Karnaphuli, which increased after the construction of the dams, was not due to the impact of those dams.

The department conducted a feasibility study only after the Bhujpur dams came into operation.

Also, in the rejoinder the LGED itself admitted that the dry season flow of the river is very thin, less than half a meter in depth. But still those dams absolutely stopped the flow of the river, leaving around a five kilometre stretch of the Halda completely dry, which would destroy the ecology of the river.

The rejoinder also conceded that the dams are being operated in an unfriendly way for fish.

Bangladesh Environment Conservation Act, 1995 (2010 amendment), clearly mentions that the authorities concerned must conduct an EIA before taking up any development projects. The law also prohibits stopping, diverting or preventing the natural flow of a river.

In our report, it was clearly mentioned how the production of fish egg in the river dropped by 60 percent last year to 624 kg from 1,559 kg in 2012, within one year of the Bhujpur dams coming into operation. But the LGED in its rejoinder made no mention of the impact on the production of fish eggs.

Even the fisheries ministry in February formed a 12-member interministerial committee composed of government officials to make recommendations about the situation of

Other prominent leaders who are in the fray in the seventh phase are federal minister Farooq Abdullah from Srinagar, BJP veterans Murli Manohar Joshi in Kanpur and Janata Dal President Sharad Yadav from Madhepura in Bihar state.

Polling has already been held in 349 of the altogether 543 Lok Sabha constituencies since April 10 before two rounds of voting are held in the eighth and ninth and final lap on May 12, four days before the votes are counted.

Mocking Rahul Gandhi, Modi dubbed the Congress vice-president as a specimen for his "little knowledge" of Gujarat.

Addressing a rally in Kheralu in Gujarat, Modi said Gandhi's claim of vast job vacancies and lokayukta smacked of ignorance, and was short on facts. His speeches were good stress-

busters, he said. Rahul hit back with force, question-

ing Modi's ties with the leading industrial house Adani Group and alleging Modi government in Gujarat handed over land worth thousands of crores of rupees at throw-away prices to the industrial group.

While the BJP ridiculed Rahul's frequent visits to socially backward caste homes and having food there, the latter asked whether it was wrong to ask Dalits about their problems and wrong to meet or hug them.

A day after Farooq Abdullah said Kashmir would not be part of a "communal India" and those voting for Modi should drown in the sea. Modi hit back by alleging the biggest blow to secularism in India was delivered in Kashmir by the Abdullah family when Kashmiri Hindus were forced out of the state due to their religion.

Modi also charged Farooq's son and Jammu and Kashmir Chief Minister Omar Abdullah and the latter's grandfather Sheikh Abdullah of communalising Kashmir for politi-

Omar took on Modi by accusing him of twisting history and dared him to visit Kashmir and seek votes.

Unleashing a vicious attack on Modi, who questioned the "big money" fetched by her paintings, West Bengal Chief Minister Mamata Banerjee labelled the BJP's PM nominee a "devil and a bloodthirsty rioter" and "butcher" of Gujarat, referring to the riots that left more than 1,000 dead, mostly Muslims, in the western state 12 years ago.

The country would be "ruined" if Modi came to power in India and the "architect" of the Gujarat riots would drench Bengal in an "ocean of blood" after drenching Gujarat "in a river of blood", she alleged in Kolkata on Monday evening.

The Mamata-led Trinamool Congress party demanded a public apology from Modi for doubting the integrity of Banerjee.

On Modi's allegation she was indulging in vote-bank politics ignoring non-Bengalis and laying on the red carpet for Bangladeshis, Banerjee said he [Modi] did not know history.

"He is polarising Bengalis and non-Bengalis. After shedding blood in Gujarat, does he want to unleash bloodbath in Bengal...," Mamata asked.

As soon as they had reached in front of Ziaur Rahman Hall, 10-12 unidentified youths waylaid them, he told The Daily Star at the NICVD.

"As we tried to run away, they caught Masud first and then me. They started hacking us indiscriminately with machetes. One of them also shot three times at me but I luckily escaped," he

Saleh said he had never seen the attackers on the campus before. "Probably, they are Shibir cadres and came from elsewhere."

He added that he and Masud had beaten up Madar Bux Hall unit Shibir president Waliullah Mahmud on Sunday and handed him over to police.

"The Shibir president had threatened us with dire consequences," he said, adding that they were active against Shibir activities on the campus.

On hearing their screams, on-duty police at Ziaur Rahman Hall rescued the victims and rushed them to the RMCH.

The assailants completely severed Masud's right ankle and cut the tendons of his left leg. The attackers also cut tendons of both hands and legs of Saleh.

Both the BCL men were seen bandaged almost all over their bodies.

Nirmal Kanti Dey, resident surgeon of the NICVD, said, "The victims sustained hack injuries in different parts of their bodies."
