CLIMATE HAZARDS IN BANGLADESH Displacement of 16m by 2050

Suggest RMMRU findings on internal migration

STAFF CORRESPONDENT

At least 16 million people will be displaced from their ancestral homes internally in Bangladesh by 2050 due to climate change induced catastrophes like flood, storm surges, riverbank erosion, and sea level rise, according to a new research.

The findings came from an analysis of the data of the 2011 and 2001 population censuses.

Some two to five million will migrate due to riverbank erosion, three to six million for flooding, and five to seven million for coastal surges, said Prof Tasneem Siddiqui, founder chair, Refugee and Migratory Movements Research Unit (RMMRU) of Dhaka University.

Presenting the results at the DU senate building, she said climate change induced hazards would cause dislocation of around 16 to 26 million people.

RMMRU and the Sussex Centre for Migration Research of Sussex University jointly conducted the research between April 2012 and January this year.

During the period, they also surveyed 1,500 households of migrants and non-migrants of three districts--Chapainawabganj, Satkhira and Munshiganj--from where people migrated and of three other areas--the capital city Dhaka, Khulna, and Keraniganj-destinations of those migrants.

HC allows ads in English, Bangla

The High Court yesterday allowed the print and electronic media which use English for communication to publish advertisements both in English and Bangla language.

Earlier on February 17, the court directed the government to take necessary measures in a month to ensure the use of Bangla in all advertisements of the electronic and print media and also on the nameplates of vehicle registration, signboards and billboards across the country.

During hearing of a writ petition yesterday, the HC modified the order, while Deputy Attorney General Biswojit Roy brought the issue to its notice. The court also extended the time till May 15 for the government to submit a report in compliance with the February 17 order. The court will seek explanation from the secretaries concerned if the order is not implemented timely, DAG Biswojit told The Daily Star.

Supreme Court lawyer Eunus Ali Akond filed the petition as public interest litigation on February 16, seeking an order on the government to issue a circular asking the officials concerned to use Bangla as official language.

Money Laundering Case

HC seeks report on Mosharraf's health

The High Court yesterday sought for a medical report of detained BNP leader Khandaker Mosharraf Hossain to decide about granting bail in a money laundering case.

After hearing a bail petition filed by the accused on April 28 on heath ground, The HC bench of Justice Naima Haider and Justice Zafar Ahmed asked the Bangabandhu Sheikh Mujib Medical University authorities to submit a report by May 12.

On February 6, the Anti-Corruption Commission filed the case with Ramna Police Station on charge of siphoning off over Tk 9.53 crore to the United Kingdom.

Recently, two HC benches denied bail to the BNP leader in the same case, ACC lawyer Khurshid Alam Khan told The Daily Star.

Bangladeshis suffer heart attacks sooner

Says Cambridge study

Bangladeshis are suffering from heart attacks 10 years earlier than typical sufferers in the west, says the preliminary findings of a Cambridge study.

"The average age of Bangladeshis who suffer heart attacks is 52, with approximately forty percent of the cases involving people below the age of 50," said Rajiv Chowdhury, principal investigator of the study. Toxic heavy metals such as arsenic, copper and

lead in fish and rice may be increasing the risk of

heart attacks, the study suggests. Along with the English university, Dhaka-based health research institution ICDDR,B and the Bangladesh National Institute of Cardiovascular

Diseases are conducting the ongoing study. Rajiv Chowdhury, senior scientist at Cambridge University, presented the findings at a seminar titled "Bangladesh at Risk of Acute Vascular Events" in

ICDDR,B auditorium in the capital yesterday. The study, which began in 2011, will continue for

another couple of years. So far 4,000 cases of heart attacks have been analysed under the study. In addition to the toxins, the generally popular

cooking pattern of frying fish, use of excess oil and prolonged cooking may neutralise the protective properties of fish, he added. Rajiv said 80 percent of the heart attack cases recorded were tobacco users. In addition to tradi-

tional causes of heart attacks, the survey has iden-

tified risk factors that are unique to the country. For example, only four percent of the patients were obese while the rest were lean.

Eminent cardiologist National Prof Brig (retd) Abdul Malik; Prof Abdulla Al Shafi Majumder, director of NICVD, and Dr Emanuele Di Angelantonio, senior scientist at the University of Cambridge, also spoke at the event.

Road accidents kill 8

Eight people were killed and 27 others injured in road accidents in Dhaka, Gazipur, Chittagong, Brahmanbaria, Bogra and Jhalakathi on Monday and yesterday.

Our staff correspondent reports, two daylabourers were killed as an electric poles-laden truck carrying them flipped on its side after its driver had lost control over the steering at Badda in the capital early yesterday, said police.

The deceased were Noor Alam, 35, and Abdul Motaleb, 55.

Our Gazipur correspondent reports, two people were killed and 12 others injured in a head-on collision between a covered van and a human hauler on Dhaka-Mymensingh highway in the city yesterday morning, said police.

The deceased were identified as Gita Rani and five-month-old girl Jyoti.

Of the injured, three were taken to Dhaka Medical College Hospital while the other

nine to Gazipur Sadar Hospital. Our staff correspondent from Chittagong reports, an elderly man died as an unknown vehicle hit him on Dhaka-Chittagong high-

way in Sitakunda upazila early yesterday. The man, aged around 60, could not be identified.

Our Brahmanbaria correspondent adds, a boy was killed as a bus hit him while he was crossing Dhaka-Sylhet highway at Rajabariakandi village in Sarail upazila in yesterday morning.

The deceased was Atik, 7, of the village.

Our Bogra correspondent adds, a man died and at least 15 others were injured as a bus fell into a roadside ditch after one of its tyres had punctured on Dhaka-Bogra highway at Bottola in Sherpur upazila Monday night.

The deceased was Golap Hossain, 48, son of late Afzal Hossain of Kalaihata village in Gabtoli upazila.

The injured were taken to local health complex and Bogra Shaheed Ziaur Rahman Medical College and Hospital.


