# RAILWAY SCAM Suspended officer Kibria lands in jail

A Chittagong court yesterday sent suspended Bangladesh Railway (east zone) senior welfare officer Golam Kibria to jail in a case filed over irregularities in the recruitment of assistant chemists at the railway.

Chittagong Divisional Sessions Judge Ataur Rahman passed the order after hearing on a bail petition filed by Kibria after he surrendered before it on the day, said Mejbah Uddin Chowdhury, public prosecutor (PP) of ACC.

On September 13, 2012, Anti-Corruption Commission (ACC) Assistant Director Rashedur Reza filed the case with Kotwali Police Station accusing three BR high-ups, including Kibria

Kibria went absconding since filing of the case, said the PP. Earlier, the court sent two other prime accused in the case suspended BR (east zone) general manager Yusuf Ali Mridha and chief mechanical engineer Hafizur Rahman Chowdhury -- to jail on March 3 and April 7.

A total of 13 cases were filed against the three over corruption in recruiting staff in different posts of the railway, said Mahmudul Haque Mahmud, another PP of ACC.

ACC submitted five charge sheets accusing them, he added. By creating fake documents, the accused recruited staff in the railway in exchange for bribes, according to the case state-

NOT COMPLYING WITH HC ORDER

# B'baria DC to face court on May 21

The High Court yesterday summoned Deputy Commissioner of Brahmanbaria Mosharraf Hossain to appear before it on May 21 for not complying with its order over producing a document. In response to a contempt petition, the court also issued a rule upon Mosharraf to explain in three weeks why contempt of court proceeding should not be brought against him.

On January 30, the HC directed Mosharraf, returning officer (RO) of Brahmanbaria, to immediately produce before it the application submitted by Ziaul Haque Mridha, Jatiay Party candidate in January 5 parliamentary polls, for withdrawal of candidature.

Ziaul, candidate in Sorail-Ashuganj constituency, sub-mitted the application to the office of RO on December 13 last year, Petitioner's lawyer Mohammad Bakiruddin Bhuiyan told The Daily Star.

Despite the application, the RO allegedly upheld Ziaul's nomination and allowed him to contest the elections where he won, he said.

Independent candidate Naiyer Kabir, who got second highest vote in the election, filed a petition with the HC on January 13 seeking cancellation of Ziaul's candidature and to direct the RO to declare him elected.

On April 29, Naiyer filed a contempt of court petition to the court against Mosharraf since he did not comply with the HC order over producing the application within January 30.

On hearing the petition, the HC bench of Justice Soumendra Sarker yesterday summoned Mosharraf and issued the contempt rule.

## Decision on contempt

Salahuddin Quader Chowdhury was violated as the tribunal did not allow him to produce his witnesses.

Salauddin was sentenced to death by the three-member tribunal on October 1 for crimes against humanity during the Liberation War in 1971.

The seven persons facing contempt charges include the two guests and the episode host Mahmudur Rahman Manna, convener of Nagorik Okiya. Giving a reply yesterday, advocate

Asaduzzaman, representative of Channel 24 and Mahmudur Rahman, said it was a live programme, and there was no way for the television authorities to stop or edit the episode. He claimed that Channel 24 discontinued

the programme soon after the comments. He also said, "It was personal opinion of the participants, and it has no connection with Channel 24's editorial policy...Still if the tribunal is scandalised, we apologise."

Prosecutor Tureen Afroz refuted the claim, saying a programme was planned before airing. "Who will be invited and what will be discussed is planned in advance, so Channel 24 can't avoid its culpability."

Defending himself, Zafrullah said he did not undermine the court. When a tribunal justice asked him if he knew four defence witnesses testified for Salauddin, Zafrullah replied in the negative.

Justice Jahangir Hossain Selim, a member of the tribunal, told him, "From your opinion [in the show], people may think that the court didn't allow Salauddin any defence witness, which is not true." The court is not responsible if a party fails to produce witnesses, he added.

Tajul Islam, a lawyer defending Mahfuz, said that in the chat show, his client only backed Zafrullah's comments. He, however, said he apologised if the tribunal was scandalised.

#### Road crashes kill 3 CITY DESK

Two persons died on the spot and another was injured when a Chittagong-bound pickup rammed a covered van from behind at Sitakunda Bypass on Dhaka-Chittagong highway early yesterday, reports our Chittagong correspondent.

The dead are Anwar Hossain, 25, of Noakhali and Md Tarek, 18, of Feni while the injured is Md Forkan, 25, of Feni.

The driver of the pickup managed to flee, said police. Our Natore correspondent reports, a motorcyclist died in a head-on collision between a truck and a motorcycle in

Basudebpur area in Naldanga upazila of Natore yesterday noon. Apel Talukder, son of Salam Talukder of Biprabelghoria village of the upazila, died on the spot.

Police seized the truck but the driver and helper escaped.


