

dragged his father and the six others out of the food storage and threatened them and asked them not to leave the place. A few days later, Nawshad said, he and his brother saw his

father and six others were being taken to a nearby building, and later he learnt that the building was a rest house. "After Zohr prayers, we saw my father and the six men were being taken to the Khoai river bank. Then my brother

and I followed them, and from a sugarcane field, we witnessed the incident." "From there, I saw my father and the six were lined up on the Khoai bank and Punjabi men [Pakistani army] shot

dead my father and the six following a signal of Qaisar, and threw their bodies into the river. We are yet to get our father's body," said an emotion-choked Nawshad. Nawshad learnt from his mother that his father and the six
