CORRUPTION CHARGES SC upholds Faisal Morshed Khan's acquittal

The Supreme Court yesterday upheld a High Court verdict that acquitted Faisal Morshed Khan, son of foreign minister during BNPled government M Morshed Khan, in a corruption case in which he had been convicted and sentenced to 10 years' imprisonment.

The SC dismissed two separate appeals filed by the government and the Anti-Corruption Commission (ACC) against

the HC verdict. A special judge's court on August 20, 2008 convicted Faisal and sentenced

Bangladesh Chhatra League activists beat up three students, one of them severely, at Dhaka University yesterday allegedly for personal grudges.

Of the injured, Rasel Ahmed, a fourth year student of peace and conflict studies and activist of BNP-backed Jatiyatabadi Chhatra Dal, needed five stitches on the head.

The two others--Masum Billah and Ahmad Ullah Siddique--both master's students of Islamic studies, were beaten because, according to a BCL leader's claim, they are Islami Chhatra Shibir activists. Some 12 activists loyal to Zahurul Haque Hall unit BCL

president Rifat Zaman attacked them while the two were chatting with friends in front of the Arts Building. They kept punching, slapping and kicking them until Acting

Proctor Amzad Ali and three teachers came to their rescue. The BCL activists misbehaved with the teachers, said witnesses. The proctor said, "There might be personal conflict

between the duo and the attackers over publication of a souvenir of the [Islamic studies] department." All the three took treatment at the university medical centre. Rasel was attacked in front of the Central Library by

BCL beats up three I saw him order father's killing

Martyr Majat Ali's younger son echoes elder brother's testimony at war crimes trial of Qaisar

In 1971 when Nawshad Ali was 11 years old, a man ordered the killing of his father and six of his father's colleagues. The memories of how the seven men were shot dead left a lasting impression on his mind but back then he was too young to identify the man.

It was not until his elder brother told him the name--Syed Mohammad Qaisar, a man facing 16 charges, including genocide and murders, in

Brahmanbaria and Habiganj in 1971. Though he could not recall the date of the fateful event, the memories are still fresh to Nawshad, now 54, who witnessed the killings. As the 11th prosecution witness in

Qaisar's case, he gave a vivid description of the killings before International Crimes Tribunal-2 yesterday.

Nawshad said the deceased men were thrown into the Khoai river, and they never found them.

His testimony was almost identical with that of his elder brother Mostafa Ali, who gave deposition as the ninth prosecution witness on April 28, saying Qaisar had directed the Pakistani army to shoot his father and the six others to death on May 29, 1971.

Qaisar, a state minister of HM Ershad's regime, was the alleged founder of Qaisar Bahini but the 73-year-old pleaded not guilty.

Nur Hossain loses gun licences

The district administration has cancelled the licences of 11 firearms of fugitive Narayanganj City Corporation Councillor Nur Hossain, the prime accused in the abduction and murder of seven people including his alleged rival Nazrul Islam, a panel mayor of the NCC.

Deputy Commissioner Anisur Rahman Miah cancelled the licences on Monday, asking police to immediately seize the firearms.

The firearms are being used by Nur's associates, said sources.

8kg of smuggled gold seized at Dhaka airport

The customs intelligence seized eight kilograms of smuggled gold from a passenger, who emptied a total of 72 bars into a bathroom seeing security men around at Hazrat Shahjalal International Airport in the capital last evening.

The detained man, Mozahar Uddin, 36, was coming back from Dubai by Emirates Airlines, and officials had information about the smuggling, said Mustafizur Rahman, deputy director of the customs intelligence. The value of the gold was estimated at Tk 3.7 crore.

Husband kills wife in capital

US state dept official due today

28 activists of BNP, affiliated organisations sent to jail

Road crashes kill eight

Eight persons were killed and eight others were injured in road crashes in the country yesterday.

Our Chittagong correspondent reports, two persons were killed and two others injured as a speeding bus hit a rickshaw carrying them

at Chandgaon in the port city yesterday. The dead were Md Awyal, 7, and the rickshaw driver, whose identity could not be known immediately. The injured were admitted to Chittagong Medical College Hospital.

Agitated locals set the bus ablaze. Later, fire fighters doused the blaze. Our Sylhet correspondent reports, three

persons were killed and five were injured in a head-on collision between a Dhaka-bound microbus and a pickup van on Dhaka-Sylhet highway at Andiura under

Madhabpur upazila of Habiganj. The dead are microbus passengers, Rubel Ahmed, 22, Ruhul Amin, 14, and Emran Hossain Rahel, 24. Five injured were rushed to the Madhabpur Upazila Health Complex

In Chuadanga, a housewife was killed after being injured when she fell down from a human-hauler as her saree entwined with its wheels on Hejalgari-Nehalpur road of Chuadanga Sadar upazila.

Beauty Begum, 41, wife of Shajahan Molla of Dasto village of the upazila, died at Chuadanga Sadar Hospital.

Our Chapainawabganj correspondent reports, a bicyclist died after being injured when a Nachole-bound truck hit his bicycle while he was crossing the road at Nachole bus stand area. Nasiruddin, 14, son of Habibur Rahman of Hakroil village in the district's Nachole upazila, died at the upazila health complex. Our Naraynganj correspondent adds a local

leader of Jatiyatabadi Chhatra Dal died on the spot as a truck rammed into his motorbike in Rupganj upazila of the distinct yesterday afternoon. Following the death of the leader Habibur Rahman Rubel, 28, son of Abdul Aziz of Charpara area, agitated locals blocked Kanchan-Rupsha road for half an hour.

Azadur Rahman, the back seat rider, was injured in the mishap.

Buet students demand exam postponement

Students of Bangladesh University of Engineering and Technology (Buet) yesterday boycotted their scheduled examinations and staged demonstrations, demanding postponement of the exams for two weeks.

Around 200 students of eleventh and ninth batches also locked the main entrance of the university from 6:00am to 7:00pm.

They said they did not get enough time to prepare themselves for the term final exams. Students of the eighth batch blocked Palashi intersec-

tion, disrupting traffic movement on the road for five hours from 6:00am to boycott the examinations scheduled to start at 9:00am. On the other hand, the 11th batch students staged a sit-in

at Central Shaheed Minar from 2:00pm. Additional police were deployed on the campus.

Earlier, on Saturday, students of eighth and 10th batches

also boycotted their term final examinations making similar demands.
