- Qualification & Experience:
a. Applicants must be a Bangladeshi Citizen.
b. Applicants must have LLB (Hons) LLM or Masters in any discipline with LLB Degree and practicing experience including Bangladesh Supreme Court not less than 15 (fifteen) years for Legal Adviser and 10 (ten) years for penal Lawyers Retired District and Session Judge may also apply.
c. Legal Adviser/Panel Lawyers must possess sound physical fitness.
d. Those who were associated with BIWTC earlier as legal Advisor/Panel Lawyers may also apply.
e. Applicants must be within 65 (sixty-five) years of age.
f. Those who have already applied for Legal Adviser/Panel Lawyers will have to apply afresh.

- Other Terms and Conditions:
a. Appointed Legal Adviser/Panel Lawyers shall be paid professional charges/schedule of fees as fixed by BIWTC for conducting cases in different Courts of Law on case to case basis. Only Legal Adviser shall paid monthly fixed retainer fees.
b. Legal Adviser/Panel Lawyers are to be appointed for 2 (two) years. The appointment will however be subject to the guidelines of the Ministry of Law, Justice and Parliamentary Affairs and Rules and Regulations of the Corporation.
