## Body recovered

Police recovered the body of a man from Mohadipur in Palashbari upazila on Thutiyapukur-Parbatipur road yesterday. The deceased is Rustom Ali, 35, son of late Moinul Huq Minshi of the village. Locals found his body in the area and informed the police. The body was sent to Gaibandha Sadar Hospital morgue for autopsy. Criminals might have killed Rustom and dumped the body in the area, said Gopal Chandra Chakkravarti, officer in-charge of Palashbari police station.

## Jamaat activist stabbed to death

An activist of Bangladesh Jamaat-e-Islami was stabbed to death by criminals at Thutiapukur in Palashbari upazila early yesterday. The deceased was identified as Rustom Ali, a resident of the village. Gopal Chandra, officer-in-charge of Palashbari Police Station, said Rustom was wanted in several cases filed with the police station. He had been absconding since long. Abu Taleb, vice-president of Palashbari upazila unit Jamaat, said a gang attacked Rustom and stabbed him indiscriminately in the dead of night while he was returning home from the hideout after a long time, leaving him dead on the spot. Informed, police recovered the body and sent it to hospital morgue for autopsy.

# Abducted SSC examinee rescued

Police rescued a SSC candidate of the district from Balurghat area in Sadar upazila of Narayanganj yesterday, two days after his abduction.

Police and family sources said Sharif went out of house around 9:00pm on Tuesday after receiving a phone call and did not return since.

The abductors later demanded Tk 1.20 lakh ransom from his family over mobile phone. After tracking the loca-

tion of the call, police raided a house in the area yesterday morning and rescued Sharif.

They later arrested Shafique, neighbour of the victim, from the spot, said Billal Uddin, officer-in-charge of Sarishabari Police Station.

They alleged that Md Azmal Hossain, assistant upazila education officer in Khansama upazila, is harassing them in absence of his boss.

# Four AL men sued for killing BNP leader Ismail

Four Awami league (AL) activists have been sued on charge of killing Kaliganj upazila BNP leader Ismail Hossain.

The accused are Shahjaham Ali, his brother Azizar Rahman, Atiar Rahman, son of Lutfor Rahman and Abbas Ali, son of Abu Taleb of Chapali village in the upazila.

Jahanara Begum, wife of the slain BNP leader, filed the case with Kaliganj Police Station on Wednesday night, accusing the four identified and five unnamed people.

None of the accused was arrested as of 5:00pm yesterday. Contacted, Officer-in-Charge Anwar Hossain said they have launched a drive to arrest the accused.

Ismail Hossain, 59, president of ward number one unit of BNP under Kaliganj municipality, was killed allegedly by Awami League activist Shahjahan Ali on Tuesday moning.
