

River up for grabbing?

UNO claims 3 acres of 'land' in Sandhya river; local AL lawmaker gives consent

The upazila nirbahi officer of Banaripara in Barisal has planted a signboard in the middle of the Sandhya river, marking out three acres of land for a "project".

The UNO, Syeed AZ Morshed Ali, did not try to hide what he was doing. "I have erected an enclosure in the river of my own accord as a char is emerging there and land grabbers might take it," he told The Daily Star.

However, no char (shoal) is seen there. The UNO, who is responsible for protecting the rivers from being

encroached upon, said he has not allocated "the land" to people as, he thinks, they would not be able to use it properly. The signboard reads: "Senior citizens' park, rest house, recreation centre,

food court, and a mosque and a temple". The river seems to have been encroached upon with at least the consent of

the local Awami League lawmaker. "I have informed the DC [deputy commissioner] about the enclosure and

also talked to the local MP about taking up a project and having it okayed by the government. The MP has agreed to it," UNO Syeed said, adding that the municipality would be able to do the job quickly.

The MP, Talukder Md Yunus of Barisal-2, told The Daily Star over the phone that the UNO had showed him the river stretch while they were crossing the SEE PAGE 2 COL 2

Ex-CEC Huda summoned

The High Court yesterday asked former chief election commissioner ATM Shamsul Huda to appear before it on June 3 to explain his "derogatory" comments about the judiciary.

"All constitutional bodies, including the Election Commission and Public Service Commission, as well as the judiciary have been politicised, and incompetent people are getting important posts there," Huda said at a seminar on political parties and democracy in Bangladesh organised by the Centre for Policy Dialogue in the

capital. The HC bench of Justice Quazi Reza-Ul Hoque and Justice ABM Altaf Hossain also issued a contempt of court rule on him.

In the suo moto rule, it asked Huda, who had led the EC in holding a widely acceptable national

'ABDUCTION' OF 2 BNP LEADERS

Tareque Sayeed faces case in Comilla

Court asks why 2 ex-Rab men won't be charged with N'ganj murders; Rana remanded

Lt Col Tareque Sayeed Mohammad, one of the three ex-Rab officials arrested for their alleged involvement in the seven murders in Narayanganj, was sued yesterday for abducting two BNP leaders in Comilla.

Saiful Islam alias Hiru, former lawmaker and president of Laksham upazila BNP, and Humayun Kabir Parvez, president of Laksham municipal BNP, went missing on November 27 last year.

Four other Rab men were also accused in the case filed by Humayun's father Rangu Mia with the Senior Judicial Magistrate's Court in Comilla.

They are Rab-11 Comilla Company Commander Maj Shahed Hasan · Raji, Rab Deputy Assistant Director Shahjahan Ali, and sub-inspectors Kazi Sultan Ahmed and Ashit Kumar Roy.

Family members of the missing BNP leaders claimed that the Rab personnel led by Tareque had abducted the two for "money".

At the court premises yesterday, Saiful's wife Farida Islam said she along · killed Azizul, 35, on suspicion that he had with her daughter Mashrufa Islam and other family members met Tareque · been working as a source of the law enforcein Narayanganj a day after her husband went missing.


