#### 2 cousins drown in Bogra river

3 more are in hospitals

A dip in the Bangalee river at Velabari of Shariakandi in Bogra turned into a nightmare for five cousins and siblings yesterday afternoon. Two of them died and the rest are in hospitals.

Mostakim Taj, 20, first year student of Bangladesh University of Engineering and Technology (Buet) and Rifat Ahmed, 21, a second year student of Green University College of Dhaka, died when they went to the river to

They fell into an underwater trench dredged by sand lifters.

Rifat's sister Nadira Binte Rija, 18, student of Eden University College, Dhaka, Shama Akhtar, 18, a medical representative, and Babu, 24, a student of Government Azizul Haque College of Bogra, got injured when they tried to save the two from drowning.


Family sources said the five had gone to bathe in the river during their visit to their village home to see their grandmother.

They said Taj and Rifat fell into the underwater trench and started to drown and the others went in to rescue them but began to drown themselves. Locals later pulled them all out but Taj and Rifat died on their way to a clinic in Bogra.

Rija and Babu were moved to Dhaka in the evening from a private clinic in Bogra town, family sources said.

Officer-in-Charge Fayjul Islam of Shariakandi Police Station said the bodies were handed over to the guard-

> However, UNO Syeed is not the first one to grab a portion of the river. Last year, local AL leaders and other influential people filled up portions of the river in two places near Banaripara Bazar to build a market and the local office of the ruling party.

On August 3, then local lawmaker Manirul Islam Mani laid the founda-

tion stone for the upazila Awami League office.

The mayor of Banaripara had welcomed the lawmaker amid festivity and was present on the occasion, locals said.

Locals said before filling up the river for the office, some local political leaders fenced off around 5,000 square feet more of the river. Later, they filled up the land and sold it to local traders at the rate of Tk 50,000 a decimal, traders said requesting ano-

That filled up land has now turned into a buzzing market.

The UNO did not take any action even after being told what was going

on. His office is just 500 metres from the spot.

The Sandhya connects the Kacha river in Kaokhali to the Kirtankhola in Barisal. It is important to the lives and livelihoods of the locals and filling it up at Banaripara is causing erosion in the villages on the other

## Witness testifies against Azhar

They had heavily knocked on the door and ordered the family to open it, the witness said, adding, his father opened the door in good faith.

"Colonel Sab salam diya hai [Mr colonel has summoned you]. Come with us now," said the witness, quoting the Pakistani army. The army forced his father and

maternal uncle into a jeep and confined them in a cell at Rangpur Cantonment.

There were nine other detainees in that cell, including eminent persons of Rangpur like Durgadas Adhikary, his son Uttam Adhikary and income tax lawyer ABY Mahfuz Ali.

"The detainees were tortured every night until April 13, 1971," he said.

Rathish added the Pakistani army and their local collaborators, including Azharul, had taken all the detainees with their hands and legs tied to Dakhinganj Cemetery around 2:30am on April 14.

"They opened fire on them. As my father was beside a pillar and fell on the ground as soon as the shooting began, no bullet hit him," the witness

But the occupation force was not satisfied and opened fire again to ensure the detainees' death. This time eight bullets pierced through Mahfuz

right thumb.

"Everyone thought my father had been killed," he said, adding, the Pakistan army left the spot assuming everybody dead.

Dinesh managed to crawl to a neighbour's house and with their help crossed the border to India after receiving primary treatment.

Rathish and his other family members had also left to India, met their father, and heard about the incident.

Following the deposition, the defence began cross-examining the witness until the three-member tribunal adjourned the proceeding until today.

The International Crimes Tribunal-2 yesterday completed recording the cross-examination of Golam Noor, 13th prosecution witness in the case against Syed Mohammad Qaisar.

Noor on Thursday testified that Qaisar along with his cohorts and the Pakistani army had launched a synchronised attack on 22 villages in Brahmanbaria that left 108 people, mostly Hindus, dead on November 15, 1971.

Qaisar's counsel SM Shahjahan yesterday completed his crossexamination saying his client was not involved in any such incidents and the witness had given "false testimony". The witness, however denied the defence's suggestion.

The three-member tribunal led by Justice Obaidul Hassan with members Justice Md Mozibur Rahman Miah and Justice Md Shahinur Islam adjourned the proceeding until today.

Qaisar, a state minister of the Ershad regime, faces 16 charges, including genocide committed in Brahmanbaria and Habiganj during the war. The 73-year-old accused, however, pleaded not guilty before the

"But he [Tareque] misbehaved with us and drove us away. He told us to meet him again and bring Comilla-9 lawmaker Tajul Islam along, " she said.

Rab official Shahed could not be reached over the phone despite several attempts.

The court ordered the officer-incharge of Laksham Police Station to submit a probe report to it, adds a correspondent from Comilla.

Meanwhile, a Narayanganj court placed ex-Rab officer Lt Commander SM Masud Rana on a seven-day remand yesterday, a day after two other former Rab officers Tareque and Maj Arif Hossain were taken on a five-day

remand. Rana was brought to the court in handcuffs around 4:45pm, hours after his arrest from the capital's cantonment area early yesterday for his alleged involvement in the seven murders.

Police sought his 10-day remand but

Senior Judicial Magistrate KM Mahiuddin granted seven days.

At the hearing, Rana claimed himself innocent, and said the place where the seven bodies were recovered was out of his duty area.

Police picked up Rana in the capital's cantonment area a day after the arrests of

Tareque and Arif from the same area. Their arrests came after the High Court on May 11 ordered law enforcers to arrest the three ex-Rab officials as suspects in

the seven-murder case. On May 6, the three officials were forced into retirement over the allegation of involvement in the killings of seven people, including Narayanganj panel mayor Nazrul Islam and lawyer

Chandan Sarker. Their names came up when Nazrul's father-in-law Shahidul Islam alleged that some officials of Rab-11 had killed Nazrul and others in exchange for Tk 6 crore from ward councillor Nur Hossain and his accomplices.

asked law enforcers to explain why Tareque and Arif were not shown arrested on the charge of killing the seven persons.

Mamunur Rashid Mondal, investigation officer of the case, will have to reply in four days.

The court order came after colleagues of slain lawyer Chandan moved a petition on the matter.

In the meantime, the government committee probing the gruesome murders talked to civil society members and took deposition of 17 people in the

fourth round of public hearing. On April 27, Nazrul, his four aides, and lawyer Chandan and his driver were abducted near Khan Shaheb Osman Ali Stadium in Fatullah of Narayanganj.

Six bodies, including those of Nazrul and Chandan, were found floating in the Shitalakkhya river on April 30, and another was found the

**CASE AGAINST TAREQUE** 

In the first information report, the complainant said Rab held Saiful and Humayun along with 10 others from Harishchar area in Comilla Sadar between 9:00pm and 11:00pm on November 27.

Shahjahan Ali and the two other accused Rab men took away Tk 14 lakh from Saiful's factory, Bangladesh Flour Mill, at Daulatganj market in Laksham on that night.

Saiful, who was in his factory at the time, along with Jasimuddin, former assistant organising secretary of Laksham municipal BNP, fled the factory.

They then contacted Humayun, and along with him were going to Comilla by an ambulance. The Rab men intercepted the ambulance at Harishchar, and forced them into a pickup.

The elite force members handed

Jasimuddin over to cops at Laksham Police Station on the same night, but there has been no news of Saiful and Humayun since, according to the FIR.

Humayun's family members said they went to file a case with the Laksham police, but the then officer-in-charge refused to take the case. Later, they filed a general diary on December 1. **PUBLIC HEARING**

FROM PAGE 16 The technique would use a robotic probe to fly alongside a space rock for months or years, gradually nudging it off course with slight gravitational changes caused by taking boulders from the

"We'd go into this enhanced gravity tractor position after we retrieve the boulder and demonstrate that we have even more gravity attraction capability by doing that," Lindley Johnson, program executive for Nasa's Near-Earth Object observations programme, told reporters in March.

The mission is being touted as a major step on the way to Mars. Nasa hopes to find an asteroid which is between seven and 10m wide for its They would then tow or push it

towards Earth so that it ends up in a stable orbit near the moon. In 2021 astronauts would then

use an Orion capsule - a manned spacecraft - to land on the asteroid Mars. and bring back soil and rock samples for analysis.

This asteroid would also, probably in the 2030s, be used as a stop-

off point for astronauts on their way

to Mars.

Exact details on how Nasa plans to pluck an asteroid out of its trajectory are not yet known, but the most recent rendering shows it is captured and held inside what looks like a giant plastic bag. Nasa has revealed two of its astro-

naut's have started training for an ambitious real life mission to land on an asteroid as a stepping stone to On Friday, it revealed prepara-

tions for the mission were underwater in a giant water tank used to simulate weightlessness. The space agency plans to land astronauts on an asteroid in the 2030s.
