confirmed that he is just a doctor, no surgeon," he told The Daily Star.

UHFPO's Dr Mosharraf Hossain, a government official, said there were some troubles "that's why we formed a probe committee. Before the report comes, I would like to say nothing." He also said, "If the doctors are found guilty, they will be punished."

The victim's son Ashraf said, "One of my relatives, who is a doctor, told me that though it's a major operation, the operation is not risky." Quoting the relative, he said, "His mother was not fit for operation because she was having diabetes. It was the main reason for her death."

Mostafa Kamal, officer-in-charge of Savar Police Station, said the relative of the victim went to the police station but did not file any case following a "settlement" with the hospital authorities.

Wishing anonymity, a relative of the woman said they had gone to the police station to sue the hospital authorities but Savar Jubo League activist Sohel forced them into the settlement.

The hospital officials refused to say anything about the incident.

both claiming that they saw Mobarak and one Jamshed pick up Abdul Khaleque of Sathian village of Brahmanbaria before killing him in 1971.

Quoting from the investigation officer's testimony, the defence counsel said Jamshed was born in 1972. "How could a person who was not born pick up a person," he said.

The defence counsel said according to documents, the Razakar, an auxiliary force to the Pakistani army, was formed in May 1971 and as per the prosecution documents, Mobarak became Razakar commander of Akhaura Thana.

"Weren't there enough capable men in Brahmanbaria until August 1971 to take control of the Razakar?" asked Mizanul.

Defence counsel Tajul Islam is supposed to argue on the legal points today.

After the defence arguments, the prosecution may give rebuttal to the defence's claims.

attacks on Hindus in Homna in April.

BCHRD, in its petition, stated that thousands of perpetrators have attacked 35 Hindu families at Baksitarampur in Homna and vandalised and looted their houses and temples on April 27, creating a rumor that two Hindu boys uploaded defamatory posts in their Facebook pages against Islam the previous day.

The local administration has not taken any effective action against the perpetrators, the petition said.
