However, the war spanning the period between March 26, 1971, and December 16, 1971, is internationally recognised as Bangladesh's War of Liberation.

government selected the company for delivery of passports to the expatriates in the UAE despite its noncooperation.

The editorial expressed surprise at the authorities' persistence on working with the Malaysian firm that breached the contract and failed to supply machine readable passport (MRP) booklets.

The IRIS rejoinder said the reports and editorial included some incorrect allegation and misleading information, which severely damaged the company's image and goodwill.

"We extended all support from our end, responded to all technical queries and provided all information/data as per the requirement of Dataedge," read the rejoinder.

The Dataedge, it added, failed to integrate their enrolment system with the central MRP system of the Department of Immigration and Passports (DIP) which the IRIS believes either the software of the Dataedge is faulty or the firm lacks competency in software integration.

About its non-cooperation with the passport authorities and delaying the integration of 33 offices, the IRIS said it submitted technical documents, deployed overseas engineers, held technical discussions and fulfilled all the requirement of the new contractor Dataedge for the integration of the offices as per contractual obligations.

Regarding the delay in the MRP project implementation in Malaysia, the IRIS said the Dataedge delayed in requesting the integration and implementation of a pilot application receiving centre beyond 30 days of signing the deal.

The IRIS claimed that it is not contractually obliged to technically support future extensions of MRP issuance centres at home and abroad. "All contracts are time bound, so is our contract with the DIP. We are not obligated to provide any support beyond the contract period," mentioned the rejoinder. It offered the DIP to use its software free of cost for integration with the central system.

The company also termed incorrect a part of the editorial, which said, "It may come as a surprise why the authorities persist in working with a foreign company that has failed to supply booklets for machine readable passport (MRP) to passport authori-

The rejoinder said supply of MRP booklets to the passport authorities is not the responsibility of the IRIS.

The Malaysian contractor alleged that the Dataedge does not have any specialised third party software such as Automated Fingerprint Information System (AFIS), which is vital for the implementation of the project.

In a letter titled "Nonprofessional approach of IRIS JV in implementation of government project" to the IRIS on May 16, the MRP project management detailed how the Malaysian company's integration process was causing problems to the government and suffering to Bangladeshi nation-Millions of people in 33 districts

have been suffering, while a lot of pilgrims and workers are not getting passports on time, regretted the letter, accusing the IRIS of not engaging efficient engineers to the integration process. It said IRIS' lone manager does not have adequate knowledge on the IRIS software system.

The letter explained how the IRIS kept the system locked with validation rules and took long time to remove

"Besides the current integration issue, the overall project performance is being hindered due to continuous nonprofessional attitude by the IRIS.. Some of the issues are to some extent clear violation of contractual agreement, which demands legal action," read the letter.

The IRIS blamed Dataedge-PWPW for failure to implement a pilot application receiving centre within 30 days after signing of the deal. But the Dataedge-PWPW readied a centre in Malaysia in less than a month and informed the government through a letter that it was ready for the pilot

The rejoinder said the Dataedge-PWPW required specialised third party software such as the Automated Fingerprint Information System (AFIS). As per the contract with the DIP, the Dataedge does not need AFIS. It has installed Neurotech, a finger image capturing machine, at 33 centres and also tested the software's compatibility with the central system owned by the IRIS. The Dataedge's Polish partner PWPW has been using the software in different countries.

According to the contract, the DII has the full authority of the IRIS software system installed in the country. The DIP bought the system and pays the IRIS for its maintenance. So, the passport authority can use it whenever necessary for integration or other purposes.

The IRIS said it was not obliged to provide any support beyond the contract period. But its contract with the government has not expired yet and thus it is obliged to extend required support.

The claim that the IRIS offered free software to the government in March is misleading as the company is contractually obliged to provide the government with software support.

During preparation of our reports, we tried to incorporate the version of the IRIS. But when contacted, IRIS senior project manager Lee

Soo Mei denied making any comment.

Cops capture another gang of 'abductors'

The newly-formed Anti-Kidnapping Squad of Dhaka Metropolitan Police arrested another gang of alleged abductors, which has a female member, in the capital's Badda and Mirpur on Tuesday night.

The arrestees, Masuma, Rajib alias Sajeeb, Nikul, Abul Kashem, Iqbal Hossain Kabir and Emdadur Rahman, are active members of an organised gang of kidnappers, said DMP spokesperson Monirul Islam at a press briefing at the DMP media centre yesterday. Detectives are trying to arrest the gang leader, Jahangir, who is on the run, he added.

The squad carried out drives following a complaint lodged by Ataur Rahman Manik, chairman of Goalbazar union parishad of Malaganj upazila of Sylhet, who had been abducted from in front of Suvastu Nazar Valley in Badda on May 11, DMP Joint Commissioner Monirul said.

One of the gang members called Manik to that place on the day and when he reached there, they took away Tk 40,000 from his possession, he quoted the arrestees as telling the detectives.

Ten days after the government started a drive against tinted glass on vehicles, the High Court yesterday asked the authorities to maintain status quo for two weeks on its action.

In response to a writ petition filed by two Supreme Court lawyers, the HC also sought an explanation in four weeks as to why the government move should not be declared illegal.

The home secretary, the inspector general of police, the commissioner and the joint commissioner (traffic) of Dhaka Metropolitan Police and a deputy secretary of the home ministry have been made respondents to the rule issued by the HC bench of Justice Mirza Hussain Haider and Justice Muhammad Khurshid Alam Sarkar.
