# Social afforestation a boon for the poor

Tk 76 crore distributed among the beneficiaries in two phases

The government's social afforestation programme brings monetary benefit to thousands of poor people who contribute to preservation and development of plantations on lands allocated by the forest depart-

A total of 1,22,000 hectares of land have been brought under the programme in the district, mostly in Madhupur, Sakhipur, Ghatail and Mirzapur upazilas, and 15,948 beneficiaries, including a large number of women, have already got a total of Tk 75 crore 62 lakh 23,530.

The beneficiaries, each serving as caretaker of a 250decimal social afforestation plot, got 45 percent of the total yield benefit.

The money was distributed in two 10-year rotations -- one from 1989-1990 to 1999-2000 and the other from 2002-2003 to 2012-2013.

Last week, 29 beneficiaries received a total of Tk 36 lakh as profit at a function at Bashtoil Range Office in Mirzapur upazila.

"I worked regularly and spent Tk 20,000 for fertiliser to take care of a 250decimal-plot of acacia trees. Now I am feeling very happy after getting a cheque of Tk 1 lakh 41

A Sunamganj court yesterday sentenced a woman to life term imprisonment for killing her infant daughter in 2002.

The convicted is Jyotsna Begum, 35, wife of Nur Ali of Mollikpur village in Jamalganj upazila,

Judge of Additional District and Sessions Judge's Court Kazi Abdul Hannan also fined the convict Tk 20,000, in default to suffer another year in jail.

According to the case statement, Jyotsna used to quarrel with her neighbours Moyna Mia, Alamgir Hossain and Shamim Mia over trifling matters.

In the early hours of October 10 in 2002, Jyotsna strangled her one and half year old daughter and circulated that the trio had killed her daughter in a bid to take revenge upon her.

#### Three die of diarrhoea in Bandarban

The disease is spreading fast in Lama upazila

Three people died and several others were attacked with diarrhoea as the disease spread in the last few days in Lama upazila of the district.

To tackle the situation, five medical teams including three special teams from Chittagong, Bandarban Sadar and Alikadom Army battalion were sent to Rupashi Para union in Lama upazila yesterday.

The teams treated 60 patients while 15 others were sent to upazila health complex as their condition was serious, said sources. A medical team was sent

to remote Tong Pong Mro Para where three people died of the water-borne disease, said Dr Maong Te Zaw, Civil Surgeon of the district. The victims were identi-

fied as Long Pong Mro, Chong Rung Mro, and Champau Mro.

The disease spread as people use contaminated river water for drinking and household work, the Civil Surgeon said.

High temperature in last few days has also contributed to the spread of the disease, he added.

Locals said diarrhoea outbreak has become regular matter as people suffer from the disease every year due to unavailability of drinking water in the dis-

#### Five dried fish traders get life for killing

A court here yesterday sentenced five dried fish traders to life imprisonment for killing a man at Dublarchar in Sundarbans in 2007.

The lifers are Joydev Biswas, his brother Mohadev Biswas, Sheikh Sirajul Islam, Romen Nath Roy and Sadhan Biswas of Chuknagar village under Dumuria upazila of Khulna.

District and Sessions Judge SM Solaiman fined the convicts Tk one lakh each, in default they are to suffer five more years in

According to the prosecution, the five dried fish traders beat up Sheto Sardar, a cook of another dried fish trader Liton Biswas, suspecting his involvement in theft of money from Joydev's bag at a fish depot at Dublarchar on February 27, 2007. He died on the spot.

Victim's son filed a murder case with Mongla Police Station on March 1 2007, accusing Joydev and four others.

After investigation, Sub-Inspector Md Shahjahan Mia of Sharankhola Police Station, pressed charges against the five on June 6 the same year.

### 'Missing' student found murdered in Jamalpur

Agitation in Pabna as abducted Mishuk yet to be rescued

A 'missing' textile student was found murdered on the bank of Brahmaputra River at Algirchar village in Sadar upazila of Jamalpur district yesterday.

The deceased is Asaduzzaman alias

Robin, 22, son of Ruhul Amin of Baruakhali

village in the upazila. He was a student of Tongi Textile Institute in Gazipur district, reports our correspondent. Police and family sources said Robin

came to his village home from the institute a few days ago. On Tuesday night, he went out of his house and did not return since.

Yesterday morning, locals found his body on the river bank and informed the police who sent it to Jamalpur General Hospital morgue for autopsy. Criminals strangled Robin and dumped

the body in the area, said Md Shahnewaj, sub-inspector of Jamalpur Sadar police station. Away in Pabna, students of Pabna

Government Technical School and College formed a human chain in front of the college on Dhaka-Pabna highway yesterday, protesting abduction of their fellow student.

They also denounced the role of the law enforcers for not rescuing Enamul Haque incident, reports our correspondent.

On November 16 last year, Mishuk, 18, a second year student of the college and son of Abdul Mannan of Goyeshpur village in Sadar upazila, was abducted on his way to the institution for Tk 4 lakh ransom, said the participants.

Following a case filed by his family, police arrested five men in this connection, said sub-inspector of Sadar police station Md Fazle Elahi.

The arrestees are Saiful Islam, Selim Reza, Saiful Islam of Pabna, Abu Taleb Sheikh alias Rabi and Rafikul Islam of Sirajganj. The students at the human chain also

threatened to go for tougher agitation if Mishuk was not rescued immediately. In Bogra, local people of Puran Bogra

area blocked Dhaka-Rangpur highway yesterday, demanding exemplary punishment to the alleged abductor and killer of school kid Shahriar Nafiz Siam.

They also brought out a procession in the town in favour of their demand, reports our correspondent.

On Tuesday, the body of Siam, 7, a class II student at Power Development Board (PDB Government Primary School), was recovered from the district town, said superintendent of police Mozammel Haque.
