## SC halts dam construction on Kobadak

The Supreme Court yesterday directed the authorities concerned to maintain status quo on construction of a dam across the river Kobadak in Tala upazila of Satkhira.

The court also scrapped a High Court verdict that had rejected a writ petition which challenged the legality of

construction of the dam. The SC sent the writ petition to HC for further hearing and disposal.

Following the SC order, the dam cannot be built across the river, said Manzill Murshid, the petitioner's cousel

Tala upazila parishad authorities have been building the dam with the government and Karitas, an NGO, funding the project.

On January 1 last year, the HC rejected the writ petition filed by Human Rights and Peace for Bangladesh seeking directives to save the river from encroachment.

The organisation later filed an appeal with the SC challenging the HC verdict, and the SC passed yesterday's order after hearing the appeal.

## Shibir attacks cops after arrest of leader

Clash leaves 3 police, arrestee hurt in Rajshahi STAFF CORRESPONDENT, Jamaat-e-Islami-backed

Islami Chhatra Shibir activists of Rajshahi University unit attacked police that triggered a clash between the two sides, injuring three policemen and a Shibir leader at Choddopai near the campus Sunday night.

Around 10 Shibir activists blasted three cocktails while police fired rubber bullets on them, said Alamgir Hossain, officer-in-charge of Motihar Police Station.

With splinter injuries, Sub-inspector Masud Rana and constables Shahinur Rahman and Rakib were taken to Rajshahi Medical College Hospital. Afzal Hossain, sports affairs secretary of Shibir's RU unit, who was shot in the right leg, was

also taken to RMCH. Police came under the attack by the Shibir men right after the former arrested Afzal, an accused in 18 crimi-

# Chief prosecutor returns to court

But Haider continues as acting chief prosecutor despite his presence

After more than one month of absence, chief prosecutor Ghulam Arief Tipoo yesterday appeared at the International Crimes Tribunal-1 during the war crimes proceeding against Jamaat-e-Islami leader ATM Azharul Islam.

The chief prosecutor sat on the first row of the prosecution team and observed the activities of the prosecutors, occasionally giving some instructions to his colleagues while the three-member tribunal was recording the deposition of a seizure list witness. Senior prosecutor, Syed Haider Ali, however, claimed

himself as acting chief prosecutor of the tribunal. "The ministry is yet to tell me anything," Haider said, adding that until the ministry asked him to step down as "acting chief prosecutor", he would continue with his position. Tipoo took one month's medical leave from April 13 and

Haider as acting chief prosecutor for the period of his absence. Tipoo returned to his workplace on April 30, and since then there has been a chief prosecutor and an acting chief prosecutor, apparently causing fractionalisation in the

**CORRUPTION CHARGES** SC scraps HC acquittal of Aman

The Supreme Court yesterday scrapped a High Court verdict that had acquitted BNP leader Amanullah Aman and his wife Sabera Aman of corruption charges.

A special court, set up on the Sangsad Bhaban premises, on June 21, 2007 sentenced Aman to 13 years' imprisonment for amassing wealth illegally and concealing the information from the Anti-Corruption Commission.

The same court also sentenced Sabera to three years' imprisonment as she was found guilty of abetting Aman.

Following an appeal filed by the couple, the HC on August 16, 2010 acquitted them of the corruption charges.

The SC passed the order yesterday after hearing an appeal filed by the ACC
