Earlier last month, the chief justice collected 10 judgments delivered by each of the six additional HC judges for evaluating their performance.

Sources said the CJ and other judges at the Appellate Division of the SC have scrutinised the judgments. The process of confirmation might

be completed before Prime Minister Sheikh Hasina leaves for China on June 6 on a five-day visit. Services of the six additional judges

were supposed to be confirmed before June 13 as they were appointed on June 13, 2012 for two years, SC Registrar AKM Shamsul Islam told The Daily Star. The then president Zillur Rahman had appointed the six additional judges

to the HC. The president confirms the services of additional HC judges on the basis of the CJ's suggestions. The CJ's recommendations are sent to the law ministry. The ministry then sends the suggestions to the Prime

president. The last Awami League-led grand alliance government (2009-2013) had appointed 60 judges to the HC, which has 90 judges now, including the six at two war crimes tribunals.

14 killed in Afghan blast AFP, Ghazni

A roadside bomb killed 14 civilians in eastern Afghanistan yesterday, officials said, the latest violence in the country as US-led troops prepare to leave after 13 years of war. The victims were travelling in the Giro

district of Ghazni province after a wedding ceremony when the bomb ripped through their vehicle, district governor Abdullah Khairkhwah told AFP. "Fourteen civilians were killed, seven of them were women, and the rest were

men, as their minivan vehicles hit a roadside bomb," Khairkhwah said. The district governor said the death

toll could rise.

Ghazni provincial governor spokesman Shafiq Nang confirmed the incident. Roadside bombs are commonly

used by Taliban insurgents to target Afghan and foreign forces but often cause civilian casualties. Attacks that kill civilians usually go

An American fighting for a hardline Islamist group carried out a deadly suicide bombing, US officials said Friday, in the first such case in the war.
