At least eight people were killed and 35 others injured by lightning strikes in Chuadanga, Chapainawabganj, Bagerhat, Jhenidah and Gopalganj districts yester-

people were killed and 11 others injured in separate lightning strikes in Jibannagar, Damurhuda and Sadar upazilas, reports our Kushtia correspondent.

Witnesses said, Sadek Ali, 24, son of Abul Hashem of Tentulia village, and farmer Saidur Rahman, 26, of Kushodanga village in Jibannagar upazila were killed when they were struck by lightning in the morning. Sadek Ali was fishing on a

Besides, 11 people were injured as thunderbolts hit them at Akandbari Kushodanga, Srirampur, Jadabpur and Tentulia villages of the uapzila.

The injured were admit-

ted to Jibannagar upazila health complex. Among them, the condition of three was stated to be critical.

Meanwhile, lightning struck Mandar Ali, 30, and his two buffallows when he went to the courtyard of his house to take the animals to the cowshed amid storm at In Chuadanga, three Nastipur village in Damurhuda upazila at 7am yesterday, leaving him and his cattle dead on the spot.

In Sadar upazila, daylabourer Anusuddin, 42, was injured when a thunderbolt hit him at Akandabaria village in the morning.

Besides, Nafiza Khatun, daughter of Kamruzzaman of Shyampur village, and Majnu Miah of Kurulgachhi village in Damurhuda upazila, were injured as as lightning struck them in the morning.



Sultana Kamal Visits Santal Village

'Dishonest land, forest officials back local land grabbers'

Sultana Kamal, executive director of Ain O Shalish Kendra, yesterday visited Khalippur Adivasipara in Nawabganj upazila where four indigenous people were brutally tortured by a gang of criminals on May 9.

After the incident, at least 60 Santal families of the village are living in fear of attacks and have almost stopped going outside their village.

The former adviser to the caretaker government went to the houses of Som Soren, 43, Babulal Soren, 43, Sonaram Tudu, 27, and Bablu Soren, 25, at the village and spent at least two and a half hours talking with the victims.

A gang of criminals tortured the four of Santal community, hanging them from a banyan tree. The victims alleged that a motive of grabbing their cultivable land was the reason behind the attack.

They said police are yet to arrest the criminals, who continue to intimidate

Terming the May 9 incident inhuman, Sutana Kamal said a section of people helped by some dishonest land and forest officials are involved in such incidents to grab the land of indigenous people.

She assured the victims of legal aid and urged the politicians to come forward to stop such heinous act.

A gang of criminals led by Mahbubur Rahman, an influential man of Kazipara village, swooped on the four people when they were loading their paddy onto a tractor at the village and beat them up.

The attackers also hung the four from a banyan tree and tortured them inhumanly. Sonaram, one of victims, filed a case with

Officer in-charge of Rampal Police Station Kazi Daud Hossain said Zahid Sheikh, 28, a drug addict son of Mokammel Sheikh, entered the house of Khaleque around 8:00pm and started hacking him indiscriminately with a sharp machete, leaving him critically injured.
