PM for finding most qualified future leaders of army

Prime Minister Sheikh Hasina yesterday directed senior officials of the army to select future leaders for promotion evaluating their professional excellence, experience, obedience, leadership quality, discipline, and above all, their belief in the spirit of the Liberation War.

She was addressing the Army Headquarters Selection Board-2014 of the Bangladesh Army held at Dhaka Cantonment.

Sheikh Hasina mentioned that the efficiency and image of any army depends on training, discipline and professional excellence of the personnel, and said that in promoting the officers to higher posts, priority must be given to their professional standard and educational qualification.

ESCAPE OF NUR HOSSAIN

N'ganj lawyers demand arrest of Shamim Osman

As the remand of Moshiur Rahman and Kamal, the two arrested for allegedly helping Nur Hossain escape, ended yesterday, Narayanganj district Lawyers' Association yesterday demanded the arrest of Awami League lawmaker Shamim Osman on the same ground.

Staging a protest on the court premise, the lawyer's association referred to a leaked phone conversation between Osman and the prime accused of the seven murders Nur Hossain, where the former assured the alleged criminal that he would have a safe passage to India.

"Moshiur Rahman and Kamal [two aides of Nur] were arrested on the basis of allegations, whereas we have proof in the form of the telephone conversation, in the case of Shamim Osman. Then why is he not being arrested? Is a lawmaker above law?" asked Shakhawat Hossain Khan, president of Narayanganj Lawyers' Association

Talking to our Narayanganj correspondent, Moshiur had previously admitted, "Nur Hossain took refuge in my house on May 1 after the bodies surfaced in the Shitalakkhya river. After two days of his stay, I told my accomplice Kamal to take him to Raghunathpur border [in Jessore] by motorbike."

Meanwhile, as rumours spread that Shamim Osman was going to be arrested, his party followers rushed to the lawmaker's house in Chasara at 1:30am yesterday, and took position in front of it to prevent his detention, reported our Narayanganj correspondent.

Education for all goals cannot be met by 2015 Says Unesco report

Despite progress made over the last decade in achieving six goals, set by Bangladesh and 163 other countries, for ensuring education for all, none of the goals will be met globally by 2015, according to a Unesco report.

In 2011, 57 million children and 69 million adolescents were still out of school, said the report, adding that insufficient financing for education is one of the main obstacles to achieving the Education for All (EFA) goals.

Unesco in collaboration with Bangladesh National Commission for Unesco and Save the Children launched the Bangla version of the report titled "Education For All Global Monitoring Report-2013/14" at BANBEIS Bhaban in the capital yesterday.

EFA is a global movement led by Unesco, aiming to meet the learning

needs of all children, youth and adults.

The countries had set the targets in 2000, aiming to meet them by 2015. Mentioning Bangladesh's statistics, the report said young people from poorer

RIGHT TO INFORMATION ACT Article-7 must be amended

Speakers tell seminar

Article-7 in the Right to Information Act, (RTI), 2009, which prevents designated information officials from providing required information to the recipients, must be changed, said discussants at a roundtable in Chittagong city yesterday.

Management and Resource Development Initiative (MRDI) and Manusher Jonno Foundation jointly organised the programme on "RTI Act, 2009 and Its Article-7".

According to the article-7, any information that may, if disclosed, cause a threat to the security and sovereignty of the country and its foreign policy cannot be sought.

But the discussants observed that some information officials were abusing and misinterpreting the article-7 for not providing information.

Prof Abdullah Al Faruk, dean of the law faculty at Chittagong University, said the citizens have the right to know, so all information must be accessible for them. At the same time, information that can go against the country's interest should be concealed. Therefore, the article must be amended to ensure the citizens' right as well as to restrict the

officials from misusing the article. Information Commissioner Abu Taher discussed as the chief guest while Chittagong Division Commissioner Mohammad Abdullah, Chittagong Deputy Commissioner Mejbah Uddin and MRDI Executive Director Hasibur Rahman Mukur also spoke.

TIPAIMUKH DAM Survey on Surma, Kushiyara starts today

A seven-member team of Bangladeshi officials will start a bathymetric survey today on a 12km stretch of the Surma, which is flowing along the Indo-Bangla border, and a 2km portion of the Kushiyara, which is flowing in India's Assam state before entering Bangladesh again.

The surveyors from the state-run Institute of Water Modelling (IWM) will investigate the hydrological impacts of India's proposed 1,500MW Tipaimukh hydropower dam project, Mir Sajjad Hossain, member of the Joint River Commission (JRC), told

The Daily Star yesterday. India's Barak river enters into Bangladesh from Assam state through Amolshid border in Zakiganj upazila of Sylhet and bifurcates into the

Surma and the Kushiyara. The weeklong survey, led by engineer Mahbub Alam, will cover the Indian side. Earlier, parts of the rivers which flow only through Bangladesh were surveyed.

RECEPTION CLOSING SCHOOLS HC issues rule against state minister

The High Court yesterday issued a rule against State Minister for Fisheries and Livestock Narayan Chandra Chanda for taking reception from the students keeping 209 schools of Dumuria in Khulna closed on May 3.

In the rule, the court asked Narayan and the government to explain in four weeks why the reception with closing the schools and receiving a replica of a boat of silver weighing 6.5 bhori from teachers should not be declared illegal.

The court also asked Narayan and the government to explain why his holding the office of state minister should not be declared illegal.

The HC bench of Justice Quazi Reza-Ul Hoque and Justice ABM Altaf Hossain came up with the rule following a writ petition filed by Supreme Court lawyer Eunus Ali Akond on May 29 challenging the legality of Narayan's action.

The writ petition said the closure of schools for the reception to the minister and presenting him the replica are the violation of the government notifications issued on last December 9 and

January 27 this year. Narayan, secretaries to the cabinet division, the education ministry, the LGRD and cooperatives ministry, director general of the directorate of education and the divisional commissioner of Khulna have been made respondents to the rule.

According to Khasi people, the community is living on government khas land and paying tax to the union parishad. They started living there way before Nahar Tea Estate was set up, in 1964, whose owner took lease of the tea garden land from the government. But the garden owner is unlawfully claiming the ownership of also that khas land where Khasis are residing.

Expressing grievances, Elfee Khonglah, general secretary of Khasi Students' Union, Kulaura unit, said, "Aren't we Bangladeshi citizens? We also have the right to live our lives."
